

MONEY MATTERS

Most folks don't plan to fail; they just fail to PLAN

With the first month of this New Year now behind us, it's time for a "reality check" to measure, and perhaps tweak, our Goals, aka New Year's Resolutions. So let's be brutally honest here and take a good hard look in our mirrors!

If any of my twelve suggestions noted in last month's column were among your goals, I sincerely hope that you recognized those important to your own financial wellbeing, and did, in fact, commit to at least a few of them.

After more than 29 years in the business of helping individuals and small business owners set, pursue and achieve their financial goals, I continue to be amazed at how many of those I counsel really have no specific and measureable goals. This fact alone, I believe, accounts for most financial failure

I always liken the absence of specific goals to that of planning a trip. Planning a trip begins with a destination and/or a purpose clearly in mind. It truly is impossible to plan a trip to "somewhere" or "anywhere." This is a powerful analogy to the absence of clearly defined financial goals. How does one embark on a financial journey without a destination? It simply isn't possible!

Measuring progress toward a specific goal is equally important; it keeps us on track and focused on the goal. Measurement is visible and each step forward improves our self-esteem and encourages our resolve to remain on the pathway to the goal.

Remember that all goals need to be attainable and reasonable. One doesn't become financially healthy overnight! The road to financial success and true financial independence is filled with potholes and detours, and often even multiple red lights! One "secret" to reaching stated goals is to break a large or formidable goal into what I like to call "bite-size" pieces. When a strategy to do this is in place, even a seemingly impossible goal become achievable. Measuring progress, no matter how small, nips off one of those "bite-size" bits and moves us closer to fulfillment of the goal.

Psychologists note that the vast majority respond best and longest to visual stimulation rather than auditory or kinetic stimulation. With this in mind, it may be helpful to create some sort of "thermometer" to chart progress. I recently suggested this to my daughter who has embarked on an accelerated and highly concentrated Master's Degree program. She made a thermometer drawing and marks off each course as she completes it! She is currently half way to her goal, and admits that the drawing is a strong motivating instrument! I challenge each of you to determine what your thermometer will denict!



1. Heat oven to 350∞ F. Line bottom and sides of 13x9-inch pan with foil. Grease foil on bottom only of pan with shortening or cooking spray. Make brownie mix as directed on box, using water, oil and eggs. Bake as directed for 13x9-inch pan. Cool completely, about 1 hour.

2. Using foil to lift, remove brownie from pan; remove foil. With deep 2 1/2-inch heart-shaped cookie cutter, cut 14 brownies. Place brownie hearts on a cooling rack or waxed paper.



3. In a microwavable bowl, microwave frosting uncovered on High 10 to 30 seconds. Stir; frosting will be thick and spoonable. DO NOT BOIL. Carefully spoon melted frosting over brownies to glaze, allowing excess to drip down sides. Sprinkle with candy sprinkles before frosting sets. For added color and texture, mix 1/4 cup Betty Crocker Rich & Creamy vanilla frosting and enough red food color to make pink frosting in a micro-wavable bowl. Microwave on High 10 seconds. Drizzle over chocolate-glazed hearts.
