

Budget deficit

Many Democrats talk about Obama inheriting a huge deficit from Bush, so let take a short history lesson.

Budgets come from Congress not the White House. The Democratic party has controlled Congress since January 2007. They controlled the budget process for 2008 and 2009, as well as 2010. In that first year, the Dems had to contend with Bush, which caused them to compromise on spending, when Bush belatedly got tough on spending increases. For 2009, Nancy Pelosi and Harry Reid bypassed George Bush entirely, passing continuing resolutions to keep government running until Barack Obama could take office. At that time, they passed a massive omnibus spending bill to complete the 2009 budgets.

Where was Barack Obama during this time? He was a member of Congress that passed all of these massive spending bills, and he signed the omnibus bill as President to complete 2009. Let's look at what the deficits was during that period.

The Democrats did not inherited any deficit, the 2007 deficit, the last of the Republican budgets. That deficit was the lowest in five years, and the fourth straight decline in deficit spending. After that, Democrats in Congress took control of spending, and that includes Barack Obama, who voted for the budgets. If Obama inherited anything, he inherited it from himself.

Most folks don't plan to fail: They just

After an almost non-existent Spring, we are now headed into full blown Summer with local temperatures already into the high 80's and low 90's. At the same time, the Markets worldwide are heating up also and giving us ups and downs just like the thermometer. What's right for your portfolio? Is another dip on the horizon?

My personal belief, backed by much information coming directly from multiple astute sources, is that a pullback may be on the horizon. Here are my reasons for my

First and foremost a lot of stocks are currently overvalued, and as such, need to fall back to reasonable levels. Second, consumer confidence is spotty at best, up today and down tomorrow, with many consumers, especially those without jobs or job prospects, still holding a tight line on spending.

The World debt crisis is not yet fully exposed, and I believe there is more to be revealed in the near future...perhaps by the time this column is printed. The Goldman Sachs probe I believe to be the tip of yet another iceberg, figuratively speaking. Additional regulation of the financial industry including banks, investment banking firms and other financial institutions is a likely outcome. The need here is not, in my opinion, for additional regulation, but for much more oversight of existing regulation. As a

financial professional for more than thirty years, I am already overwhelmed with compliance regulations. The "big boys" of the financial world manage to escape such regulation, and with enough "creativity," especially in the areas of new product development, they are often able to move forward with their own agendas, perhaps a few steps ahead of the regulators.

Here at home, the unprecedented debt accumulating under current Washington leadership, is likely to cause interest rates to rise, causing bond prices to fall. Increased taxes to fund Administration programs are almost a certainty, while inflation will most likely be hard to prevent, perhaps not immediately, but most assuredly in the long term.

Add to all of this that the Obama Administration is pushing hard to have China devalue its yuan. If and when China yields to this US pressure, it will boost the value of the US dollar, allowing the US to repay trillions of dollars worth of debt with cheaper dollars. Don't look for China to do this any time soon, if at all. If China does not acquiesce to US pressure, the dollar will remain weak, enabling China to acquire more equity in the US. Since China is now the largest holder of US debt, one can only contemplate the outcome. At the same time, as more European debt surfaces, the Euro could weaken and that could have a positive effect on the US dollar.

Meanwhile, more close to home, residential home sales are rising every so slightly, and housing prices are also re-bounding slightly, but indications are that more foreclosures are possible as homeowners, many of whom should never have been encouraged to be homeowners to begin with, due to their being without substantial credit worthiness, fall into arrears without employment or visible means of making good on even "modified" mortgages...if in fact they can weather the interminable difficulties and time lag of qualifying for such modifications. Statistically, a large percentage of those qualifying for "mortgage loan modifications" default anyway within 7 months! One might ask,

"Are the loan modification programs of the Federal Government really helping?"

In a single sentence, there are multiple problems still before us, and likely a few more, as yet un-named, to surface. So where should your own portfolio be headed?

Of course, no one solution is right for everyone, but to generalize, always risky to be sure, take stock of your own assets, your liabilities, the most likely questions facing you in the foreseeable future, and then head for those portfolio entities that have intrinsic value, those that are largely inflation-proof, and those that will be necessary when others are not

## THE WORLD IN REVERSE

"Will Your Retirement Years Be Quality Years?"

It's no secret that our elder population is living longer. Since 1900, the number of Americans over age 65 has tripled. By 2030, there will be an estimated 1 million centenarians (people over 100 years old). Unfortunately, living older in America does not necessarily mean seniors will live better. According to researchers, centenarians demonstrate some common habits that lead to their longevity. They maintain a level body weight, they do not smoke, they do not drink in excess, they move daily, they maintain strong social relationships, and they use humor to cope with stress. These are all positive quality of life choices and behaviors.

Quality of life during retirement is also dependent upon financial wellness as well. A sound financial plan and good asset management is critical for seniors. The use of the federally insured and guaranteed Home Equity Conversion Mortgage (HECM) program designed for seniors age 62 and older is a great tool to help seniors with retirement quality of life issues. The HECM program was passed by an act of Congress in 1989 and signed into law by Ronald Reagan. This program allows seniors to tap into their home's trapped equity and receive either monthly payments for life, a lump sum, or

place part or all of the cash equity into a growing line of credit. Most importantly the senior homeowner will never incur a monthly house payment while they occupy their home. Additionally, there are no income or credit qualifications and the homeowner retains the title and ownership of their home. Moreover, no debt can ever be passed to the heirs after the homeowner passes away. The HECM program can allow seniors to use their trapped equity in their home to travel more, quit working a job, visit the kids more often, play more golf, eliminate debt, pay off an alligator traditional mortgage (which frees up a monthly payment), have more monthly cash flow, or do anything they want to create more options in their golden years which in essence leads to a better quality of years. 
I believe that everyone of us should take a stand when that happens. As sure as you need air to breath there will be a cost laid upon all of us.

## THE OMBUDSMAN

The Long Term Care Ombudsman Program (LTCOP), comes under the umbrella of the Department of Elder Affairs. The LT-COP has 17 districts covering Florida's 67 counties and services the entire state.

What does the LTCOP do? The Ombudsman does assessments /inspections of all licensed facilities in the state, i.e., Nursing Homes, Assisted Living Facilities and Adult Family Care Facilities. These facilities are licensed by AHCA, (Agency for Health Care Administration).

The Ombudsman a volunteer, does these assessments/ inspections in every licensed facility once a year with quarterly follow ups, along with friendly visits, complaints, and follow up visit on these complaints. The next question would be how do people find out about who to call when services are needed? Every licensed facility must have the LTCOP, poster, displayed in their facility along with a copy of the residents' rights. These posters are there by law, with the phone number to call. The phone number is the same throughout the state. 1-888-831-0404, when this number is called the local LTCOP office is automatically reached no matter where in the state you are calling from.

There are many people living in and calling these facilities home. Many of these residents' have families living a far distance away or in another state, some with no family at all. When any resident needs help and calls the eight hundred numbers they have found a voice that will be heard. The Volunteer Ombudsman is assigned the case and goes out to do an investigation of the cause of the complaint. There are times that a complaint can be dealt with and solved within a couple of day, and other times it can take up to a couple of months. The complaint is to be resolved to the satisfaction of the resident.

The Ombudsman is the residents' voice. The Ombudsman is there to make a difference for that resident, to help in anyway that they can to resolve any issue that the resident may have.

The Long Term Care Ombudsman Program is an active volunteer program helping all those who live in any of these licensed facilities. They are always there to help. You do not need to be a resident in a Long Term Care Facility to make a complaint. You can be a friend, a relative, employee, or someone who just stopped by the facility and noticed something wrong. When this happens, you just call 1-888-831-0404 and get help for that resident. If you see an Ombudsman in a facility, you can stop them and ask them about getting help for someone. Do not turn your back on someone who may need help. The Ombudsman Program is a phone call away. Make someone's life a little bit better by helping.
