Interviewing Jackie Porter

School Board Budget Tom Loury

I have been covering the School Board story since I heard someone say they are not buying local. I find that not true! There is a good portion buying local, but there are some that feel they are not inclined and are buying out of Texas and parts unknown. Then the roof issues came up and I am trying to cover that. Because it is not being covered accurately and or just not giving all a voice. It seems that the questions Jackie Porter has been asking are proving to be good honest questions, like is there a warrantee on a roof that the School Board voted 4 to 1 to replace at a price of approx \$500,000. It seems to me that there is only one person fighting for the tax pavers.

Jackie Porter has agreed to answer questions about the budget process. The following are some questions and answers styled to inform you the taxpayer.

Question: Last month you told us that the tentative budget would be presented to board members on July 22 and that you would have workshops on it through August. Can you tell us any details about the tentative budget

and what to expect?

Answer: The tentative Marion County School District budget for 2010-2011 as originally presented to the School Board totals \$549,748,945. The proposed budget includes a .25 mil property tax increase described as a "critical operating needs" tax that is projected to bring an increase in revenue of \$4,324,405. The "critical operating needs" has been summarized as funding for after-school credit recovery and summer enrichment programs. I have requested a detail of those summer classes and their corresponding costs.

I voted "NO" on the tentative budget because it included the "critical operating needs" tax increase. Taxes should not be raised in the middle of a recession, especially in Marion County, currently at 13.9% unemployment which exceeds the national average. Local businesses and individual taxpayers need 100% of the tax relief that will come from the decline in their property values. It is not fair to take advantage of that tax relief by adding a .25 mil increase.

Setting the record straight

It was the Lady Lake Chamber of Commerce Breakfast. The speaker for the event was Leo Champaigne, a veteran that wanted to set the record straight. Here is his account as best as I can recollect it.

Leo Champaigne spoke in a quiet, but matter-of-fact voice. Here is his story. In the beginning Leo Champaigne joined the Marine Corp. as a mere teenager. He went through basic training and wound up with an artillery unit, the 5th Marine Division's 13 Regiment. They went right to war. After their equipment was destroyed during the shelling on a beach landing he was told to fall in with the E Company, 2nd Battalion 28th Marines.

Four days of fighting they gained a few hundred yards. The Japanese were well dug into tunnels all over the Island. The marines'

job was to secure the base of Suribachi. First they had to get to the highest point then claim the island theirs. Leo carried an American flag under his poncho because it was raining. The Battle of Iwo Jima raged on while the four men climbed. They made it to the top and Leo and three fellow soldiers

MONEY MATTERS

Most folks don't plan to fail; They just fail to PLAN!

Well, my slogan above has been part of this column for more than two years now, but never has it been so important to me personally than in the past few weeks as my beloved husband of nearly thirty years progressed through the last days of his life. If there is a part of your own life where Death looms on the foreseeable horizon, I urge you to PLAN, PLAN, PLAN! Make no mistake, we are never prepared to have a loved one leave, but we can definitely be prepared for many of the myriad details that will need our immediate attention.

Remember to update Beneficiary designations on all retirement accounts such as IRA's, 40l(k) Plans, insurance contracts, pensions and military accounts. Review and update family Trusts immediately. With the diagnosis of terminal illness and pending death, your attorney is an invaluable aid to avoiding pitfalls after

the fact.

Another end-of-life financial issue is the cost of care. A long term illness can bleed the family coffers leaving debt and even financial destitution behind. Plan ahead with Long Term Care Insurance. Be sure your contract includes Home Health Care. It is statistically true that most terminally ill individuals prefer to remain in their own environment as opposed to finishing their days in a hospital or even a Hospice facility.

Statue to Move



CONFEDERATE STATUE SET TO MOVE TO VETERANS PARK

WHO: Marion County Parks and Recreation, Marion County Veterans Services, Marion County Historical Society and Landis V. Curry (a local citizen and attorney)

WHAT: Confederate Civil War soldier monument, commonly referred to as Johnny Reb, to move from the Marion County Judicial Center to the Ocala-Marion County Veterans Memorial Park

WHEN: Tuesday, Aug. 24, 2010 (The dismantling process starts on Aug. 23; however, crews are expected to start re-assembling the statue at the Veterans Park on Aug. 24. Dates are subject to change unexpectedly.)

WHERE: Ocala-Marion County Veterans Memorial Park (2528 E. Silver Springs Blvd., Ocala)

WHY: On Jan. 19, 2010, Marion County commissioners unanimously decided to move a Confederate Civil War statue, commonly referred to as Johnny Reb, from the south side of the Marion County Judicial Center to the northwest corner of the Ocala/Marion County Veterans Memorial Park.

Instead of using tax dollars to move the statue, Commissioner Charlie Stone suggested setting up a separate account to accept donations. Landis Curry, a local citizen and lawyer, volunteered to organize the fundraising effort, raising more than \$34,000.

LaPerle Memorials of Inverness will dismantle and reconstruct the monument. Local companies, including Moss Construction Management, Steven Counts Inc., Florida Concrete, A&A Trucking, Sims Crane & Equipment Co., Mid-State Electric Cooperative, Brown Sprinkler & Irrigation and United Masonry, have donated labor and/or materials. Jim Couillard, a Marion County landscape architect, has designed the new location to include sidewalks so spectators can easily get to the statue, lighting and landscaping to create an appropriate setting.

Commissioners chose the northwest section of the Veterans Memorial Park instead of the Civil War Plaza section of the park for several reasons. First, the 23-foot-tall Civil War statue would overshadow the adjacent Medal of Honor monument, which is 13-feet tall. Second, the board did not want to modify the original statue to make it better complement the aesthetics of the Civil War Plaza. Therefore, the board deemed the northwest section of the park the most appropriate location; the Marion County Historical Society agreed.

Commissioners started discussing the idea of moving the Confederate Civil War statue to a more suitable location in November 2009 when the Judicial Center expansion project started to near its completion.



put the flag up on a piece of pipe protruding out of the ground the Japanese were using as air pipes. No one realized once the flag was up it would have such an effect. Hours later the Japanese came out of the tunnels an the battle escalated, many died.

Later after the fact they had sent Leo and the other three men to the other side of the island on assignment.

While on assignment they found out that a second flag raising happened to get photos and to put up a larger flag making their point as victors.

Leo said nothing about the second flag raising, two of the four men was killed during battles a short time after that. The one

other did live long enough to make it home and died soon after.

After serving three + years in the Marine Corp. he came home to celebrate with his friends and family the end of the war. Everything was quiet on the home front. The celebration had already happened and left him behind.

Leo did not tell the story to his family and friends. Leo's daughter recognized his picture in an old Veterans Magazine picture and she started asking. That is when he told her his story and he has been telling it ever since. After Leo found he was the last of the four who really did raise the flag he decided to tell his story. The other three died without recognition and Leo thought he could get them some recognition for what they had done and set history straight. Leo did not want to let his buddies down, him being the

No one is left alive to deny or confirm his story. The historians say they have no evidence of his accounts, but they were the same historians that mistook the second larger flag as the original flag to be raised first. Remember these historians were not there and Leo was.

I believe Leo's story! First I sat at the

Lady Lake Chamber of Commerce breakfast while he told his story. He has nothing to gain. The photos that got all the attention were of the second flag raising. We have many stories told in history and I think he is setting the record straight. Historians need to listen! Ask questions, get to the truth.

We have a real hero alive and well living in the Villages. We have many heroes living there, many don't tell their story.



Sarah's Story

Recently I read an article in Parade Magazine regarding dog fighting and Michael Vick's abused pit bulls. After reading this article in Parade Magazine I felt the need to share Sarah's story.

Dog fighting has been a part of society for hundreds of years. As a dog lover it pains me to think of all the poor dogs that have been used and abused over the years in the sport of dog fighting. If you have ever wondered what is so wrong with dog fighting maybe Sarah's story will help show want happens to the victims of dog fighting, the dogs themselves.

A few years ago I adopted a bull dog mix who I named Sarah. She came to us the night prior to the 2008 presidential elections so I named her Sarah after Sarah Palin who was running for Vice President. My husband was out walking our lab/greyhound mix, Murphy, when he spotted this half starved bull dog. My husband called into the house to tell me he had a half dead pit bull in the garage. I went out to the garage to see what he had now brought home since he seems to attract stray dogs.

I was appalled when I saw her. I could not believe that anyone would allow a living animal to get into the shape that Sarah was in. She had sores on most of her body and had lost most of her hair due to malnutrition. I counted twenty-seven scars on her head alone. Sarah was nothing but a bag of bones, every rib showed and I could see her back and hip bones. She also looked as if

she had just recently weaned a litter of puppies.

Just moments after my husband found Sarah a sheriff deputy knocked at our door. The sheriff explained that someone had called and reported that a pit bull was running the neighborhood. Upon seeing the shape that Sarah was in I thought that this young sheriff was going to cry. The sheriff determined that Sarah was not a threat to anyone and asked if we could keep her until animal control could pick her up, which I agreed to. Animal control could not get to my home fast enough as far as I was concerned.

I had read and heard what bad dogs pit bulls were and I did not feel very comfortable having one of these mauling machines in my garage, even for a night. After listening to my husband's weeping most of the night as he kept Sarah company in the garage I began to wonder if I was not going to have another dog.

Well two years and nearly two thousand dollars later spent on returning Sarah to good health we are now the proud owners of a beautiful bull dog mix. All of the nice people who have helped us get Sarah healthy again believed that she was used for dog fighting at one time and then turned into a breeder to produce bait dogs. Bait dogs are used for fighting dogs to train on, kind of like a chew toy. Our vet feels that Sarah was left on the highway to die after she stopped producing pups.

Prior to meeting Sarah I never gave much thought to dog fighting. Dog fighting did not affect me personally so why give it any thought at all. Since meeting Sarah I have read many stories about hundreds of dogs just like her and it breaks my heart to read them. I have spoken to a local humane society director and he told me that dogs are put to death every day across the United States because no one wants to adopt a dog that is a pit bull.

Dog fighting and the media have created an image that all pit bulls are vicious killers that maul small children. There are over four million pit bulls living in homes across the country giving their owners devotion and love everyday. If socialized and loved pit bulls are one of the most loving and loyal breeds.

Recently I read an article relating to pit bulls that stated not to judge a book by its cover because it may be the best book that you ever read. The dogs used in dog fighting are the victims and should be given a chance of finding a good and happy life. No dog should have to live as Sarah lived prior to finding happiness at our house.

An end must be put to the needless suffering of innocent animals. Dogs are meant to be man's best friend and not used for his sick entertainment. The biggest roll model of dog fighters is Michael Vick one of the current quarterback's for the Philadelphia Eagles. It would make me and animal lovers all over the world extremely happy to see Michael Vick and people like him spend their lives in jail just like the abused dogs spend their lives in cages and fear. Today when I see a pit bull I now see the breed as lovers and not fighters. Give this breed a chance; stop the hurt and misunderstanding of these beautiful dogs.

The Importance of Senior Fitness

(Family Features) According to the National Institutes of Health (NIH), exercise and physical activity are some of the best things older adults can do to stay healthy. Even moderate exercise can improve the health of those who are frail or who have age-related diseases.

Without physical activity, older people tend to grow weaker in four areas important for staying healthy and independent: strength, balance, flexibility, and endurance. The NIH maintains that:

- * Increasing strength and endurance make it easier to climb stairs and carry groceries.
 - * Improving balance helps prevent falls.
- * Being more flexible may speed recovery from injuries.

Exercising regularly can also have a positive impact on the immune system, blood pressure, cardiovascular system and it can decrease the risk of heart disease and help with depression or anxiety.

The American Senior Fitness Association has some recommendations for those wanting to start a fitness program.

* Get medical clearance to exercise.

- * Don't exercise if you are injured, sick, or running a temperature.
- * Always warm up and always cool down.
- * Drink plenty of water before, during and after exercise.
- * Avoid heavy meals for about two hours before energetic exercise.
- * If fatigue and/or discomfort last longer than one or two hours after exercising, cut back the next day but don't stop completely. Comfort ranges can change daily, so don't get discouraged if you can't do the same amount of exercise as you did the day before.
- * Concentrate on exercises that improve and maintain your range of motion, lubricate the joints and keep muscles flexible. Everyday activities will be easier to carry out and you'll have less pain, too.

Stop exercise and consult your physician immediately if you experience any of the following:

- * chest pain or tightness in the chest, neck or throat
 - * considerable difficulty breathing
- * abnormal heart rhythm; nausea, dizziness, light headedness, or visual interruption
 - * excessive cold sweat
 - * extreme or lasting weakness or fatigue



For a good, overall exercise program, consider tai chi. Tai chi is a self-paced system of gentle physical exercise. It involves standing and performing a series of movements in a slow, graceful way. Each movement smoothly flows into the next. Studies suggest that tai chi may improve balance

and knee joint stability, both of which help balance.

Staying active does the body and the mind a world of good. Find exercise and activities that you enjoy and you'll be able to stick with it and improve your quality of life.



NACWA Executive Director Ken Kirk commended the department for consistently meeting federal compliance standards and ensuring that Marion County citizens receive the best possible water quality.

To operate a public utility, agencies must meet between 230 and 600 federal compliance points (depending on the type of system) to keep its federally required National Pollutant Discharge Elimination System permit. Winners of the Gold Peak Performance award met those federal standards 100 percent of the time.

"Achieving 100 percent compliance is not easy," Utilities Department Director Flip Mellinger said. "On any given day, a rain storm, equipment failure or power outage could disrupt the system. Even if the disruption was a minor problem that lasted only 15 minutes, that system would not qualify for the gold standard. This means that six of our facilities operated perfectly all 365 days in 2009."

Kirk recognized Marion County Utilities at the association's 2010 summer conference in San Francisco, California in late July. However, due to budget constraints, Utilities staff could not attend the event.

New Process for Permits

MARION COUNTY, Fla. (Aug. 6, 2010) Traditionally, when event organizers

wanted to host a community festival, fair or concert in unincorporated Marion County, they would need a special event permit from Marion County government. Special event permits (not to be confused with special use permits) are required for properties not specifically zoned to host events that last one to seven days.

Getting that permit required applicants to obtain seven signatures from county and state officials, including law enforcement, fire rescue and public health among others. The process, which officials described as "antiquated" and "fragmented," could take several weeks to complete and required event organizers to travel to various locations throughout the county. Now, however, that process has changed.

In a unanimous decision on Aug. 3, 2010, Marion County commissioners adopted a new, streamlined process for special event permits. Marion County Fire Rescue Division Chief Paul Nevels led a seven-person committee to improve the process, after commissioners received complaints from the community.

Richard Guynn, Past-President of the Ocala Jaycees, tested the new process when applying for a permit for the annual "God and Country Day" Fourth of July event. Guynn told commissioners that the new process is better than ever. He said he received his permit within five days whereas the previous process took a month.

Applicants can complete this process in three simple steps:

- 1. Download and thoroughly read the special event permit application online at www.marioncountyfl.org http://www.mar- ioncountyfl.org> . Click on the "I Want to Tab" at the top and select "Apply for a Special Event Permit." Or, fill out the application in person by visiting the Marion County Zoning Division (2710 E. Silver Springs Blvd., Ocala).
- Meet with a Zoning Division representative who will guide you through the process. When you meet, bring all of the required documents, e.g. site plans and written authorization from the property owner among other documents.
- 3. Receive confirmation from the Zoning Division.

Using an existing software program, Zoning Division officials will enter your information into the system and send it to the required reviewers. In short, event organizers will no longer need to drive to various locations to gather the signatures required to obtain the permit. If all goes as expected, the permit can take as little as 72 hours to complete (depending on the circumstance and complexity). The special event permit costs remain \$15.
