Baxley Speaks at OBL Breakfast

Dear Friends,

The 2011 legislative session was a great success. Our elected leaders were able to tackle a variety of really difficult subject matters and make some key policy changes to improve our State, the economy and the quality of life in our communities.

Despite the challenging economic times forcing many of us to vote for some difficult decisions (because of the nearly \$4 billion dollar deficit) we were able to do our Constitutional duty to balance the budget. We made a decision, as leaders, that we would live within our means and not increase the burden on taxpayers. And we did not!

Passing a bill is a very involved process. Bills must be thoroughly vetted through multiple bi-partisan Committees and Committee Members. It must be scheduled to be heard on the floor of the House and Senate. If there are any amendments, or time just runs out, bills may begin to 'die.'

Below are some of the highlights of reforms that came out of this session: Improving the economic climate:

We passed legislation that will completely eliminate the State Corporate Income tax

4th of July **School Board Budget**

There has been ongoing turmoil and unrest between the public and cost cutting proposals by Superintendent Yancey. Some costs cutting measures proposed by the Superintendent are outsourcing student transportation and cutting a minimal amount of travel expenses. I feel his cost cutting measures aren't deep enough and in the right places.

First of all, there is the issue of outsourcing student transportation. Based on a recent Auditor General's report for fiscal year

end 2010 the number of buses and routes reported by the district had been overstated. Page 46 of the audit states: "Our review of the buses and their corresponding routes disclosed that the District had renumbered some of their buses to reflect the transportation zone that the buses transported students in (Ref. 51)." The report also notes that 24 routes "were missing and could not be located."Ladies and Gentlemen...the overstating of buses and routes in operation is inexcusable

A May 28, 2011 student transportation report issued by Marion County Public Schools to the Florida Department of Education indicates 23,563 students rode buses this year; however, this number has not been audited. The public has been told for months from the Superintendent's office that 29,000 students are transported every day. The information released to the public and the press was overstated by 23%!! The previous error in reporting student transportation numbers by the Superintendent's office, including their overstatement of buses and routes, leads me to question the savings of \$700,000 claimed by the Superintendent. As I have said before, I am not in favor of outsourcing student transportation because the cost savings have not been proven to justify the amount of risk placed on the School District.

Another proposed cut by the Superintendent was for to reduce 1/2 of the out-ofcounty travel for all employees at a savings \$100,000. When I read this calculation it seemed too low. Expenditures for travel inversification does not ensure against market risk

clude seminars, conferences, staff training, registration fees, meals, lodging, and mileage reimbursements. Finance provided me with an analysis of travel. The out-of-county travel costs were reported at \$519,000 for this year. The report also showed in-county-travel to be \$310,000. A grand total of \$829,000 just this year! My proposal is to eliminate all travel expenses.

There are many departmental budgets which comprise the main school district budget. Those budgets are not available for me to scrutinize and remain the duty of the Superintendent. I do not support tax increases, I do support a complete review of all department's non-essential expenses. I also proposed a 10% cut for salaries of the Superintendent, School Board Members, Deputy Superintendents, Executive Directors, Directors, Supervisor I, Coordinator I & II, and HACC Program Manager. This cut would save about \$575,000.

I have not been in agreement with some issues with the Sheriff of Marion County. The Willow program is a "Work in lieu of Arrest." Some years back I got involved because the Willow program was putting 8 and 9 year olds in with 17 year olds to work on the Sheriff prison farm. I managed to get the 8 and 9 year olds out of the program buuuuut there is still a lot to do. The 10, 11, and 12 year olds should not be with the older prisoners. They are being recruited by them. The other thing that is so blatantly wrong is that they are using the school resource officers to introduce students into the system and the schools are allowing it. These should be two different issues. The school should take care of their own problems and not send any kids to a prison work farm. Instead of teaching kids to respect and listen to police officers they are teaching hate.

If a school rule is broken? Keep the student an extra hour or more at school cleaning up the ground or studying.

Back to the Willow program. Scare tactics are used to sign the kids in. The parent, mostly the mothers are told (usually at the school) we are going to handcuff your child and take them to jail or you can sign them into this work program, they can go home with you. They are taken to the Sheriff's work farm and expected to work on a Saturday. I agree with the program, but not the way they are signed in and not the younger children in with the older teenage offenders

When I got involved before, after it was all over I received a letter of thanks from the



State Juvenile authorities because they know right from wrong. They thanked me for getting involved. I actually got thanks from several deputies who are no longer there.

We need to take the 10, 11, and 12 year olds out of that program, or keep them separate from the older offenders. The offenses on the street are very different than the ones in the schools.

Talk to these new candidates about the changes you would like to see. That would be the School Board and the Sheriff candidates. I had hundreds of people talking to me about the Willow program and they agreed it was not right to expose the young kids to the older offenders and they felt it should not be part of the school system.

This has nothing to do with the officers on the street but it has everything to do with policy, make it stop!

Now is the time to make a difference! ******

Tuesday June 14 school board meeting Jim Yancey did not attend. Missing were the two chief finance people.

Interesting and disturbing that 10 days before two of the most life changing decisions in Marion County School history, (going to a 4-day school week affecting 41,000 children and privatising student transportation affecting nearly 350 employees lives,) the Superintendent and his top finance directors were out of town, instead of answering phone calls and crunching numbers.

It is my opinion that any one of the School Board members that vote for privatising transportation can be held liable in case of injury or death of a student, because of neglect of the vendor. For instance a student is hurt or worse. A twenty million dollar lawsuit is filed. The vendor files bankruptcy and folds. WHO IS LIABLE then? I believe the lawyers could say if the school system was running transportation this would not have happened.

The other thing that bothers me is the report from a recent Auditor General's report for fiscal year end 2010. The number of buses and routes reported by the district had been overstated. Our History

During the American Revolution, the legal separation of the Thirteen Colonies from Great Britain occurred on July 2, 1776, when the Second Continental Congress voted to approve a resolution of independence that had been proposed in June by Richard Henry Lee of Virginia. After voting for independence, Congress turned its attention to the Declaration of Independence, a statement explaining this decision, which had been prepared by a Committee of Five, with Thomas Jefferson as its principal author. Congress debated and revised the Declaration, finally approving it on July 4. A day earlier, John Adams had written to his wife Abigail:

"The second day of July, 1776, will be the most memorable epoch in the history of America. I am apt to believe that it will be celebrated by succeeding generations as the great anniversary festival. It ought to be commemorated as the day of deliverance, by solemn acts of devotion to God Almighty. It ought to be solemnized with pomp and parade, with shows, games, sports, guns, bells, bonfires, and illuminations, from one end of this continent to the other, from this time forward forever more."

Adams's prediction was off by two days. From the outset, Americans celebrated independence on July 4, the date shown on the much-publicized Declaration of Independence, rather than on July 2, the date the resolution of independence was approved in a closed session of Congress.

MARION COUNTY, Fla. (June 14, 2011) – Due to dry conditions, the Marion County Multi-Agency Wildland Task Force recommended to extend the mandatory burn ban for Marion County today. Marion County Board of County Commissioners Chairman Stan McClain approved and signed the original emergency order on May 31.

The burn ban prohibits campfires and all open burning, excluding attended and monitored barbeque and cooking equipment. The burn ban also prohibits the use, ignition or

discharge of any type of explosive compounds, fireworks, flares or sparklers. If citizens are caught violating the burn ban, they could face fines and other consequences. However, commercial burners may still be eligible for a burn permit on a case by case basis pending onsite inspections from the Florida Division of Forestry and/or Marion County Fire Rescue. Utility Phone Pay System

MARION COUNTY, Fla. (June 8, 2011) If you're one of Marion County Utilities' nearly 29,000 customers, you now have a new way to pay your monthly utility bill. The department kicked off its phone bill-pay in the beginning of June. Clients now have the option of paying by phone, online, mail, automatic bank draft or in-person at select Marion County Tax Collector locations or the Marion County Utilities office.

The phone payment option comes to fruition after several years in the making. Utilities staff wanted to provide more convenient options for residents, particularly those who may have decreased mobility or access to technology.

"It's convenient and secure. All you have to do is punch in the information on the phone," said Marion County Utilities Administrative Manager Nancy Jarvis. "A lot of people don't have computers and may not be able to physically get around, but almost everyone has a landline or cell phone."

Residents can use a credit card and pay via the phone pay system 24 hours a day, 7 days a week. To access the system, customers should call 352-671-8503. Acceptable forms of payment include Discover, MasterCard and Visa debit or credit card; there is no credit card surcharge. Callers can also use the system to check their payment history. Utilities officials will use this same automated system to notify water users if a bill is past due or a boil water advisory is issued.

Although the phone pay system is the latest, it's not the only recent addition to utility pay options. Marion County Utilities launched a partnership in May with the Marion County Tax Collector to accept utility payments at various Tax Collector office locations. The reason – many of the utility's customers are located in the outer parts of the county while the Marion County Utilities office is located near downtown Ocala.

Residents can now visit the Ocala McPherson Complex, Belleview, State Road 200, Dunnellon, East State Road 40 or North Highway 441 Tax Collector locations and pay their bills on-site by cash, check or credit (American Express, Discover or MasterCard). A small convenience fee will be applied to credit card payments.

Drop in Unemployment

Region posts drop in unemployment, gains in jobs and labor force

Joblessness in Citrus, Levy and Marion counties dropped in May from 11.7 to 11.5 percent over the month, and was 1.2 percent down over the year, according to today's release of employment data by the Agency for Workforce Innovation.

The unemployment rate for Workforce Connection's three-county region is one percentage point above Florida's rate of 10.5 percent. The national unemployment rate

held at 8.7 percent.

Out of a labor force of 208,299 in the region, there were 24,016 unemployed, down from 24,128 over the month, and 184,283 with jobs, up from 182,329.

Jobless rates in May for the Workforce region were 11.9 percent in Marion County, down from 12.1 percent; 11.0 percent in Citrus County and 10.3 percent in Levy County, which remained unchanged.

Rusty Skinner, Workforce's chief executive officer, said all indicators are "very positive" for the region. Not only has joblessness dropped or held steady in the region, but Skinner said there have been gains in job creation and expansion of the labor force which is the number of those actively seeking employment.

"That's what we needed to see," Skinner said. "If we just have a drop in the unemployment rate, but no concomitant gains in jobs and labor force, then that tells us people are getting discouraged and giving up or leaving the area. What we're seeing today is very positive. We're not out of the woods, but we're starting to see some light."

The number of unemployed in Marion County unemployment dipped by 134 to

15,832, at the same time the labor force expanded by 1,120 to 132,611 and the number of employed rose by 1,254 to 116,779. Nonagricultural employment for the Ocala Metropolitan Statistical Area (MSA) was 90,400 in May, down 1.8 percent of 1,700 jobs over the year – the third steepest rate of job decline in the state.

In May in Citrus County the number of jobless barely moved, from 6,400 to 6,384 while those with jobs rose slightly from 51,638 to 51,825 for a gain of 187 jobs and the labor force posted a modest gain, up 171 to 58,209.

The situation is much the same in Levy County. The number of unemployed remained virtually unchanged, rising by 26 to 1,800. At the same time, those with jobs increased by 200 to 15,679 and the labor force expanded by 226 to 17,479.

Marion and Citrus counties' unemployment rates continue to slide down the ranks of highest rates in the state. In April month, among Florida's 67 counties, Marion ranked sixth highest, Citrus was 10th and Levy County was 24th. In May, Marion fell to seventh, Citrus 11th and Levy 25th. The Ocala MSA dropped from third to fourth highest among the state's 23 MSAs – the second consecutive month of decline – behind Palm Coast's 13.8 percent, Miami-Miami Beach at 13.7 percent and Sebastian-Vero Beach at 12.5 percent.

Since May 2010, government lost the most jobs in the Ocala MSA, with a loss of 1,300 jobs, followed by mining, logging and construction and leisure and hospitality, with a loss of 300 jobs each, and information and other services, which saw a loss of 100 jobs each.

Manufacturing continued to remain unchanged over the year.

Education and health services gained 300 jobs, followed by trade, transportation and utilities with 200 jobs as well as transportation, warehousing and utilities, which also posted 200 new jobs.

Workforce Connection serves career seekers by planning and coordinating training, education and placement opportunities and also provides business development services such as on-the-job training, paid internships and other financial incentives. Last year, more than 36,000 career seekers and 1,600 businesses received services.

The local, business-led nonprofit organization works with economic development partners throughout the three-county region to bring new employers to the area as well as to provide services and hiring and training incentives that help new and existing businesses, large and small.

Prepare gas or charcoal grill. Place chicken on grill and cook, turning, until done throughout, about 6 minutes per side. Cool and shred meat coarsely.

Add chicken to vegetable salad mixture. Add cilantro and parsley; stir well to combine.
