Dear Chairman Stone and Board members

Our National Organization, which works to keep state and church separated has been contacted by tax payers and residents of Marion County who strenuously oppose the practice of prayers at City Council meetings. The Freedom From Religion Foundation (FFRF), has 18,000 members including 800 in Florida.

It is our information and understanding that the Marion County Board of County Commissioners ("Board") includes prayers as a part of its meetings.

Government prayer is unnecessary, inappropriate, and divisive. Calling upon the Board members and citizens to rise and pray (even silently) is coercive, embarrassing and beyond the scope of secular government.

Board members are free to pray privately or to worship on their own time in their own way. They do not need to worship on taxpayers time. The Government should not lend its power and prestige to religion, amounting to a government endorsement that excludes one 1-in-5 American who are not religious. The Board compounds the violation when majority of prayers are sectarian, in this case to Jesus, or a majority of the officiants are of one religion, in this case Christian or Christian clergy. Such prayer creates acrimony, makes minorities feel like political outsiders in their own community, and shows uncontitutional Government preference not just for religion over nonreligion, but Christianity over other faiths.

Citizens of all religions or no religions are compelled to come before you on important civic matters and to participate in important decisions affecting their livelihood, their property, and quality of life, These citizens should not be made to feel offended. excluded, or like political outsiders because the local government they support with their taxes imposes religious ritual at local government meetings. Local government meetings should not be in the business of performing religious rituals, or exhorting all citizens, regardless of beliefs, .....etc

MARION COUNTY, Fla. (Aug. 22, 2012) – Glass. Plastic. Tin cans. Newspaper. Aluminum cans. Cardboard. Office paper. If you recycle at any of Marion County's recycling centers, you know those categories represent the different containers you have

to separate your recyclables into each time you visit.

But soon, you can stop separating. Beginning Sept. 1, Marion County Solid Waste will offer single-stream recycling at all 18 of its recycling centers countywide. This means no more separating recyclables - all items can be disposed of in one container.

Bonds and Interest Rates

What happens to the price or value of a bond when interest rates move up or down? An

inverse (or opposite) relationship exists between the price of a bond and interest rates. As general interest rates go down the value of previously issued bonds goes up and as interest rates rise the value of previously issued bonds goes down.

The reason for this has to do with the cal-

culation of the bondís yield (the stated interest rate or coupon that the bond pays divided by the current bond price). This can best be explained with an illustration:

Let us assume that XYZ, Inc. has issued a bond for general corporate financing purposes that originally sells for \$1,000 and carry¹s a coupon (or stated interest rate) of 6%. In this case for every XYZ, Inc. bond that a bondholder owns they will receive \$60 per year in interest payments from XYZ.

Now let's suppose that one year later general interest rates have gone up by 1%. XYZ is also again offering similar bonds to the public as they did the year before except that now they carry a coupon rate of 7%. Obviously the 7% coupon rate is more preferable (all things being equal) than a 6% coupon

rate. So, the XYZ bond with the 6% coupon rate will go down in price to the point where the division of the \$60 coupon into the current price of the bond equals 7%.

Similarly if general interest rates were to go down than the price or value of a previously issued XYZ bond with a higher coupon rate will rise in value. If the bond rises in price relative to its original issue price (usually \$1,000) the bond is said to trade or sell at a premium. In the case of the aforementioned illustration when a bond trades or sells below its original issue price the bond is said to trade at a discount to its original issue price. Of course, there are many factors that go into the pricing of a bond in the general marketplace. Examples include the credit rating of the issuing entity and the length of time remaining until the bond matures or comes due.

In June, the Marion County Board of County Commissioners unanimously approved an agreement with Waste Pro of Ocala to provide single-stream recycling at county recycling centers.

According to the five-year contract, Waste Pro of Ocala will be responsible for constructing a regional material recovery facility in Marion County as well as for transportation of the recyclables from county recycling centers to the Waste Pro facility. Marion County will receive 55 percent of the revenue from the sale of the recyclable material. This revenue, combined with cost savings due to the new recycling processes, is anticipated to cover the cost of the expanded services.

According to the Florida Department of Environmental Protection, Marion County currently ranks 10th out of Florida's 67 counties in a statewide ranking of each county's adjusted recycling rate.

"We hope this enhancement of our recycling program will increase Marion's recycling rate and help reduce the amount of materials going into the landfill," said Marion County Solid Waste Director Mike Sims. "Plus, recycling will be easier and less time-consuming for our residents – with no increase in cost to the department or to the taxpayers."

TALLAHASSEE ~ Acknowledging increased concern about pipeline safety due to aging infrastructure susceptible to corrosion, the Florida Public Service Commission (PSC) today approved two petitions allowing three Florida natural gas companies to recover their costs for hastening pipeline replacement within 10 years.

"The PSC is committed to working with Florida,s natural gas utilities to maintain a safe and reliable pipeline infrastructure that meets consumers, daily needs," said PSC Chairman Ronald A. Brisé. "An added byproduct from the utilities, energy infrastructure improvements is an immediate economic development boost in their service territories."

Peoples Gas System's (Peoples) Cast Iron/Bare Steel Replacement Rider, approved today, will accelerate the replacement of cast iron and bare steel distribution pipes on its system. Cast iron is subject to corrosion which in turn may lead to cracking if exposed to mechanical pressures such as excavation or heavy road traffic. Pitting can occur in unprotected bare steel distribution pipes, reducing the pipeline,s structural integrity. The initial bill impact for a typical

Peoples, residential customer is \$0.05 per month starting in January 2013.

A joint petition filed by the Florida Public Utilities Company (FPUC) and the Florida Division of Chesapeake Utilities Corporation (Chesapeake) received Commission approval for Gas Reliability Infrastructure Programs (GRIPs). GRIPs, a proposed industry program, permits a gas utility to recover the cost of accelerating the replacement of bare steel pipeline with polyethylene (plastic) pipeline. FPUC,s initial bill impact starting in January 2013 is \$0.12 per month for a typical residential customer; Chesapeake's initial bill impact starting in January 2013 is \$0.37 per month for a typical residential customer.

An annual mechanism to track savings in operations and maintenance expense and depreciation is required for both pipeline improvement programs. The U.S. Department of Transportation has urged natural gas utilities to replace these older facilities as a safety measure.

idea of what the other two pages say. It was from Dan Barker and Annie Laurie Gaylor, Co-Presidents of the Americans United for separation of Church and State.. The following is a complaint about prayer prior to the County Commission Meetings and the response from the County Attorneys.

Prayers at County Commission Meetings Dear members of the Board of County Commissioners:

We have received a complaint regarding the Board of County Commissioners practice of opening its meetings with Christian prayer. We have reviewed video of the eight meetings held between January 10, 2012, and May15, 2012. Seven of those eight videos captured the opening prayer. Each time, the prayer was delivered by a member of the County Commission, and at five of the seven meetings the prayer was specifically Christian, referencing the name of Jesus Christ. We write to inform you that your prayer practice is in violation of the Establishment Clause of the First Amendment to the U.S. Constitution, and to ask that you bring your prayer practice into constitutional compliance by either ending the practice altogether or by revising your prayer policy to allow only nonsectarian prayer.

The U.S. Supreme Court has held that prayers at the opening of legislative sessions are constitutionally permissible only if there is no indication that the prayer opportunity has been exploited to proselytize or advance any one, or to disparage any other, faith or belief." Marsh v. Chambers, 463 U.S. 783, 794-95 (1983). The Court later clarified this standard by stating that the ruling in Marsh cannot justify "contemporary legislative prayers that have the effect of affiliating the government with any one specific faith or belief." Cnty. of Allegheny v. ACLU, 492 U.S. 573, 603 (1989). The U.S. Court of Appeals for the Eleventh Circuit, which has jurisdiction over Florida, adopted this standard in Pelphrey v. Cobb Cnty., 547 F.3d 1263,1270-72 (11th Cir. 2008).

None of the above decisions, however, offers any shelter for the County Commission's prayer practice. The prayers given in Marsh were nonsectarian, whereas the County Commissioners are overwhelmingly Christian. See Marsh, 463 U.S. at 793 n.14 (prayergiver had "removed all references to Christ"). And in Pelphrey, while the Eleventh Circuit did not find fault with the fact that the prayers were sectarian; the court did note that the County Commission's prayer practice had included enough diversitythere were Jewish, Muslim, Baha'i, and Unitarian Universalist prayergivers and prayers—to ensure that the prayer opportunity had not been exploited to proselytize or advance any one faith. Pelphrey, 547 F.3d at 1228, 1277-78. Here, as far as we are aware, no prayers of non-Christian faiths have been

Moreover, in Marsh and Pelphrey, the

prayers were given by clergy-persons and directed at the elected officials. See Marsh, 463 U.S. at 784; Pelphrey, 547 F.3d at 1266-67. Courts have held that it is unconstitutional for elected officials to deliver sectarian prayers themselves, because doing so convey a message that the elected officials endorse the specific religious beliefs reflected in the prayers. See Doe v. Indian River Sch. Dist., 653 F.3d 256, 288-90 (3d Cir. 2011); Wynne v. Town of Great Falls, 376 F.3d 292, 301-02 (4th Cir. 2004) (cited with approval in Pelphrey, 547 F.3d at 1272). Here, the County Commissioners give the prayers.

For these reasons, the Commission's prayer practice unconstitutionally affiliates the County with Christianity. We therefore ask that the prayer be replaced with a moment of silence. The constitutionality of a moment of silence is undisputed; furthermore, a moment of silence is far more inclusive than a prayer, because it allows attendees to pray or not to pray, in accordance with their own conscience. Alternatively, the prayers could be made non-sectarian, bring-

ing them into line with the prayers upheld in A!arsh. 463 U.S. at 793 n.14. Finally, the County Commission could change its policy to invite members of the community to offer the invocations, while ensuring that prayergivers of faiths other than Christianity are allowed the opportunity to present prayers. An injection of diversity into the prayers would demonstrate that the County Commission's prayer practice is not meant to endorse Christianity, and would bring it into line with the practice that was approved in Pelphrey. 547 F.3d at 1277-78.

\*\*Publishers Note: I believe I headlined this story correctly because denying prayer before a meeting in Marion County Florida is "Dancing With The Devil!" I also believe in Marion County we could muster up 200,000 Christians that would disagree with denying prayer at any meeting!

#### **Unemployment Rate**

Unemployment rate up slightly over the month, down significantly since July 2011

(OCALA, Fla.) – Workforce Connection's regional unemployment rate was 10.6 percent in July, up 0.4 percent over the month but down 2.1 percent from one year ago. Out of an expanded labor force of 206,753, there were 21,866 jobless or 4,586 fewer unemployed than this time last year.

The July 2012 unemployment rates, released Friday by the Florida Department of Economic Opportunity, were 10.5 percent in Marion County, up 0.2 percent over the month; 10.8 percent in Citrus County, up 0.5 percent; and 10.3 percent in Levy County, up 0.5 percent. Florida's not seasonally adjusted unemployment rate was 9.3 percent in July and the United States rate was 8.6 percent.

Workforce Connection CEO Rusty Skinner said that the unemployment data for July again shows expected month-by-month fluctuations of the overall economy. All of Florida's 67 counties' unemployment rates declined over the year, while 66 counties' unemployment rates rose over the month.

"Summer months are traditionally uneven," Skinner said. "Combined with the uncertainty of our national economy, the sluggish employment response will probably continue through the end of the presidential election cycle."

When viewed in the long-term, Skinner noted that each county in the region shows job growth.

"Marion shows a growth of 2,700 more

people working from one year ago, Citrus shows 500 more in employment and Levy employment is up by about 160," Skinner said.

In July, nonagricultural employment in the Ocala Metropolitan Statistical Area was 89,700, an increase of 0.4 percent or 1,100 jobs over the year.

Seven major industries gained jobs over the year, led by leisure and hospitality and education and health services (+500 jobs each); professional and business services (+200 jobs); and manufacturing, trade, transportation, and utilities, financial activities, and other services (+100 jobs each).

The one industry that lost jobs over the year was mining, logging, and construction (-500 jobs), while information and governmental remained unchanged over the year.

When it comes to gauging economic recovery, both Skinner and DEO's Rebecca Rust, the state's chief economist, emphasized that it is important to track the trend, not the monthly blips. The region's July rate was 2.1 percentage points lower than the year-ago rate of 12.7 percent when there were 25,947 jobless and 3.0 percentage points lower than July 2010 when 26,534 were out of work.

"The change is very minor in terms of the long term," Rust said. "There needs to be a change in the same direction for at least four months, consecutively, to be a trend."

Rust cited movements she described as "positive indicators," including a decline in the number of job losers, and increase

in percentage of those who have left jobs voluntarily as well as those re-entering the labor force.

The increase in job leavers is up from 6.7 percent to 7.1 percent, Rust said, and shows "they are feeling more optimistic, so they're voluntarily leaving" to shift careers, go back to school, or retire.

Across the region, the labor force grew by 843 to 206,753, the number of unemployed dropped by 461 and the number of those with jobs increased by 69 to 184,887 over the month.

Here is the breakdown for each county:

Citrus County's labor force decreased by 23 over the month to 55,664, the number of employed fell by 259 to 49,676 and those without jobs increased by 236 to 5,988. One year ago, there were 6,989 unemployed.

Levy County's labor force increased by 39 to 16,765, employment is down by 38 jobs to 15,044 and the number of unemployed rose by 77 to 1,721. In June 2011, there were 2,084 jobless.

Marion County's labor force grew by 827 to 134,324, the number with jobs increased by 366 to 120,167 and those unemployed increased by 461 to 14,157. In July 2011, there were 17,379 without jobs.

Marion County's unemployment rate dropped from 12th to 15th, Citrus County's fell from 10th to 12th and Levy County dropped back one place to 18th. The Ocala Metropolitan Statistical Area (MSA) remained the fifth highest among the state's 23 MSAs, behind Palm Coast with 12.7 percent, Sebastian-Vero Beach with 12.2 percent, Port St. Lucie with 11.7 percent and Lakeland-Winter Haven at 10.6 percent.

Workforce Connection is the local, business-led organization dedicated to connecting qualified workers with local employers in Citrus, Levy and Marion counties through cost-effective, high-quality employment, training and education services in collaboration with business, community, education, economic development and government partners. On average, 36,000 job seekers and 1,500 businesses receive services at no charge each year.
