
ery minute of it.



showed up to get one good picture to run in the paper and write a short story. I interviewed Mary Filer of Parks and Recreation who was coordinating the event at the time.



Third Quarter 2012 Economic and Market Review

Perhaps the biggest event in the third quarter was the Federal Reserve

embarking on another large scale asset purchase program. Coined QE3 (Quantitative Easing round 3), this program essentially continues the framework of its predecessor in which the Fed will buy an additional \$40 billion per month of mortgage backed securities. Further, they announced this would be an open ended policy along with a near zero federal funds rate until at least 2015. In their commentary, they identified their concerns with slow economic growth, elevated unemployment and global market strains. In short, the Fed is artificially keeping interest rates low in order to aid the recovery in housing and help consumers and businesses save

money through refinancing. This artificial market sweetener was embraced by investors and served as the main catalyst behind the above average market returns during the quarter. If it ultimately leads to more jobs and higher growth, the Fed's action will be justified. If not, unwinding these programs could be disorderly and result in lower asset prices in the capital markets at some point in the future.

For now, the Federal Reserves determination to keep interest rates low for an extended period of time has forced investors to add risk in order to gain a reasonable investment return. In this environment, both stock and bond prices have trended higher and, absent an exogenous event, they should continue to perform fairly well. As this has unfolded in the capital markets, much of the economic data has deteriorated during the year, including manufacturing and employment. The gauge of industrial production has slipped to a negative growth rate over the past few months, and is the lowest level in three years. Further, the Purchasing Manager Index (PMI) registered 49.6 percent,

indicating contraction in the manufacturing sector for the third consecutive month through August, and the lowest reading since mid 2009. The general indications in manufacturing are a slowdown in orders and demand, with continuing concern over the uncertain state of global economics. The United States is the worlds largest manufacturing economy, producing 21 percent of global manufactured products. Maintaining a healthy, growing manufacturing sector is a vital part of the long-term growth equation.

The softening in the manufacturing sector has put pressure on overall employment during the year. The latest reading showed weekly jobless claims remain elevated at around 382,000 and the pace of new jobs has declined to under 100,000 per month through August. Further, the unemployment rate has been stuck at over 8.0 percent since early 2009. Companies appear to be holding back on hiring and investment as overseas demand cools and the prospect of tax increases and spending cuts in the U.S. threatens growth. While the employment environment remains challenging, the trend remains positive and jobs are being created.

Beyond the tentative U.S. economy, other developed nations are feeling the pinch of slow growth, high sovereign debt levels and

weak employment. In early September, the head of the European Central Bank (ECB) announced a massive, open-ended financial support program for weaker European nations. In essence, the ECB will purchase bonds on the secondary market to bring down borrowing costs and, hopefully, jumpstart growth. Investors perceived this action as good news with limited downside risk of further debt-related problems erupting with European countries any time soon. In China, the key gauge of manufacturing activity has contracted for eleven consecutive months. Consequently, growth has fallen to around 7.5 percent from close to 9.0 percent. While still healthy, their economy is feeling the effects of a slowdown in the U.S. and Europe.

Looking ahead, the accommodative stance by central banks around the world should keep interest rates low, aid economic growth and keep risk assets in modest demand over the near term. This is likely to occur, even as the world economies are slowing. The added strain of the uncertainty surrounding the presidential election and European debt problems could add volatility to the capital markets over the next few months. In this uncertain environment, we expect both stock and bond returns to re-

Smart Justice

While economic conditions and the effort to restore prosperity for this area and the country will continue to dominate our attention, a number of other topics are on the horizon for

the next legislative session as we attempt to work smarter and give constituents best value for their tax dollars.

The economic tightening and \$5 billion reduction in state revenues has made everyone review how we do things and ask the question, "If we weren't already doing it this way, how would we do it?" This can be scary for those already used to the present way of doing things, but is an exciting question that can bring better results.

Historically, Florida has been "tough on crime", and we have seen crime rates declining. But, prison population has increased to over 100,000 inmates and the costs associated make this an expensive issue.

A number of policy adjustments in other

states have given us good data on policies that would make sense as smarter ways to handle corrections. Two broad concepts that could have a remarkable impact are "Diversion" on the front end and "Re-Entry" programs on the back end. If we could reduce recidivism by one-third, we would save \$1 billion dollars.

Also due for some review are the sentencing guidelines we currently abide by, and move towards the opportunities to reform inmates through re-entry portals and work release options instead of the high cost, high security prison beds. These ideas and others are now being studied by TaxWatch and other entities. This area needs careful

analysis as our primary obligation is public safety. There are some inmates that are such a danger that all we can do is keep our communities safe from them.

We believe in accountability, but we also believe in redemption. Careful risk assessment can tell us who is a danger and whose primary issues are mental health and substance abuse issues. Above all, we must provide public safety and the best possible value to tax payers. "Smart Justice" is an important area to look for better solutions for the citizens of our great State.

Fungal Meningitis Outbreak Grows

OCALA — Three women are the latest in Marion County to be confirmed as cases in the fungal meningitis outbreak that has affected 16 states.

A 69-year-old woman and a 71 year old woman who both were treated at the Florida Pain Clinic and a 73 year old woman who was treated at the Marion Pain Management Center are the latest Marion County cases. They were identified as a result of the ongoing investigation of the fungal meningitis outbreak associated with contaminated lots of methylprednisolone acetate.

The total number of cases in Marion County has risen to 13, including three deaths. Nine of the patients were treated at the Marion Pain Management Center, including two of the deaths. Four patients were treated at the Florida Pain Clinic, including one death. The statewide case total

has increased to 17.

"I want to urge any patients who have been notified that they received injections from the New England Compounding Center to monitor their health and be aware of the symptoms," said Dr. Nathan Grossman, director of the Marion County Health Department. "Even if symptoms are mild, contact a health care professional for evaluation."

Symptoms include new or worsening headache, fever, sensitivity to light, stiff neck, new weakness or numbness in any part of the body, slurred speech and increased pain, redness or swelling at the injection site. Infected patients may develop very mild symptoms that are only slightly worse than usual. For example, many infected patients have had slight weakness or even a mild headache.

FROM THE GOVERNOR'S DESK

ORLANDO -Governor Rick Scott spent his 14th "Let's Get to Work Day" working at the Florida Department of Law Enforcement's Orlando Regional Operations Center, where he processed evidence in the evidence intake center, worked as a crime analyst in the biology section, analyzed a gun at the firearms section, and participated in an exercise with the cybercrimes unit whose mission is to crack down on computer crimes including on-line sex predators.

Governor Scott said, "My goal is to create a Florida where every family feels safe in our communities. As a father of two and

a grandfather, I know how important it is for our families to feel safe. Too often, we've seen evening news stories of families and forever changed by a senseless crime. That's why I'm proud of our progress in knocking down the DNA case backlog by 60 percent, while also providing the funding necessary to expand an increase the number of DNA samples in the database.

"Thanks to the hard work of the men and women I met today, we're making progress every day in bringing offenders to justice and making our streets safer. Today, we are at a 40-year low crime rate, which means we're headed in the right direction."

Governor Scott helped collect evidence submitted to FDLE from local agencies, process DNA, and observe how DNA samples are put into the national DNA database.

In the month of September 2012, FDLE provided 365 "hits" to local, state and national law enforcement agencies. A hit is when evidence associated with a crime is identified to an individual's specific DNA. Currently, there are more than 862,000 offender DNA samples in FDLE's database. It is the second-largest such database in the country. Samples are obtained from felony convictions and those arrested for homicide, assaults, sexual battery and lewd and indecent exposure. In January 2013, FDLE will begin adding burglary, robbery and theft arrests to the database thanks to funding provided under the Scott Administration.

The Florida DNA database began in 1990 and has grown to be one of the largest DNA databases in the country. Florida is part of the FBI's national DNA identification index system known as CODIS. This system allows state and local law enforcement agencies' crime laboratories to store and compare DNA records from convicted offenders and crime scene evidence with that of other state DNA databases.

Hollingsworth, 52, of Arcadia, is manager of VCH Management Inc. He has maintained 4,000 acres of citrus groves in Hardee and Desoto Counties since 1981. Hollingsworth received his bachelor's degree from Florida Southern College. He is reappointed for a term beginning October 19, 2012, and ending May 31, 2015.

Horrisberger, 59, of Lakeland, is procurement director for the Coca-Cola Company. Previously, Horrisberger worked for Cargill, Inc. from 1978-2007. He received his bachelor's degree from the University of Minnesota and his master's degree from the University of St. Thomas. He is reappointed for a term beginning October 19, 2012, and ending May 31, 2015.

These three members join Jesse A. Clark III, Michael J. Garavaglia Jr., G. Ellis Hunt Jr., Martin J. McKenna, Virginia S. Pena, and Michael O. Taylor on the commission.

The appointments are subject to confirmation by the Florida Senate.

The Marion County Health Department, Florida Pain Clinic, Marion Pain Management Center and the Surgery Center of Ocala have collaborated to contact patients who may have been injected with the infected medications.

The fungal meningitis that is caused by the contaminated medicine is not contagious and cannot be transmitted from person to person. The medications associated with this outbreak are not the same as the epidural injections given to pregnant women during childbirth.

1 lime zested

2 limes, juiced, divided

1/4 teaspoon sugar

1/4 teaspoon Mexican chili powder

1/4 cup red bell pepper, diced

1/4 cup yellow bell pepper, diced

1/4 cup red onion, diced

2 tablespoons cilantro, rough chop

1 cup Wholly Guacamole dip

Mix oil, 1/4 teaspoon salt, black pepper, cumin, sugar, chili powder, lime zest and juice of 1 1/2 limes.

Add to turkey and allow to marinate for

at least 20 minutes - do not exceed 30 min-

Mix in bell peppers, onion, cilantro, dip, turkey, the rest of the lime juice and remaining salt.

Serve in a pita, on a whole wheat bun, as a lettuce wrap, or with crackers.

Turkey and Corn Enchilada Casserole

Serves: 6 First Layer

1 15-ounce can corn. drained

1 15-ounce can creamed corn

8 ounces sour cream (non-fat)

1/2 cup ricotta (low-fat)

1 8 1/2-ounce package corn bread mix Second Layer

1 cup turkey, shredded

1 cup shredded cheese

1 cup enchilada sauce, divided Wholly Guacamole dip, for garnish

Mix together all first layer ingredients in a casserole dish.

Bake at 350°F for 30 minutes or until firm.

Take out of oven, poke fork holes all around it.

Pour 1/2 cup red enchilada sauce over corn bread.

Top with turkey and cheese.

Put back in oven until cheese melts.

Top with remaining enchilada sauce, guacamole dip; serve.
