(Nov. 20, 2012) – Newly-elected county commissioners David Moore, 42, and Earl Arnett, 65, have officially joined the rest of the Board of County Commissioners. Judge David Eddy swore Moore and Arnett into office at Tuesday's county commission meeting. Returning Commissioner Stan McClain, 51, also took the oath of office. The trio joins Chairman Kathy Bryant and Vice Chair Carl Zalak III, on the Marion County Board of County Commissioners.

Moore replaces former commissioner Mike Amsden for the District 1 seat. Arnett replaces former commissioner Charlie Stone for the District 5 position. This is the first time Moore and Arnett have held elected office.

"I look forward to working with the commission to impact the challenges of our community in a positive way and continue to build a confidence in our citizens, so that as we move forward we can be also confident that we have their support with a mutual achievement that can be shared by all," Moore said. Moore campaigned on budget discipline focusing on essential and emergency services, job creation through business-friendly practices and protection of water resources. Moore is a Citrus County native and decade-long Marion County resident and has worked in the financial field for 14 years.

Arnett, a U.S. Army veteran and owner of Earl's Tint and Signs, is a Washington, D.C., native and decades-long Marion County resident. During his commission race, Arnett campaigned on economic growth through reduction of duplicative mandates and regulations, as well as budget efficiency through streamlined operations.

"My focus will be on maintaining the financial solvency of our county by helping to develop an environment where businesses can develop, grow and thrive," Arnett said.

McClain is serving his third term on the board. "I am honored to continue to serve," McClain said. "I hope to be able to continue a tradition of fiscal responsibility and honor the families of Marion County."

How is inflation measured?

The United States government through the Bureau of Labor Statistics (BLS) uses the CPI,

or Consumer Price Index, to measure inflation or the change over time that consumers pay for a basket of goods and services.

The CPI reflects spending for consumers and wage earners in rural settings (which represent 87% of the U.S. population). It is determined from data provided by people and their purchases. The most current CPI data is collected from tracking 7,000 households from across the country regarding their quarterly spending habits. Another 7,000 families keep and provide diaries on their purchases over 2 week periods to gather data on more frequently purchased items such as food. So over a year spending information is provided by 28,000 households on a quarterly basis not to mention the bi-

weekly diaries. The CPI covers all goods and services and is subdivided into eight major categories:

Food and Beverages: (breakfast cereal, milk, coffee, chicken, wine, full service meals, snacks)

Housing: (rent of primary residences, owners equivalent rent, fuel oil, bedroom furniture)

Apparel: (men¹s shirts and sweaters, women¹s dresses, jewelry)

Transportation: (new vehicles, airline fares, gasoline, motor vehicle insurance)

Recreation: (televisions, toys, pets and pet products, sports equipment, admissions)

Education and Communications: (college tuition, postage, telephone services, computer software and accessories)

Other Goods and Services: (tobacco and smoking products, haircuts and other personal services, funeral expenses)

The broadest and most comprehensive measure of CPI is the All Items CPI for All Urban Consumers (CPI-U). The Bureau of Labor Statistics publishes thousands of CPI indexes each year. One you may have heard mentioned quite often is the All Items less Food and Energy. This index is often reported and is designed to remove the more vola-

tile components of food and energy. However, food and energy are always calculated and reported in the All Items CPI. CPI data is published by BLS and is available free of charge through the BLS website.



PSC Approves Progress Energy Florida Recovery Rates

TALLAHASSEE — Florida's Public Service Commission (PSC) today approved inclusion of \$327.6 million in Progress Energy Florida's (PEF) 2013 fuel factor projections for potential insurance recoveries related to the utility's delamination event at Crystal River 3. This decision resolves outstanding issues from the Commission's annual recovery clause hearing and finalizes PEF's 2013 customer rates.

By Florida Statute and established Commission policy, electric utilities may recover certain expenses from customers through cost recovery charges adjusted annually by the PSC. Cost recovery is allowed on fuel and purchased power, capacity (including nuclear), conservation, and environmental requirements. Utilities may not, however, earn a profit on fuel charges.

Charges related to fuel and purchased power are included in the fuel charge on customers' bills. All other approved charges are included in the energy charge, which also includes the utilities' base rate charge. PEF customers also have nuclear cost recovery amounts, approved on November 26, included in the energy charge.

Starting in January 2013, monthly bill charges for a PEF residential customer using 1,000 kilowatt hours (kWh) follow:

The current bill of \$123.19 will decrease to \$116.06, a reduction of \$7.13.

PEF recovery amounts include: fuel and purchased power \$33.93, capacity \$17.38, conservation \$3.06, environmental \$4.94, and Gross Receipts Tax \$2.90.

Recovery charges for Tampa Electric Company, Gulf Power Company, and Florida Public Utilities Company were approved on November 5 during the PSC's annual recovery clause hearing. Recovery charges for Florida Power & Light Company will be determined following the Commission's decision in its pending rate case.

PSC Approves Nuclear Cost Recovery for FPL and PEF

TALLAHASSEE — To help secure a diversified and stable energy future for Florida, the Florida Public Service Commission (PSC) today approved cost recovery amounts for construction of planned nuclear generating plants and additions to existing nuclear plants for Progress Energy Florida (PEF) and Florida Power & Light Company (FPL).

PEF's approved recovery of approximately \$143 million includes costs associated with construction of its proposed nuclear power plant, Levy Units 1 and 2, and adding capacity to its existing Crystal River 3 (CR3) nuclear generating plant. CR3 recovery in-

cludes only prudent 2011 uprate costs, since the Commission approved PEF's motion to defer 2012-13 CR3 project cost recovery to next year. When completed, PEF's nuclear projects are projected to add approximately 2,380 megawatts (MW) of new nuclear base load generation to its system, enough energy to power 1.3 million homes.

FPL's approved recovery of approximately \$151 million recovery includes costs associated with construction of its planned Turkey Point Units 6 and 7 and adding capacity to existing Turkey Point Units 3 and 4 and St. Lucie Units 1 and 2. When completed, these projects are projected to add approximately 2,722 MW of new nuclear base load generation to FPL's system, enough energy to power 1.4 million homes.

Estimated 2013 residential nuclear cost recovery, based on current sales forecast, is about \$4.79 per month for the first 1,000 kilowatt hours (kWh) for PEF customers and about \$1.69 per month for the first 1,000 kWh for FPL customers. Approved amounts for both PEF and FPL customer bills will be recovered through the fuel and capacity cost recovery charge on customer bills beginning in January.

To encourage the development of nuclear power, the Florida Legislature enacted a law in 2006 to permit utilities to recover some nuclear plant project costs during the construction process. The PSC then adopted a rule on how to evaluate those costs annually. Annual PSC nuclear cost recovery hearings, held this year in September, allow Commissioners to hear testimony from the utilities and consumer groups on recovery of actual and estimated project costs.

PSC Approves FPL Rates for Added Nuclear Generation

TALLAHASSEE — Completed nuclear Extended Uprate Projects (EPU) at St. Lucie Units 1 & 2 and Turkey Point Unit 3 has added 367 megawatts (MW) of clean, nuclear generating capacity to Florida Power & Light Company's (FPL) energy portfolio. Since the projects are now serving FPL customers, the Florida Public Service Commission (PSC) today approved a base rate increase to cover increased operating costs as allowed by rule.

Because nuclear power is low cost, the added capacity will benefit Florida's customers. Over the life of the projects, savings are estimated to be \$3.8 billion. These figures also include the EPU project currently underway at Turkey Point Unit 4, which will add 123 MW of capacity upon completion next year.

Across the United States, nuclear uprate projects are considered a cost-effective way to increase energy capacity, since there are currently 16 EPU projects waiting for Nuclear Regulatory Commission approval.

Through Florida Statute 366.93, enacted in 2006, FPL can increase existing nuclear reactor capacity and petition for revenue recovery through a base rate increase when the project is placed in commercial service. The statute allows for project carrying costs to be recovered during construction, lowering the utility's base rate increase request when

a project is completed and put into service.

FPL's approved \$246 million revenue increase represents a base rate increase of \$2.59 per month on a typical 1,000 kilowatt hour residential bill beginning in January.
