In August the Florida legislature was called to convene a special session. A Circuit Court Judge, Terry Lewis, ruled that the congressional map did not meet with the recently passed Fair District Amendments to the Florida Constitution. This judge ruled that 25 of the 27 congressional districts were legal, but invalidated Districts 5 and 10 which are currently represented by Corrine Brown and Daniel Webster, respectively.

During the special session new maps were drawn which addressed the Judges' concerns. We remain hopeful that what passed the Florida House and Senate will comply with the Constitution.

A hearing has been set for August 20, 2014, to hear arguments on the new map and possible changes to the election schedule. The lawsuit was originally brought forth

by the League of Women Voters, Common Cause of Florida and other Democratic-aligned groups. They are trying to argue that this year's election should take place under the newly drawn districts. It is unknown what will happen to ballots already cast and their fate would be decided by Judge Lewis' ruling after the August 20 hearing.

Many of you have already cast your ballot and your vote should count! The Florida Speaker of the House and Florida Senate President have committed to maintaining their strong objection to any attempt to invalidate thousands of ballots cast by Floridians including our overseas military personnel.

While we believe in separation of powers, we are going to do all that we can to prevent special interest groups and activist judges efforts to create chaos in our election process and invalidate your vote.

**Officers Suspended Without Pay**

5 OFFICERS SUSPENDED WITHOUT PAY FOR EXCESSIVE USE OF FORCE

MARION COUNTY, FL (August 11, 2014) - On Thursday, August 7, 2014, (5) officers with the Marion County Sheriff's Office assisted with the execution of (5) search warrants and (5) arrest warrants. During this time, a use of force was used by these officers to affect an arrest of one of the wanted subjects. As a result of the agency's standard use of force review, the Sheriff's Office discovered that video existed depicting the officers actions which appeared to be potentially excessive. Sheriff Blair and his senior staff were briefed about the circumstances regarding this use of force, as

well as reviewing the video taped evidence. Upon reviewing this information, immediate action was taken by Sheriff Blair to suspend all 5 officers involved in this arrest without pay and at the request of Sheriff Blair, contact was made with the Florida Department of Law Enforcement to conduct an investigation of the incident who will work in conjunction with the State Attorney's Office.

Sheriff Blair has taken swift action concerning these allegations of misconduct and does not and will not condone inappropriate conduct. The agency is unable to comment further concerning the investigation other than the investigation is on-going by FDLE.

**HEARING MATTERS**



Paul was born in 1939 in Delaware. He rough-housed with his 4 brothers and teased his 2 sisters like all normal brothers. His mom would ask him to, quiet down as she melodically played the piano for his family. Paul played baseball, was a Cub Scout, had a cork gun and collected trains. Paul jokes with his family that his brain did not turn on until the third grade and while he learned to read and write the country recovered from World War 2. His father worked

in insurance and loved his family dearly.

When Paul a now father of three and grandfather of five tussles with his young grand kids or golfs with the older ones in the back yard, hearing loss has never been at the forefront of his mind. Looking back, at a successful career in Sales with music as a hobby, it had never occurred to Paul that his ability to listen actively and understand the needs of his customers through the emotion in their voice was a gift of sharp and healthy hearing. As he harmonized with his Barbershop quartet to perfect pitch and played the piano for church, he never dreamed that one day it would be difficult to even hear the notes.

Paul a jovial and loving man recently

found himself continuously asking, what? And snapping at his loving wife out of frustration. Paul was embarrassed by the constant need for her to reaffirm what she had said. Paul a provider for his family and has never needed to rely on the assistance of others. Still playing with his trains this Christmas and listening to the television on high volume just to hear Jimmy Stewart's lines in, "it's a Wonderful Life" he realized much like Stewart's character in the film, he himself was beginning to lose touch with the world around him. He wondered, how much more of a difference could I make? How much more do I have left to give? How much richer would my relationships be if I could hear clearly?

Knowing that prolonged hearing loss can lead to a decrease in alertness, a safety issue with his young grand children around, increased chance of dementia which plagued

his sweet mom in the later years of her life and depression, fatigue and stress which was now beginning to be directed towards the love his life, his wife, he needed to make a tough decision.

Paul said that it was funny how history repeated itself, his light came on he began to enjoy conversations, music and television in a way he had not been able to for years and the country continued to recover from war.

Paul knows that it took all of the pride and confidence he had learned in the Cub Scouts and on that baseball field to admit he needed to meet with a hearing expert at Audibel hearing centers, but he knew that they have successfully been treating hearing loss for many years. Paul knew that they had experience and training in the latest top of line methods and technology required to fully evaluate his hearing and to provide the care and solutions he needed to reverse the effects of his hearing loss.

Today Paul sits with his family by the pool as his grandchildren run through his garden and he sips a lemonade and listens to his sisters and brothers reminisce about the good old days. Paul responded I sure do and he chuckled to himself knowing his wife would still say that he messed up the house but he knew because of his trip to audible hearing centers no one would ever tell him to turn down the radio again!

## CEP News

Most often, we talk about our efforts at recruiting new primary employers (Business Attraction), helping existing companies to grow and expand (Business Retention), and assisting entrepreneurs start and grow new businesses (Business Creation). Our efforts at Business Services aim to provide the tools necessary to allow any business or business person to grow their business through Networking, Talent Development, and Business Education. There have been several recent projects which are helping our community be an opportunity place.

### IHMC

The Florida Institute for Human and Machine Cognition may well be one of Ocala's best kept secrets. Its unusual name and unique mission leave a number of people

wondering what goes on in the former Ocala Library just off the downtown square. However, IHMC is the epitome of an opportunity place.

IHMC is a not-for-profit research institute with scientists and engineers investigating topics related to understanding cognition in both humans and machines. Headquartered in Pensacola, the Ocala research center opened in 2007. The facility is currently undergoing a renovation with the basement being converted to offices to house more researchers. This facility houses some of the most distinguished natural language researchers in the world and it is here, in downtown Ocala!!

In addition to ground breaking research, the facility hosts a number of lectures bringing more renowned and recognized speakers to our community. Additionally, IHMC hosts programs and initiatives to engage young people in STEM related areas such as robotics. Let me repeat the most important part—this facility and researchers bringing opportunity is in downtown Ocala.

### Sprint Building

Nearly adjacent to IHMC's facility is the former Sprint building. The Ocala City Council recently approved plans for local developer Sandy McBride to renovate the building, formerly an office building, into approximately 15 lofts. The project will result in a nearly \$3.7 million investment in the community.

Our community already offers a wide va-

riety of housing. From gated communities to historic homes, zero lot developments to sprawling country estates can be found here. The lone exception is downtown lofts. What upper story living exists is quickly filled whenever a unit becomes available. The addition of 15 or more units will not absorb all of the demand but it will be significant addition. You will truly have the opportunity to have any type of housing here, in our community.

Entrepreneurship

When you combine IHMC, the loft project, and the growing technology base with now established companies like Seven Gun Game and Ocoos, joining new and growing businesses like R+L Carriers, Ansafone, and a nearly full Power Plant Business Incubator, one can discover that virtually any opportunity (include research, technology, and urban living) can be found here.

Growing these opportunities and more is what will continue to keep our community Moving Forward!

GOV RICK SCOTT: PER STUDENT SPENDING WILL BE HIGHEST IN FLORIDA HISTORY NEXT YEAR

Will propose an increase in total state funding for education to over \$19.6 billion

Governor Rick Scott said, “I am proud to announce that in the upcoming legislative session we will propose an increase in Florida’s per-pupil spending to the highest level in our state’s history. We already have the highest total spending in K-12 this year and gave every teacher the opportunity for a pay raise. Because we were able to get Florida’s economy back on track, revenues are now

projected to stay at a strong enough rate to support historic investments in education.”

“Florida job growth, and the overall growth of Florida’s economy has made it possible for us invest record amounts in education. The credit for our historic investment in education goes to the hard working people of Florida who make it all possible.”

“My mom taught me that a good education was the way out of poverty and I want all Floridians to have the opportunity to receive a great education and have their shot at the American Dream. By increasing per pupil spending to historic levels next year, school districts will have more resources to provide Florida children the best education possible.”

The Governor’s proposal would equate to a total of over \$19.6 billion, which means \$7,176 per student - a \$232 per student increase over this school year and a \$50 increase over the 2007-08 per student funding level of \$7,126, the previous record high level. Florida’s Revenue Estimating Conference for the General Revenue Fund met on August 7, 2014 and Floridians will see sustained revenues. Florida is projected to have a growth of nearly \$1.1 billion over the latest 2014-15 revised forecast.

## Recreate a Restaurant Classic

Serve Porterhouse Pork Chops with Steakhouse Butter

### Dry-Rubbed Porterhouse Pork Chops with Steakhouse Butter

Yield: 6 servings

Prep time: 1 hour

Cook time: 8 to 10 minutes

6 Porterhouse Pork Chops, about 1-inch thick



### Steakhouse Butter:

- 1 stick butter at room temperature
- 1/4 cup shallots, finely chopped
- 1 clove garlic, crushed
- 1/2 teaspoon kosher salt
- 1 tablespoon parsley, chopped
- 1/2 tablespoon freshly squeezed lemon juice
- 1/4 teaspoon white pepper
- 1/4 teaspoon Worcestershire sauce
- Pinch of thyme
- Wax paper

### Dry Rub:

- 2 teaspoons kosher salt
  - 2 teaspoons raw sugar
  - 1 teaspoon chili powder
  - 1/2 teaspoon granulated onion
  - 1/2 teaspoon granulated garlic
  - 1/2 teaspoon black pepper
  - 1/2 teaspoon ground coriander
- For butter, two hours before grilling, heat medium-sized skillet over medium heat. Add 2 tablespoons

### CONSISTENCY 2

Last month we discussed how being consistent in all aspects of your life is not only good for your mind but also your body. I specifically illustrated this with reference to research pertaining to chiropractic care and being consistent in taking care of the human frame from a preventative standpoint. There are even psychological studies that show that being consistent in your sleep patterns, meals and daily activities keep you more focused, alert and calm during the day. I am reminded of this when I take my morning and/or evening walks. It is the time for me to not only get some physical exercise but also to connect with Mother Earth and all her creation. There is a consistency, a perfect harmony of balance throughout the Universe that keeps things “glued” together. When you are consistent you are more apt to see your connectedness to others and all living things.

This pattern of consistency in our life, in the things that surround us, and in our Universe can be explained in mathematics, the basis of all the sciences, with the “Golden Section”. I have discussed this in previous

years, but for those not familiar, let me explain. I find this particularly true with the athletes, both human and equine, that I treat. These athletes must be on a schedule of exercise, diet, and treatment to stay at peak performance. They don’t just do these things on occasion and expect to be at the top of their game. They must have a regular, consistent program. The “treatment” I share with them not only deals with balancing all the muscles, joints and nerves of their body, but also their “energy patterns”, which includes applied kinesiology, neurovascular, neurolymphatic, trigger points, acupressure and ting points. But just as important is dealing with their “psyche”. Now this is different in horses than in people. Horses deal more with instinct, as I like to say, in that who you are speaks so loudly they don’t have to hear a word you

say. They don’t care what kind of degree you have, how well you dress, or the vehicle you drive or house you live in. But if you don’t have your health, no matter how “rich” you might be, it is impossible to stay on track. I urge you therefore to take good care of the vessel your Maker endowed you with. If you do you will be at the optimum point in achieving maximum success and happiness.

butter and melt. Add shallots, garlic and salt. Cook for about 5 minutes, stirring occasionally until shallots are soft. Transfer to medium bowl and let cool for 15 minutes.

Add remaining butter, parsley, lemon juice, pepper, Worcestershire sauce and thyme. Using fork, mash and mix until fully blended.

Lay out a piece of wax paper (approximately 12-by-12 inches) and form butter into an 8-inch-long log shape in center. Roll butter up in wax paper and twist ends tightly to form an even round log of butter. Place in refrigerator for one hour or until firm. This can be made up to two days ahead of time.

For rub, combine salt, sugar, chili

powder, onion, garlic, pepper and coriander in small bowl. Mix well. Sprinkle rub liberally on both sides of pork chops. Let rest for 15 minutes.

Prepare grill to cook directly over medium-high heat. Place pork chops on cooking grate and cook for 4 to 5 minutes until golden brown on bottom. Flip chops and cook another 4 to 5 minutes until golden brown on second side and cooked to internal temperature between 145°F (medium rare) and 160°F (medium). Remove from grill and let rest for 3 minutes.

Unwrap butter and cut it into 12 equal-sized medallions. Serve each pork chop with a medallion on top.
