We in the Florida House of Representatives adjourned three days earlier than scheduled this year, because of an impasse over the state budget, mainly because the legislature cannot agree on healthcare

funding. I thought it would be important to provide some perspective on this very important issue.

Our reasons for opposing Medicaid expansion are simple and clear: Medicaid is a flawed program, and the federal government is an unreliable partner.

Numerous studies suggest that patients with no health insurance at all often have better health outcomes than those covered by Medicaid. Its notoriously low reimbursements to doctors, hospitals, and clinics that treat Medicaid patients offer little incentive to provide excellent care. It is my belief that a program that currently covers 3.7 million Floridians at a cost of \$23.5 billion a year, should be yielding better results.

Furthermore, expanding Medicaid is bad for our children and our grandchildren. Some argue that federal funds are "free" money. Nothing from a government with an \$18 trillion debt is free. As tempting as it may be to accept money for a quick fix to a current crisis, we know that Florida families will shoulder our share of the national debt burden. Every new dollar spent on expansion to cover able-bodied adults means less money for our children's education and public safety, or higher taxes to foot the bill. We believe that what we do today has consequences for tomorrow.

But there is yet another reason why the House opposes Medicaid expansion, and it's

because we believe we can do better for the neonle we serve.

Some say that expanding Medicaid is the compassionate thing to do. We say there's no compassion in offering substandard care to Florida's most vulnerable citizens and saddling our children and grandchildren with unsustainable debt.

That is why the Florida House opposes expanding Medicaid and Obamacare, and that is why I am proud to stand with them on this issue.

#### THE MARION COUNTY SHERIFF



CRIME RATE LOWEST IN HIS-TORY

The Florida Department of Law Enforcement released their crime statistics for 2014 on Wednesday, May 20th, showing that the number of

index crime offenses (murder, forcible sex offenses, burglary, etc.) within the jurisdiction of the Marion County Sheriff's Office has decreased by 4.1% during the past year. Since Sheriff Chris Blair took office in 2012, the MCSO's index crime offenses have decreased by 8.9% to the lowest crime rate in the history of the agency.

Here's a breakdown of the key crime/ numbers that have decreased at the Sheriff's Office from 2012-2014 under Sheriff Blair's leadership:

Index Crime Offenses -8.9%, Murder -14.2%, Forcible Rape -21.3%, Aggravated Assault -16.3%, Burglary -14.8%, Larceny -4.2%

According to the FDLE, the MCSO has the 17th lowest crime rate out of the 67 Sheriff's Offices in the state of Florida. The MCSO's 4.1% crime rate decrease does not include the cities of Ocala, Dunnellon or Belleview.

FDLE also released statewide crime clearance rates on Wednesday (the clearance rate measures the amount of crimes solved by

law enforcement). According to the FDLE, the MCSO had a 53.6% clearance rate for 2014, the sixth highest clearance rate among Florida's 67 Sheriff's Offices. That's more than double the state average of 26.1%. This means that citizens within the MCSO's jurisdiction are more than twice as likely to have their crimes solved compared to citizens in other counties in Florida. For Sheriff Blair, our 8.9% crime rate decrease shows the hard work that he and his dedicated employees have done to make sure Marion County is a safer place to live. "Over the past two years, we have changed our game plan on how we solve crime in Marion County," said Sheriff Chris Blair. I created our Crime Suppression Unit, which specifically targets major crimes and takes wanted offenders off the streets quicker. Placing these repeat offenders in jail frees up our deputies to handle other calls for service. I have also increased our crime prevention awareness presence to help better educate our public about crimes in their areas. Additionally, we have reached thousands of citizens through our Citizen's Academy Partnership program, Town Hall Meetings and social media interactions that have allowed our agency to be more transparent and provide an outlet for citizens to engage in dialogue with us so we can more proactively fight crime. I believe our 8.9% decrease in crime is due to these cumulative proactive measures we are taking and I am proud to say to our citizens that they are safer now than they were two years ago.

Take a Look at What Ocala/Marion County Has Accomplished!

What a great time to live in Ocala and Marion County! There are so many incredible things going on in our community. In

the busyness of work and life, we sometimes miss the good news about our community. This month, I would like to highlight some of the really incredible news and announcements of recent days:

Among the Fastest Growing Economies Over the last 24 months, the economy of the Ocala MSA (Marion County) has grown 1/3 faster than the national average. Additionally, according to a report prepared for the US Conference of Mayors, the area is predicted to be one of the 40 fastest-growing economies in 2015.

Leading Florida is Job Growth

The Ocala MSA has been the leader over the last year in job growth. Our job growth rate was approximately 50% higher than the Florida average. The local economy added jobs in nearly every category. The Ocala MSA was #1 in the growth of health care and education jobs and #2 in manufacturing jobs. These numbers align with a report from Forbes a couple of years ago which predicted the Ocala MSA would be the national leader in job growth.

Most Challenging High Schools List

All seven of Marion County's main stream high schools were included in the Washington Post's most recent list of Most Challenging High Schools. This list identifies approximately the top 10% of high schools based on the number of collegelevel exams taken by students and then the number of tests at each school was divided by the number of graduating seniors. Consider for a moment that ALL SEVEN of our high schools made the list. Incredible!!!

**CSX Select Site** 

Recently, CSX announced they had certified an 86-acre site at the Ocala/Marion County Commerce Park as a CSX Select Site. This made Ocala and Marion County as the home to the first CSX Select Site in Florida and one of a handful of Select Sites in the Eastern US. This significant designation tells any major rail user that CSX has determined that they can serve most any company's rail needs at this location.

Partner Trade Grant

The CEP was recently awarded a \$7,500 grant to assist with the planned trade mission to Newbridge, Ireland. Planned for the fall, this trip is focused on encouraging export opportunities and business partnerships with businesses in Ocala's twinning city. Additionally, Newbridge and Ireland offer a great entry point into the European Union. The grant will be used to help fund Gold Key Matching Services for participating businesses. The Gold Key program is a US Department of Commerce initiative which provides qualified appointments for our businesses.

#### "Not All Who Wander Are Lost"

Bike culture The Decision to Press Further

After arriving in Copenhagen and settling into my kollegium (Danish style dormitory) and meeting my roommate and other students in my program, things were settling in well and classes began. Copenhagen is famous for being one of the most bike friendly cities in the world, so it wasn't long before I had my own bike, rented for the duration of my stay. Part of our student package included a transportation pass for the bus, metro, and S-tog (pronounced S- tow, which translates to "S-Train") All of these systems were a million more times convenient, efficient, and popular than what I was used to in America, but to really experience the city, you need a bike. Plus a bike was still the preferred method of travel for most of the inhabitants of Copenhagen (more than 50% of travel in Copenhagen is done by bicycle).

In Copenhagen, the transportation infrastructure is designed to highly favor bike traffic over vehicles, and city busses over personal cars. So for example, there are several roads, once you get into the heart of the city, in which only busses and bikes can travel down, no personal cars. Also, all of the main roads have bike lanes, to a caliber that are unrivaled to any I had experienced in America. Complete with their own traffic lights, turn lanes, and resting bars to lean against at stop lights, as to save one from dismounting their bike. The traffic light and flow patterns were designed so that if you are riding your bike at a speed of 12 kilometers an hour (about 7.5 mph, and on certain roads) you will actually sync up with

the lights to get continues greens lights. And ultimately, this means less stopping in traffic and shorter commute time than if you were driving a car. Not to mention the taxes on purchasing a car (as told by one of my Danish professors) is 120% of the cars cost. Once insurance is factored in the extra costs total 200% of the price of the car. With costs like that coupled with the convenience of bicycling, it's rare that anyone living in the city has a car (29% car ownership rate). This "convenience" also provides all the health benefits of exercising and less traffic congestion and carbon footprint.

There was much exploring and learning to be done about the city. Denmark places a lot of priority on green design, environmentalism, human happiness, and a high level of "livability". A fun example would be that in the heart of Copenhagen there are trampolines built into the sidewalks, up to about 6 in a row. They are designed to encourage spontaneous play. If you sit on a bench near them you will see them not only used by children. You can catch businessmen in suits heading to lunch, college age young adults, children, and senior citizen travelers visiting from other countries. Small things like this are at the core of what makes Denmark unique and just a bit whimsical and equally outrageous to my own American experience. At the same time, it is an incredibly safe city. There were many times that I would just walk around the city late at night, all by myself. This was not an outrageous thing to do either. Even here in America at my university, there are signs posted all over cam-



pus telling me to, "Be Safe, don't walk alone at night!" -this breaks my heart, for various reasons. There is a joke in Copenhagen, basically saying that if a crime is committed against you, you can only be a bicycle, as bicycle theft is the only crime anyone really worries about.

All of my other American student peers were from all over the country. I made friends from schools such as University of Kansas, Michigan, Arkansas, UC Santa Barbara, etc. But no matter where we were from and our vast array of life experiences we were all taken aback by the simultaneous whimsical and practical nature of the city and its people. We were all smitten. We were also

Although, I was about four years older than a lot of my contemporaries, this age difference wasn't enough to make our lives too far removed from each other. In fact, I was able to meet a handful of people I will probably keep in touch with for a very long time, especially with the help of mediums like facebook.

I became close with several young women in particular. As providence would have it, my randomly selected roommate and I became very close. And when a major and entirely unexpected tragedy struck me, the death of a very dear friend back home, she was there for me above and beyond what could be asked of a stranger. She had a heart

of gold. So much so that she spent the previous summer in Cambodia working in the red light districts with Christian missionaries. fighting against the sex trade. Even though she was barely 21 years old, she was an inspiration to me and as I found out later, to many others in our program as well. Her heart was so on fire for Jesus and being the type of person God would hope someone could be while at the same time not being pretentious at all about it AND a lot of fun to be around. She was also an adventurer. After classes ended she was planning to meet with her sister and another friend and go traveling around Europe and do volunteer work in hostels in exchange for free room and board for the next four months. It was organized through a website called HelpX.net, almost like a traveling volunteer's version of craigslist. "How exciting and brave!" I thought!

Each day the "brevity of life" and what was to be done with it consumed my thoughts. Until eventually, after two months of watching my roommates' travel plans for the fall come together before my eyes, I one day had an epiphany that I was going to do the same. Except that I was going to do it alone. For what seemed like the first time in my life I was going to do something (that may have seemed to others completely crazy) entirely alone. I decided that I to was going to go traveling, playing it by ear, for a month around Europe. It ended up growing (as all good plans should) into four months. Never planning where I would be more than three weeks in advance.

So I signed up for HelpX, two weeks before classes were going to end, chose the small search area of "ALL OF EUROPE" and began to search for some place beautiful that sounded like it had fun work to do. The first place I found was a gorgeous finca

(small farm) in Spain, with a river running through it, hills and forests surrounding it, with some horses, cows, a donkey, chickens, and a Border Collie name Xuco (shoe-ko) who became my hiking partner. It also had a nearly 500 year old working iron and grain mill, both still operational. The work to do was to tutor a woman in her early 30's in English. In exchange my meals and housing would all be provided for. I figured, "hey, I know English and my grammar is decent enough to give guidance." But most of all, the pictures with her ad were beautiful. So we got in touch and it was arranged that she would pick me up at the airport once classes ended. But in the meantime I was able to go on a final class trip to Edinburgh and Glasgow Scotland where we explored so many castles! Castles on every corner, more castles that America has Starbucks we joked! Myself and two of my girlfriends even made friends with some high school age guys who were celebrating their version of prom (a Kaylee) in their formal kilts and whole familv based traditional regalia and they tried to teach us to dance with them in traditional

and accountability are critical to supporting our veterans. It is no secret that our veterans who have served with honor and distinction were not receiving the proper care they deserved, and when Florida offered support and assistance - our efforts were rebuffed.

This problem arose last spring when national media reports documented the poor treatment of veterans at federal hospitals in the Sunshine VISN, a federal region including Florida and other states. Reports said the treatment of veterans was so neglectful that veterans sustained injuries and tragically lost their lives. These issues were also made visible through the hard work of Florida Congressman Jeff Miller, who shed a light on the conditions plaguing federal VA facilities – and we are appreciative of Congressman Miller's efforts to protect our veterans and hold the federal government accountable.

We cannot allow our heroes to suffer at the hands of neglect and incompetence ever again. I appreciate your willingness to follow through on Florida's requests to provide our Agency for Health Care Administration with audit reports detailing facilities' activities and to take action on our requests for information.

We have said for some time that Veteran's Affairs was not taking our requests for information seriously, and your commitment demonstrates a fundamental shift from how the federal department previously operated. It is imperative, however, that the VA follow through on its commitments; no doubt greater transparency and accountability will benefit our veterans.

Thank you for your immediate attention to these matters and I look forward to your action on these issues.
