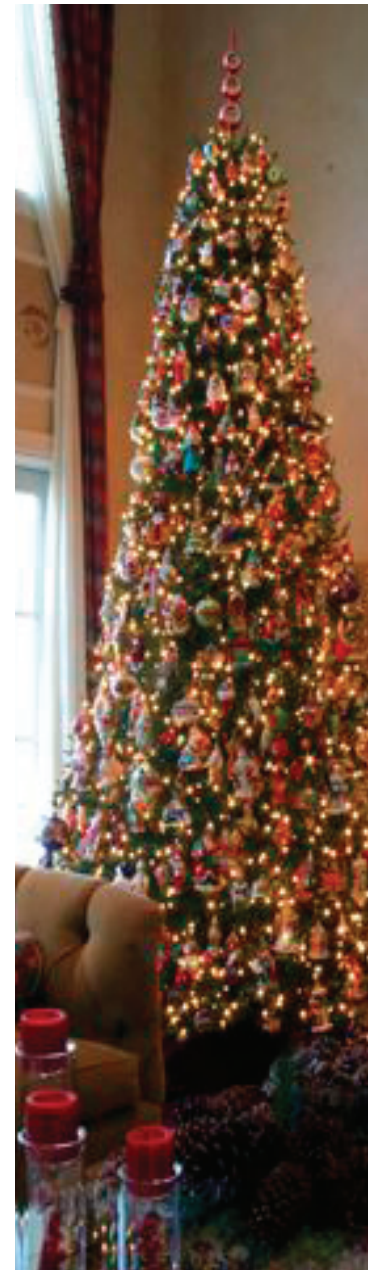

This week House Bill 169 was presented to the Criminal Justice Subcommittee. This bill was drafted in direct response to a Florida Supreme Court ruling, which stated that the original

legislative intent of Stand Your Ground was unclear in regards to the burden of proof in Stand Your Ground hearings. The Supreme

Court had ruled that the burden of proof rests with the accused. That was not the legislative intent. In fact, when Stand Your Ground was passed, a pre-trial hearing was never contemplated; this was a construct of the courts. Currently, the burden of proof lies on the citizen claiming self-defense. This effectively designates such citizens as guilty until proven innocent. House Bill 169 would change the burden of proof, reconciling the fact that American justice asserts the defendant as innocent until proven guilty. It is always the duty of the state to prove a crime was committed. Unfortunately, HB 169 did

not pass its first committee, Criminal Justice Subcommittee. Justice Cannady and Polston made clear in their dissenting opinion, "By imposing the burden of proof on the defendant at the pretrial evidentiary hearing, the majority substantially curtails the benefit of the immunity from trial conferred by the legislature under the Stand Your Ground

law. There is no reason to believe that the legislature intended for a defendant to be denied immunity and subjected to trial when that defendant would be entitled to acquittal at trial on the basis of a Stand Your Ground defense.

bert of Utah, Scott Walker of Wisconsin, and Matt Mead of Wyoming all signed on to the letter. In the letter, the governors express serious concerns about recent comments made by Federal Bureau of Investigation Director James Comey in which he admitted that the U.S. does not have the capacity to adequately screen all Syrian refugees who attempt to enter the U.S.

As governors, we are charged with ensuring the safety and wellbeing of our citizens. In order to adequately fulfill this duty, we

request that you immediately review the process by which you conduct background checks on all individuals applying for refugee status and address the gaps acknowledged by your director of the FBI.

In the wake of this recent tragedy, and until we can ensure the citizens of our states that an exhaustive review of all security measures has been completed and the necessary changes have been implemented, we respectfully request that you suspend all plans to resettle additional Syrian refugees.

Recently, the Ocala Star Banner wrote an opinion editorial entitled Shortchanged on Impact Fees, which we believe with more information the writers would have understood the proposed approach

actually maximizes funding for transportation and public safety—two significant needs in our community.

This is an issue which has been discussed and debated at public meetings for more than six months. The driver for this discussion is economics. For those who are unaware of this discussion, earlier this year the County Commission hired a consultant (as required by law) to review transportation impact fees should they be reinstated. The consultant did come back with a set of recommendations. However, more than a few people were disturbed by the recommendations.

The Commission did ask the CEP to assemble a task force to review. The task force included representatives from engineering, road building, commercial real estate, residential real estate, home builders, commercial builders, law, developers, finance, and

appraisers. The group represented professionals who work on the front lines in this area every day but it also represented groups who at times are at different points in this discussion. Yet despite their differences, this diverse group came to a unanimous set of recommendations.

The greatest challenge to the consultant recommended impact fees (besides creating the highest fee schedule in the region) was the lack of knowledge to current building challenges. Coming out of the Great Recession, anyone who has built or purchased a home or building has experienced the conservative nature of appraisals. What one may not realize is that approximately 30% of proposed new construction is NOT appraising at estimated construction cost. In other words, it costs more to build than the appraiser thinks it is worth. If a project does not appraise, then it does not get built.

The task force made a number of recommendations which included reduced impact fees and the sales tax. A four-year sales tax not only generates more money for our substantial backlog of transportation needs but it also provides a significant source of revenue for both public safety and our cities. The sales tax (1% would cost the average Marion County household less than \$100 per year) would ensure that everyone is

helping to fund our transportation and public safety. It ensures that the thousands of guests and tourists who use our roads and rely on our public safety system while in Marion County are helping to support and fund these items.

The path, which has allowed our community to get to this point, is an excellent example of our elected leaders partnering with community members with on the ground experience to come to solutions that address pressing issues.

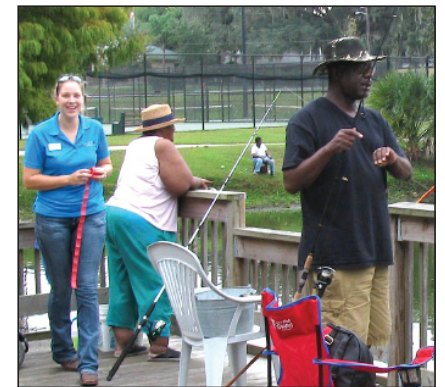

Sobering Statistics: Impaired Driving During the Holidays

Christmas and New Year's are some of the most festive times of the year: family get-togethers and parties are things we love about the holiday season but these festivities can be dampened due to drunk driving. The U.S. National Institute on Alcohol Abuse and Alcoholism reports that drunk drivers play a role in about 40 percent of traffic deaths over the holidays. The U.S. Department of Transportation says that 300 Americans die each year in the days surrounding the Christmas and New Year's holidays. An average of 27 people nation-wide die each day in December due to drunk-driving wrecks alone.

The victims of impaired driving have no limits: they can be grandparents, parents, young adults with bright futures and children who have not yet experienced all the wonderful things life has to offer. These statistics are supposed to be sobering. Drinking and driving is truly a selfish act that affects so many people, and yet, this issue is easily prevented.

During the holidays, we encourage you to prevent impaired driving by not consuming alcoholic beverages if you plan to drive. If a guest does consume alcohol at a party, make sure a designated driver is arranged or have them sleep over at a friend's house until they sober up. When driving on the roads, be extra vigilant and practice defensive driving techniques. In addition to not drinking and driving, put your phone down and pay attention to the road. Your vehicle is the most dangerous weapon you will ever possess and being an aware driver helps you prevent an accident right out the gate.

Our patrol deputies will be on the roads this holiday season looking for impaired drivers. If you observe reckless or impaired driving, please call 911 so we can dispatch a deputy to that location. “Not All Who Wander Are Lost”

Not All Who Wander are Lost: In the Garden of Mette

I arrived back in Copenhagen, Denmark on August 12, 2014 and planned to stay there until early September when I would travel to Hungary. My time spent during this second round was spent living very simply. My host, Mette, had a small home that she had built herself on a tiny plot of land on the edge of the city. The community she lived in was like nothing I had seen before. In the 1950's these cabins were summer homes for the upper middle class to get out of the city. There are now deed restrictions and requirements of full time living for these communities. Such country living while still being within the conveniences of the city is a rare commodity. By bike, it was still only a 40 minute bike ride to the heart of Copenhagen. Most of the people living here had large gar-

dens in these tiny spaces. To visualize, the land plots were just a bit larger than half of a volleyball court. Mette's property was absolutely maximized for gardening. Her goal was to be able to grow everything she eats, in her garden and minus a few things this was nearly a realized goal. She had several apple trees, a plum tree, potatoes, various squashes, tomatoes, chilies, beans, berries, various leafy greens, at least 10 different types of herbs, and finally bees. Stepping outside and having nearly all of the ingredients needed to make an impressive meal all within a 20 foot distance from the front door was nothing I had ever experienced! I would go outside every day and pick my own leaves for making mint & pineapple-sage tea. Everything was made from scratch and she taught me (but I learned poorly) how to make various breads from scratch.

My main job was to pick up the apples that would fall each day.

Her house was 900 square feet at best. It had a fully equipped kitchen, a living room, and an unfinished bathroom. This meant she had a compost toilet and then the shower wasn't constructed yet. Just outside the back door she had a claw-foot tub that we would run the flexible shower head to and then shower in the garden. When the weather was sunny, this was so nice! But in Copenhagen, even in August, the temperature was often in the high 50's or raining. Suddenly the outdoor shower was much less romantic. Her property was all privacy fenced so there was no worry about being seen by neighbors. But I'm sure you're wondering, "... wait, compost toilet??" If you do a youtube search of "waterless dry toilets" the first video that comes up is the closest example to what we had. Basically, a compost toilet is an alternative to having a septic tank. Here, there was a large open tank underneath with a normal looking toilet in the bathroom. The toilet had diverted the urine away to keep the "products" separate (keeping the excrements separated kept it from stinking). After a "#2" one would just pour a scoop of sawdust into the toilet. Mette said she would have to go outside and rotate it only about once per month, as she lived alone. She also claimed that the only time there was ever a smell was if someone who ate meat (she was a vegetarian) would stay with her, and even still, that it wasn't substantial. Before arriving I knew she had a compost toilet, but didn't really know what to expect. Once I got there all my fears were put to rest as it was really not too far off from normal and certainly not any more dirty or abnormal than a typical toilet.

Her "room" was a loft that was really just an extension of the living room. This meant I didn't have my own room or real bed. I set up a roll out mattress (that was actually the most comfortable bed I had during my entire Euro trip) and used an old antique trunk to act as a bit of a divider. From my "bed" I could look out the big windows that lined the living room wall and look out at the stars. Since we basically slept in the same room we would usually get into our beds and then end up having bed time chats, like preteen girls at a slumber party.

FROM THE GOVERNOR'S DESK

Dear Speaker Ryan and Leader McConnell:

Please be aware that several organizations have requested that our state Department of Children and Families support the relocation of 425 possible Syrian refugees to Florida, as they receive federal funding to house these refugees in our state. Following the terrorist attacks by ISIS in Paris that killed over 120 people and wounded more than 350, and the news that at least one of the terror attack suspects gained access to France by posing as a Syrian refugee, our state agency will not support the requests we have received. More importantly, however, it is our understanding that the state does not have the authority to prevent the federal government from funding the relocation of these Syrian refugees to Florida even without state support. Therefore, we are asking the United States Congress to take immediate and aggressive action to prevent Presi-

dent Obama and his administration from using any federal tax dollars to fund the relocation of up to 425 Syrian refugees (the total possible number of refugees pending for state relocation support at this time) to Florida, or anywhere in the United States, without an extensive evaluation of the risk these individuals may pose to our national security.

As the federal elected body that exercises oversight and authorizes federal spending, please take any action available through the powers of the United States Congress to prevent federal allocations toward the relocation of Syrian refugees without extensive examination into how this would affect our homeland security.

My office stands ready to provide any available information regarding this request for your immediate action.

Mette was the real definition of a "foodie". She had a Masters degree in food studies, was currently teaching college level food and cooking classes in Copenhagen, and also worked as a major event planner for large scale food related events. While I was there she was working to finish organizing an anticipated 3,000 person food festival to take place in the middle of the streets of the Vesterbro district of Copenhagen. There was also a food festival for children that Mette was working on and so I volunteered to help her out with that. Fancy this, my volunteer time even counted towards the practicum hours that I needed in order to graduate from UF. So all the while I was having this wonderful and educational life experience, it was counting towards my college education/credits as well. I learned so much about gardening, cooking, and food during my second stay in Copenhagen.

The children's food festival was oriented to teach kids in a hands on way where food comes from, what it looks like raw, and be encouraged to try new things. They even had a stage in which a man butchered a pig on stage and educated the crowd by showing all of the organs, explaining the uses of each part of the animal, what foods they go into, and so on. But it wasn't just all educational, there was also two concerts performed, including the Danish equivalent of Justin Bieber- aka screaming preteens everywhere!

As I had mentioned previously, the perspective on parenting in Denmark is very different than in the US. Overall, much more interactive even if it means higher risk. So for example, we worked with the Organic Denmark Association in their tent. Our interactive event allowed for groups of chil-

dren (as young as 5) to choose from a large variety of vegetables, clean, cut, and prepare them to be cooked in a stir-fry over an open fire (the adults did the cooking/fire part). But the children were given very sharp paring knives or peelers in which to cut up their veggies. A group of about 6-8 kids would be working at a time with two adults advising and verbally guiding them- but very hands off overall. The kids would peel dice and chop all by themselves with brand new hair splitting knives! And over all the days that the festival lasted and the several hundred children that came through our tent, only one person cut themselves. And that person was ME, the ADULT! I was washing dishes and the knife slipped and... ta da! Danish society doesn't shelter or coddle their children as much as we do in the US. Remember, it was my Danish professor several months earlier that had told me, "In Denmark we pride ourselves on the right for our children to break their arm." She said this to address the general topic, while we were discussing playground designs and how they have fewer safety features (such as railings) than in the US.

In financial news, if you recall just before leaving Spain I had my wallet stolen. Well my father was able to express mail me a new credit card in the meantime. However, Europe had already converted to the chip system that is just now becoming common here in America. Being that my new card had no chip and only the swipe, I was still basically unable to find anywhere that would accept my credit card. If the business even had the machinery to run a swipe card, it would require a PIN number. What? I had never used this in America and it proved borderline impossible to find out my PIN from my

credit card company. So, this meant a month of money wire pickups from my wonderful family back home in the meantime until we could figure out something more permanent. Luckily, I didn't really need money as living with my host Mette still included free room and board. And with that, the lack of money and tight budget saga continued into the future. Little did I know it was about to become even more tight as my access to money wiring was to end soon.

How To Pick A Tax Professional

(NAPSI)—If you're like most taxpayers, according to the IRS, you hire a professional to help you file your tax return—after all, a mistake could mean fines, penalties, even prison. If you do hire one, you should know that no matter who prepares the form, you are legally responsible for what's on it.

Eight Hints On Tax Help

Here are eight tips to keep in mind when choosing a tax preparer:

1. Check to be sure the preparer has an IRS Preparer Tax Identification Number (PTIN). Anyone with a valid 2015 PTIN is authorized to prepare federal tax returns.
2. Find out the fees up front. Avoid preparers who base theirs on a percentage of your refund or who say they can get larger refunds than others can.
3. Always make sure any refund due is sent to you or deposited into your bank account, not the preparer's.
4. Be sure your preparer offers IRS e-file and ask that your return be submitted to

the IRS electronically. Any tax professional who gets paid to prepare and file more than 10 returns generally must file the returns electronically. It's the safest and most accurate way to file a return, whether you do it alone or pay someone to prepare and file for you.

5. Make sure the preparer will be available. You should be able to contact the tax preparer after you file your return—even after the April 18 due date. This may be helpful in the event questions come up about your tax return.

6. Good preparers will ask to see your records and receipts. They'll ask you questions to determine your total income, deductions, tax credits and other items. Don't rely on a preparer who's willing to e-file your return using your last pay stub instead of your Form W-2. This is against IRS e-file rules.

7. Don't use a tax preparer who asks you to sign an incomplete or blank tax form.
