16-YEAR OLD INDICTED FOR 1st DEGREE MURDER

16-YEAR OLD INDICTED FOR FIRST DEGREE MURDER IN OCTOBER 2018 SHOOTING

MARION COUNTY, Florida (January 18, 2019) – On Tuesday, January 15, 2019, Marion County Sheriff's Office (MCSO) Major Crimes detectives arrested and charged 16-year old Luis Ortega (DOB:

09/19/2002) with First Degree Premeditated Murder for the homicide of 18-year old Brandon Hammett (DOB: 04/27/2000). Hammett was shot and killed by Ortega during an attempted robbery on October 26, 2018.

On Friday, October 26th, at approximately 6:30 p.m., multiple MCSO

deputies and Ocala Police Department officers responded to the area of 3200th block of SW 43rd Court in reference to a shooting. When units arrived on scene, they found Hammett in a vehicle suffering from gunshot wounds. He was transported to the hospital, where he later passed away from his injuries.

MCSO Major Crimes detectives conducted a thorough investigation and discovered that Dalton Purvis (DOB:

06/10/1999), felt that he had been cut short on the last batch of marijuana Hammett sold him. Purvis gathered Denver Sutter (DOB: 11/22/1999) and

Carlos Flores-Renteria (DOB: 01/29/2002) together and developed a plan with them to rob Hammett. Purvis also asked if Flores-Renteria could invite Ortega to come along, because he knew Ortega had a gun. Purvis, Sutter and Flores-Renteria told

As part of the CEP's mission to *be the catalyst for a prosperous community*, the organization partners closely with local governments (as well as state and Federal) to ensure that we are creating and maintaining a business climate which

encourages growth and prosperity. A recent example of this can be found in the issue of revisions to the County's Comprehensive Plan.

Over the last several months, the Marion County Board of County Commissioners held workshops and public hearings on potential revisions to the Comp Plan. Among the groups who were active in participating in this process were supporters of our area's equine industry as well as builders, developers, environmentalists, and others. Two of the clear desires of both the participants and the Commission was to strengthen our Farmland Preservation Area (FPA) and to incorporate language into the plan regarding the development of future transportation corridors especially in the FPA.

The FPA encompasses an area in northwest Marion County which is home to many of our iconic horse farms. While the FPA has existed for a number of years, it really did not have the structure to do as its name suggests—preserve farms. The CEP has been a proponent for quite a while of strengthening the FPA. Supporting the

basics of the finalized language was an easy step.

Incorporating language regarding the development of transportation in this area relates back to the community's experience last year when the state began discussions of building the Coastal Connector through the heart of the FPA. While this project died it was realized that having language in the Comp Plan which address how such projects develop was important. Many groups worked very hard to develop language which would adequately protect this area while also providing the County a seat at the table should such a project arise in the future. The CEP was honored to be able to recommend language that was ultimately adopted by the County Commission to be included in the official transmittal of the revisions to the state.

The revision process is a great example of our community's leadership and democratic principles at work. Literally hundreds of citizens contributed to the process by attending meetings, speaking, and submitting comments. The final result is document that reflects our community's strengths through partnerships and collaboration.

The CEP and our business partners greatly value our strong partnership with our local governments and look forward to continuing to work together to keep our community *Moving Forward*.

Sweet Potato Chili



- ¼ tsp ground cayenne pepper
- ¼ tsp ground cinnamon
- 2 14.5-oz cans diced tomatoes
- 2 c low-sodium chicken or vegetable broth
- 2 15-oz cans kidney or pinto beans (with their juices)
- 1½ lb orange- or yellow-fleshed sweet potatoes, or a combination, diced

Add onion and bell pepper, cook until crisp-tender, 2 minutes. Add garlic, spices, and 1 tsp salt and cook, stirring, 1 minute. Add remaining ingredients. Bring to a boil. Reduce heat. Simmer until sweet potatoes are tender, 25 to 30 minutes.

New Brain Health Initiative

New Brain Health Initiative Could Unlock Mysteries Of Alzheimer's, Dementia

(NAPSI)—Scientists are contemplating important questions about health, mind and

age: Could your blood hold the molecular secrets to a fountain of youth, preventing age-related brain disorders? Are brain aging and Alzheimer's disease caused by a failure of interconnected systems, triggering a dominolike cascade of disease? Can targeting the red blood cells and blood vessels jointly keep your brain healthy and prevent dementia?

The Problem

As people live longer, Alzheimer's and other age-related dementias are on the rise, projected to reach more than 75 million people worldwide by 2030. To date, no effective therapy has been developed for these disorders, which are not only deadly but exact a high financial and emotional toll on society.

The Research

To find solutions, three large-scale research teams are exploring those questions as part of an initiative to merge research of the brain and the blood vessels to develop new understanding of—and, ultimately, better preventions and treatments for—age-related brain disorders such as Alzheimer's disease.

The Scientists

To help, American Heart Association, the world's leading voluntary organization focused on heart and brain health, and The Paul G. Allen Frontiers Group, a division of the Allen Institute, launched the \$43 million research project to bridge the science of vascular and brain health through revolutionary, out-of-the-box thinking. Additional supporters include the Oskar Fischer Project and the Henrietta B. and Frederick H. Bugher Foundation.

The three teams, headquartered at the Salk Institute for Biological Studies in La Jolla, Calif.; Stanford University School of Medicine in Stanford, Calif.; and University Hospitals Cleveland Medical Center in Cleveland, OH, respectively, work to develop new solutions to the urgent problem of age-related cognitive decline. The researchers are:

"Rusty" Gage, Ph.D., a neuroscience researcher and president of Salk, who will lead an eight-year project looking into new targets for therapeutic research and biomarkers of early-stage cognitive decline.

Tony Wyss-Coray, Ph.D., a professor of neurology at Stanford, who will lead a four-year project studying how changes in the immune system affect cognitive health.

Mukesh K. Jain, M.D., a cardiologist at University Hospitals Cleveland Medical Center and Professor of Medicine at Case Western Reserve University, who will lead a team of investigators on a four-year project investigating whether targeting red blood cells and blood vessels can prevent dementia.

The Hope

The research could yield transformational discoveries to better detect, treat and prevent cognitive decline.

Retirement Readiness Fixes

Four Retirement Readiness Fixes For Baby Boomers

(NAPSI)—The Stanford Center on Longevity's 2018 “Sightlines Report” found that baby boomers have accumulated less household wealth and carry more debt in comparison to previous generations of American retirees.

The report found that overall household asset balances—and retirement savings in particular—are lower for boomers than for the elderly Americans born before them. detectives that they intended on Ortega's presence to serve for security and intimidation purposes.

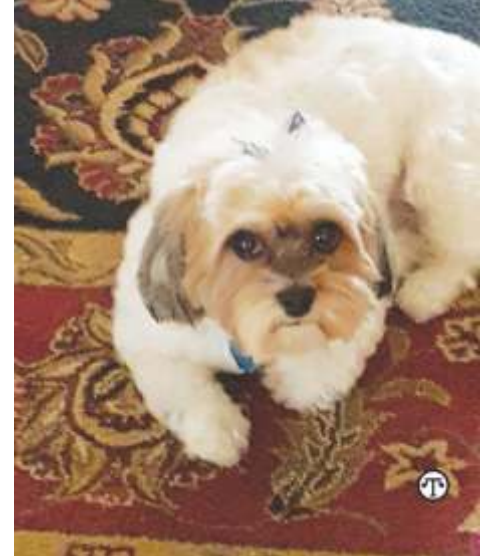
The four suspects then met Hammett at the incident location in order to "buy more marijuana." However, when Hammett arrived, the suspects told Hammett to hand over everything he had to them. According to suspects' statements, it was at this time when Hammett put his vehicle in reverse in an attempt to flee the scene. Ortega then shot Hammett while he was backing up.

Purvis, Sutter and Flores-Renteria were arrested and charged with Felony Murder in the days following the shooting. A grand jury was convened on Tuesday, January 15, 2019, and a grand jury indicted Ortega for the charge of First Degree Premeditated Murder and later that same day, Ortega was located and arrested for the grand jury's warrant. During his interview with detectives on Tuesday, Ortega confessed to shooting and killing Hammett. Ortega is currently being held in the Marion County Jail on no bond.

makes many errors and is more interested in looking at social media than working is given the same raise as other employees who are on-time, work hard and concentrate on their job—the company will be sending a message to the hard-working employee that they can get the same pay but are actually somehow stupid for working diligently.

In a more basic example, we want to stop people stealing and we have laws. Unfortunately, we are seeing that for most of us, if we are caught stealing then we are prosecuted. However, if we are part of the Elite then it becomes, as Bill Clinton famously said, "It depends on what the definition of "Is" is".

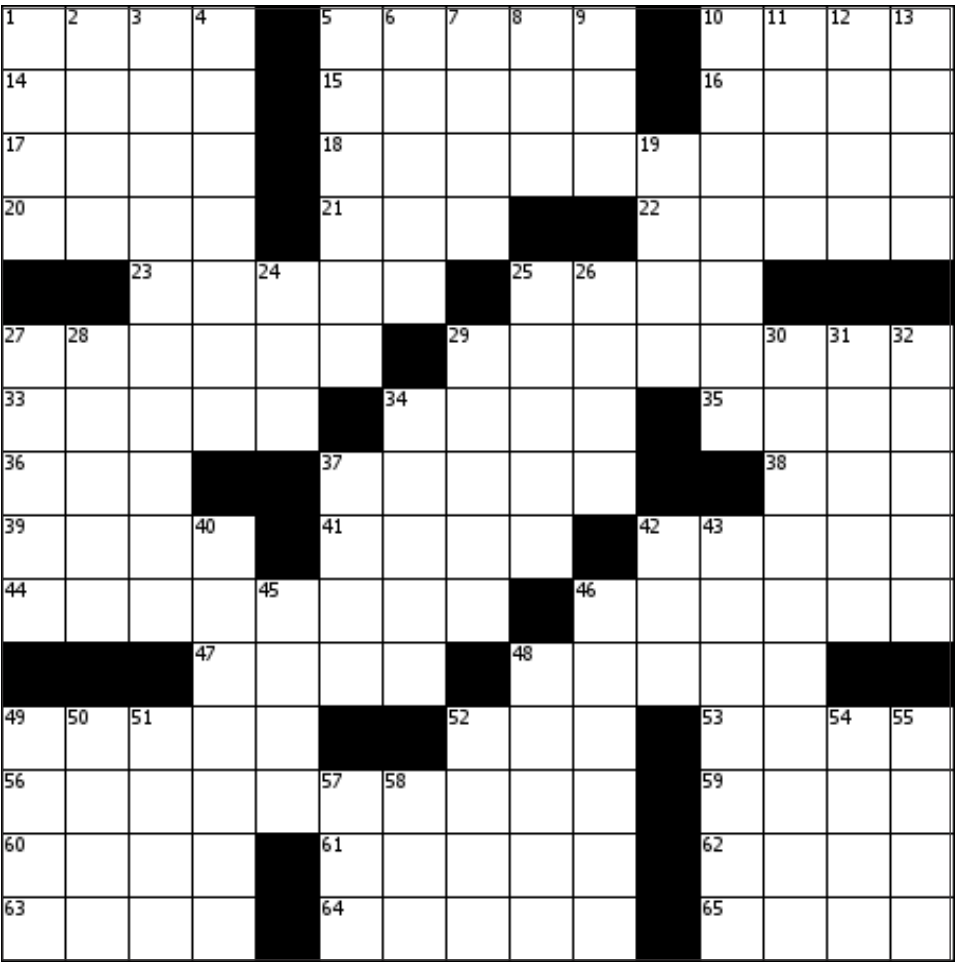

representative saved the day.

"When Mary called in, I was taken aback with her car and dog being stolen," said the tech expert who answered the call. "I really felt for her. I work at home and my two dogs are at my feet all day."

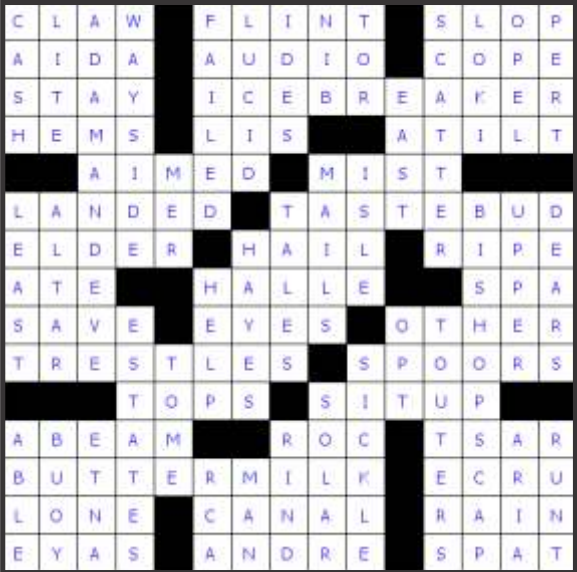
