A 1999 treaty between the United States and Ukraine on mutual legal assistance in criminal matters.

**From THE WHITE HOUSE,**

November 10, 1999. To the Senate of the United States:

With a view to receiving the advice and consent of the Senate to ratification, I transmit herewith the Treaty between the United States of America and Ukraine on Mutual Legal Assistance in Criminal Matters with Annex, signed at Kiev on July 22, 1998. I transmit also, for the information of the Senate, an exchange of notes which was signed on September 30, 1999, which provides for its provisional application, as well as the report of the Department of State with respect to the Treaty.

The Treaty is one of a series of modern mutual legal assistance treaties being negotiated by the United States in order to counter criminal activities more effectively. The Treaty should be an effective tool to assist in the prosecution of a wide variety of crimes, including drug trafficking offenses. The Treaty is self-executing. It provides for a broad range of cooperation in criminal matters. Mutual assistance available under the Treaty includes: taking of testimony or statements of persons; providing documents, records, and articles of evidence; serving documents; locating or identifying persons; transferring persons in custody for testimony or other purposes; executing requests for searches and seizures; assisting in proceedings related to restraint, confiscation, forfeiture of assets, restitution, and collection of fines; and any other form of assistance not prohibited by the laws of the requested state.

I recommend that the Senate give early

**Plaques, Bricks and a Horse Museum Downtown in the Horse Capital**

 The equine industry is a really big deal here in the Horse Capital of the World. In fact, it is worth over \$2.6 billion a year in the Ocala Metro and our public and private leadership appreciates the importance of this industry to our community.

A few years ago, the CEP commissioned a study showing the incredible number of jobs and revenue created in the Ocala area by the horse world. With this study, came a new realization of a need to find ways to bring the horse world and the non-horse world together. The CEP began its Equine Engagement Initiative with this goal in mind.

A new project from this initiative is a

partnership between the CEP and the City. Bronze plaques will be created and placed in the new or re-done sidewalks downtown to celebrate a variety of horse breeds. The plaques will name thoroughbreds or other breeds who were either born here or who had strong ties and connections to this area. Perhaps, they were trained here or spent some major part of their lives here on one of the farms. Any horse born, weaned, conditioned, competed, trained or who learned to be a racehorse here, could be eligible for a plaque or a brick. It was decided an App would play a major role in sharing the details with visitors, so that the famous horses' names could be located on this App and interested parties could learn all about the equine history and how these horses were tied to the area. Over then next

year or so, one should start to see this plaques around the square.

While developing this, we realized that many people own a pasture pet or two, who they may love dearly, but who would not qualify for such recognition. That was when the brick opportunity part of this project became a real option. A brick ribbon will be created near the bronze plaques and for a nominal fee, horse owners will be able to have their horses name placed on the brick. There are horses who, although not in the Hall of Fame and who may not have won the Triple Crown, but who have been dearly loved by their owners. For many horse owners, these beloved creatures had a very real impact on their lives. My horse Sundance, aka Sunny, is 34 years old and has been by my side for over 26 years. Sunny will be one of many to be celebrated in our downtown square on his very own brick. What better way to celebrate your horse!

## Hepatitis Cases Increasing

### Hepatitis Cases Increasing in Marion County

OCALA, Fla.-Marion County is continuing to see an increase in cases of hepatitis A locally and wants to encourage residents to get vaccinated for the virus. To help, the Department of Health in Marion County is holding its second drive-through hepatitis A vaccination event on Saturday, Nov. 2, from 10 a.m. to 2 p.m. at its Ocala office (1801 SE 32nd Ave.). Anyone who would like to receive the hepatitis A vaccine can come to the event to get the shot for free.

The hepatitis A vaccine is a two-series shot, with each dose given six months apart. The first shot provides 95 percent protection, but both shots are needed to provide long-term protection. This means individuals who obtained their first hepatitis A shot at the department's April drive-through event should come to the Nov. 2 event to complete the shot series.

The department recommends that individuals who are either high-risk for contracting the virus or high-risk for serious complications from the virus get vaccinated. This includes (but isn't limited to) individuals who:

- Use injected or illicit drugs.
- Are experiencing homelessness.
- Are diagnosed with underlying liver disease.
- Work with homeless or intravenous drug users outside of a healthcare setting.
- Are over age 60 and have a serious underlying medical condition.
- Are first responders.
- Come into direct contact with others who have the virus.

The Department of Health in Marion County has tracked 138 total cases of the virus in the county since the start of January, the sixth highest number of cases in the state. The department has been offering free hepatitis A vaccinations since early 2019 to help combat the increase in cases locally. State Surgeon General Scott Rivkees, M.D., declared a public health emergency <http://www.floridahealth.gov/document/newsroom/press-releases/2019/08/phe-hav-filed-08-01-2019.pdf> on Aug. 1 in response to the hepatitis A outbreak in Florida.

Hepatitis A is a highly contagious, vaccine-preventable illness that attacks the liver and can cause symptoms of abdominal pain, nausea, vomiting, dark urine, and yellow skin and eyes. Symptoms typically last less than two months but can last up to six months. Individuals are contagious with the virus for up to two weeks before showing symptoms. Not everyone who becomes ill with the virus shows symptoms.

The virus spreads through the feces of people who have the virus. If a person with the virus doesn't wash their hands well after

Friends,  
As the month closes, we will be well into our final few weeks of committee meetings before the 2020 Legislative Session begins in January. This leadership in Tallahassee is very

talented, energetic and committed to making Florida the best place to live, work and raise a family. We have you, the voter, to thank for sending us these leaders and it is quite humbling to be part of this great process that shapes policy for 20 million residents and millions more visitors. We do not have a perfect system, but it is so much better than anything they have anywhere else in the world. We have gotten to work on

a lot great ideas and proposals so far, and it is exciting to be able to share a few of those things with you today.

Earlier this year, we filed SB 498 Consumer Protection. This legislation will crack down on unlicensed vendors who have been predominately preying on people living in our senior communities, but their reach is not just limited to them and it is becoming a state-wide issue. These are vendors that typically show up at your front door, promise a service, take your deposit and either never return, or only partially complete the job. This legislation would help put a stop to these dishonest practices.

More specific to Lake County, though its



affects will be felt throughout the region, we have filed SB 384, which would eliminate an unnecessary water authority board called the Harris Chain of Lake Restoration Council. This board was recommended to sunset in 2008, but action was never taken to do so. Eliminating government waste and bureaucracy has always been a top priority, and this is one way that we begin doing that.

Speaking of top priorities, the issue of protecting life has and always will be number one. We have some great pro-life legislation coming out of the Florida Legislature. SB 404, filed by Senator Stargel, will require parental consent for a minor to have an abortion procedure. Current state law only requires parental notification. It is absurd to think that a 15-year-old girl has to have consent from her parents before getting Tylenol at school, but could be allowed to walk into a clinic and get an invasive, dangerous procedure without any input from her parents. Your Senator has also filed legislation that would

help expand the Safe Haven Law to add "newborn safety devices" as an acceptable method of surrendering an infant at one of these Safe Havens. No person should ever have to make such a difficult decision, but this addition to our Save Haven Law would allow them to do so in complete anonymity and hopefully encourage more people to choose to allow their infant a chance to live their life. Our hope is that this will continue to spread the message that all life has value, even if it is not how someone envisioned it would be.

Finally, we have also filed a memorial to the U.S. Congress, urging them to adopt an Amendment to the Constitution, titled "Regulation Freedom Amendment", that would require any federal regulation to be adopted by a majority vote of the House and Senate. Every day, more federal regulatory authority threaten our constitutional liberties. Federal regulators need more accountability from the people's elected representatives.

# Insect-based Foods...Yuck!

For what seems like decades, excited environmentalists have been pitching insect-based foods as the next major trend in agriculture. The upsides to insect protein are clear. Producing it requires roughly one-tenth the land of other meat sources, and insect farming is inherently more efficient (think about how big a cow is, and then visualize a mealworm).

So far, environmentalists have been wrong about adoption—clearly, most people aren't buying bug protein at the supermarket—but this hype cycle seems different. Investors and founders are getting more deeply involved.

Ynsect, a France-based company focused on producing insect proteins for pet and other animal foods, raised a \$150 million

Series C in February. AgriProtein, another insect protein company, raised \$105 million in June of 2018. InnovaFeed, a France-based insect protein company, raised a roughly \$43 million round this August.

With a growing population driving up the demand for agriculture, and current agricultural processes contributing to our climate crisis, the resource-friendliness of insect protein stands to have an impact.

As other alternative meat startups have ballooned in revenue—Beyond Meat priced its IPO at \$25 and currently trades above \$139—it seems like insect protein could be as potent of a market as the alternative meat market we've seen explode over the last year.



## US decision to pull support for Syrian Kurds

Earlier this month, the Trump administration announced that US forces would withdraw from parts of Syria currently held by the Kurds and allow Turkey to move forward with military operations in the area. The abrupt move was met with backlash from politicians on both sides of the aisle.

**Governor Ron DeSantis Announces Legislation to Expedite Water Quality Improvements**

**Jupiter, Fla.** – Today, Governor Ron DeSantis announced proposed legislation for the 2020 Legislative Session that will expedite water quality improvements throughout Florida. The legislation incorporates recommendations of the Blue-Green Algae Task Force, which the Governor created shortly after taking office to aid the Department of Environmental Protection (DEP) in protecting, conserving and managing the state's natural resources.

The Governor made today's announcement following a tour of the Loxahatchee River District, where he was joined by DEP Secretary Noah Valenstein and Chief Science Officer Dr. Tom Frazier as well as other environmental stakeholders from across the state.

"The health of our state depends on the health and quality of our water," said Governor DeSantis. "That is why I am proposing legislation to expedite the improvement of our water quality throughout Florida. These comprehensive proposals, recommended by the Blue-Green Algae Task Force, will greatly aid the Department of Environmental Protection in our mission to enhance the quality of our state's most precious natural resource."

The proposed legislation furthers the directives outlined in Governor DeSantis' Executive Order 19-12 and is based on the recommendations of The Blue-Green Algae Task Force. The Blue-Green Algae Task Force, through its discussion and deliberations, provides guidance and specific, science-based recommendations with the goal of expediting improvements and restoration of Florida's water bodies that have been adversely affected by blue-green algae blooms.

The Blue-Green Algae Task Force

received input from a variety of stakeholders and identified runoff from agricultural lands, onsite sewage treatment and disposal systems, sanitary sewer overflows, and stormwater runoff as some of the significant sources of nutrient pollution and made recommendations to improve the state's policies and programs to achieve targeted nutrient reductions and protect public health.

"Addressing nutrient impacts will require actions by all stakeholders in Florida and significant water quality changes can only occur when all stakeholders work together," said DEP Secretary Noah Valenstein. "This legislation is the foundation for implementing necessary actions by the department, local governments and our regulated community based on the Task Force's recommendations."

"Today was another example of leadership by Governor DeSantis," said Eric Eikenberg, CEO of The Everglades Foundation. "The Governor outlined a comprehensive approach to address water quality problems that have been plaguing our state and the Everglades for decades. Today's announcement ends the era of defending the status quo and moves us into a new chapter of fixing what has been neglected. We look forward to working with the Governor and the Legislature to improve our waterways, restore the Everglades, and protect Florida's vibrant economy."



going to the bathroom, feces can get on their hands and can transfer to objects, food and drinks. When these things are shared, other people can unknowingly swallow the virus. If a person who has the virus comes in close contact or touches other people-this includes sex-the virus can also spread. This virus is hardy and can live on surfaces for more than a month.

The best way to prevent hepatitis A infection is through vaccination with the hepatitis A vaccine. It's also important to practice good hand hygiene, including thoroughly washing hands with soap and water after using the bathroom, changing diapers, and before preparing or eating food, and to avoid sharing food, drinks, drugs or

cigarettes. Alcohol-based hand sanitizer does not kill the hepatitis A virus.

Health care providers should immediately report all cases of hepatitis A to their local health department to ensure a quick public health intervention and prevent the spread of the disease among close contacts of the person sick with the virus.

Information (RFIs) for the three project types outlined in the plan.

“My administration is committed to making smart investments to help improve our state's air quality long-term,” said **Governor DeSantis**. “This funding will allow us to focus on projects that will reduce harmful emissions, help modernize school and transit bus fleets, and provide access to charging stations in our state as electric vehicle usage continues to increase.”

The Beneficiary Mitigation Plan will be funded by the national Volkswagen Settlement, of which Florida was allotted over \$166 million to improve air quality. While Florida is home to some of the best air quality in the nation, this funding will allow

for significant investment to reduce diesel emissions and expand the infrastructure for electric vehicles. Florida's Beneficiary Mitigation Plan outlines how the State intends to spend the full \$166 million awarded to the state under this settlement.

Florida's plan focuses on:

- School, transit and shuttle buses (70%)
- EV Charging Stations (15%)
- Diesel Emissions Reduction Act (DERA) “Option” (15%)

“The Department has worked diligently to develop a plan that meets the needs of our state, the priorities of Governor DeSantis and public comments that were received during the draft plan development process,” said **DEP Secretary Noah Valenstein**. “We look forward to working with local governments and other partners to expand Florida's electric vehicle infrastructure.”

# Home Fire Risks

## Home Fire Risks Increase As Weather Cools

(NAPSI)—The fall and winter seasons bring cooler temperatures, holidays, and images of cozy nights by the fireplace. Yet the change in seasons also comes with the chance of severe weather and an increase in fire risks. According to the U.S. Fire Administration, more home fires occur in winter than in any other season.

“Holiday decorations, space heaters, generators, and fireplaces all present fire hazards if not properly used and maintained,” said Steve Hirsch, chair of the National Volunteer Fire Council. “Residents should be aware of the dangers and take the steps to make sure their families and homes are protected.”

Follow these tips to minimize home fire and safety risks:

- Install smoke alarms in every sleeping room, outside each separate sleeping area, and on every level of the home. Test monthly to ensure they work.
- Install carbon monoxide alarms and test them at least once a month.
- Know where the gas, electric, and water main shut-off controls are and how to use them.
- Place fire extinguishers in the kitchen, garage, and living room, and make sure all household members know how to use them.
- Develop a home fire escape plan and practice it with the entire family.
- Keep portable generators outside and away from the home.
- Install a screen in front of each fireplace or wood stove. Store cooled ashes in a metal container outside the home.
- Have chimneys professionally inspected and cleaned every year.
- Keep anything that can burn at least three feet away from fireplaces, radiators, space heaters, or other heat source.
- Never leave lit candles unattended, and keep them out of the reach of children and pets.
- If using a live Christmas tree, keep it adequately watered and get rid of it after Christmas or when it gets dry.

Residents can also take an active role in protecting their communities from hazards such as fires, medical emergencies, and much more. Fire departments across the country are looking for volunteers to serve as firefighters, EMS providers, and auxiliary members.

“The majority of firefighters in the U.S. are volunteers—neighbors helping neighbors in an incredible and rewarding way,” said Hirsch. “We need more people to answer the call to serve.”

Training is provided by the department, and volunteers can serve in a variety of roles, from providing life-saving emergency response services to conducting fire prevention programs and disaster preparedness planning.




