## Economic Data Demonstrates Continued Economic Growth

**Governor DeSantis Announces Florida's October 2021 Economic Data Demonstrates Continued Economic Growth Thanks to Successful Policies That Put Floridians and Businesses First**

*18 consecutive months of job growth, 12 consecutive months of labor force increases*

**TALLAHASSEE, Fla.** — Today, Governor Ron DeSantis announced that Florida continues to make economic progress with more job growth, labor force increases, and a decline in the unemployment rate. The steady economic growth that Florida is witnessing is thanks to successful policies that put Floridians and businesses first. Florida's economy continued to thrive in October 2021, with 18 consecutive months of private-sector job growth, adding 44,300 jobs over the month and increasing by 5.7% over the year. Florida has also experienced 12 consecutive months of labor force increases with a growth of 29,000 over the month. Florida's labor force growth represents a 5.8% increase over the year, which is significantly higher than the national rate of 0.5%. Florida's unemployment rate, currently at 4.6%, also decreased by 0.2 percentage points from the revised September 2021 rate of 4.8%.

In total, Florida has gained 1,111,000 private sector jobs since April 2020, which represents 89% of jobs lost during the pandemic that have been recovered. Florida continues to see significant increases in

labor force, growing 579,000 over the year as Floridians gain confidence in returning to work. Florida's unemployment rate has lowered over the year, decreasing by 1.2 percentage points. Data in the month of October indicates that there continue to be many job opportunities available for Floridians throughout the state, with more than 518,000 jobs posted online.

"Florida's economy continues to grow faster than the nation because we put the needs of Floridians and businesses first and make smart policy decisions that push back against heavy-handed mandates," said **Governor Ron DeSantis**. "With 18 consecutive months of job growth and 12 consecutive months of labor force increases, we will continue to make investments that move our economy forward."

"Florida continues to see job growth, increases in labor force, and a decline in unemployment rate thanks to Governor DeSantis' policy decisions to protect Floridians and their jobs," said **Secretary Dane Eagle of the Florida Department of Economic Opportunity**. "Floridians and businesses remain confident in the state's economy, and as evidence of that confidence, Florida's current participation in the labor force of 10,590,000 is actually larger than Florida's February 2020 labor force of 10,461,000."

Prediabetes is a serious medical condition that, if untreated, can put you

at increased risk of developing type 2 diabetes, heart disease, and stroke. But the good news is that by making some healthy lifestyle changes, you can manage or even reverse your prediabetes and lower your chances of it developing into type 2 diabetes.

Prediabetes affects approximately 88 million U.S. adults and occurs when your blood glucose, also called blood sugar, is higher than what is considered normal and recommended for you but not high enough to be diagnosed with type 2 diabetes. Most people with prediabetes are not aware that they have it, and there are usually no symptoms. People with risk factors for prediabetes include people who have overweight or obesity, are 45 years old or older, have a parent or sibling with diabetes, or are from certain racial and ethnic backgrounds.

"It is important for people with risk factors for prediabetes to learn if they have the condition," says NIDDK Director Dr. Griffin P. Rodgers. "Even small steps to improve your health and manage prediabetes can make a big difference in

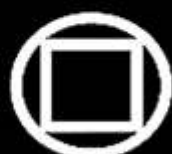

Dear Friends,  
It's a great day to live in the Free State of Florida! As of this writing, we have just concluded the 2021 Special Session to combat the federal government's unconstitutional

vaccine mandates and it is a pleasure to bring you a brief report on all that we accomplished.

In October, Governor Ron DeSantis called for a special session to provide protections for Floridians who have lost their jobs or are having their employment threatened due to vaccine mandates. In response to that call, the Florida Legislature promptly drafted four bills for

consideration. All four have passed through the legislature and were signed by the Governor in Brandon, FL with legislative leaders by his side.

House Bill 1B prohibits private-sector employers from requiring COVID-19 vaccine mandates for their employees unless they provide the following opt-outs. Medical reasons, as determined by a physician, Advanced Practice Registered Nurse, or Physician Assistant. Medical reasons include pregnancy or the anticipation of pregnancy. Also, any sincerely held religious beliefs, prior COVID-19 infection as determined by a lab test, periodic testing at no cost to the employee or personal protective equipment (PPE) provided by the employer. The Department of Health has been directed to adopt rules to implement these exemptions.

Any business, with less than 100 employees, found in violation of this law, can be fined up to \$10,000 per violation and business with more than 100 employees can be charged \$50,000 per violation. There is a complete prohibition on public educational institutions and government entities from requiring employees to be vaccinated against COVID-19 as a condition of employment. Violations include a fine not to exceed \$5,000.

Additionally, This bill prohibits K-12 public schools from imposing student mask and vaccine mandates and would also prohibit the quarantining of students and teachers unless they become symptomatic or test positive for COVID-19.

Accompanying this legislation, House Bill 3B, protects employee's private religious and medical information when filing a complaint against employers who violate the provisions in House Bill 1B.

House Bill 5B takes the first step toward developing a proposal to withdraw from

OSHA and assert state jurisdiction over occupational safety and health issues. Withdrawing from OSHA would remove the ability for the Biden Administration to continue with its reckless overreach in to state affairs.

Finally, House Bill 7B, removes the authority for the State Health Officer to require vaccinations during a public health emergency. This never-before-used provision contained some very troubling language that would allow the Surgeon General to force vaccinations "by any means necessary". No one person in our state should have that kind of authority. Removing this part of current law will ensure Floridians, now and in the future, have the freedom to make personal health care decisions.

Individual rights and liberties are worth protecting and we are standing with Floridians and their families to protect them from unlawful attempts by the federal government to force one-size-fits-all COVID mandates. Thank you for sending me to Tallahassee to be your voice as we fight to protect faith, family, freedom, opportunity and life itself.

## Keep Your Child COVID-19 Safe



### Three Ways To Keep Your Child Safe From COVID-19

Children and teens are catching and spreading COVID-19 at an increasingly high rate. Even if your child or teen has not yet contracted COVID-19, they are at risk, especially with the low number of vaccinated residents in Oklahoma.

"In the early months of the COVID-19 pandemic, older people were most likely to get the virus. Now it is affecting everyone, and children and teens are also at risk of contracting the virus and experiencing long-lasting impacts," said Dr. Dale Bratzler, University Chief COVID Officer and Professor in the OU Hudson College of Public Health. "We need to do everything we can to keep all our kids safe, and the best way to do that is to get more people vaccinated."

Parents and other adults in a child or teen's life can take steps to protect young people and themselves.

### Get Your Child Vaccinated When Eligible

The best way to protect your children from COVID-19 and all the potential complications is to get them vaccinated as soon as they are eligible. The COVID-19 vaccine is free, widely available, and highly effective in preventing hospitalization and death from COVID-19. Like most vaccines, some minor side effects may occur, such as a sore arm or slight fatigue, but the symptoms and long-term impact of contracting COVID-19 are much more serious. Ultimately, it is much safer for children and teens to get a COVID-19 vaccine than getting the disease itself.

If your children are not eligible to be vaccinated, you can still keep them safe from COVID-19 by practicing recommended prevention methods such as physical distancing when possible and continuing to wear a mask, especially in crowds or while indoors. **Assess travel plans.** Consider delaying travel until you're fully vaccinated. Remember, masks that cover your nose and mouth are required for everyone on planes, buses, trains and other public transportation. If you're unvaccinated, plan to get tested one to three days before your trip within the United States and three to five days after you return. Plan to self-quarantine for seven days, even if the test is negative. If you travel by car, be aware that you and your travel companions could be exposed to the virus on stops for gas, food and bathroom breaks. Remember to wear a mask, wash your hands frequently and maintain social distancing at these locations. If traveling internationally, especially to places where vaccination rates are low and COVID-19 is spreading, visit the CDC's website for recommendations on international travel.

**Get tested.** If you've been in close contact with someone who has COVID-19, or if

**DeSantis Announces Lawsuit**

*Florida brings legal action against the Occupational Safety and Health Administration's Emergency Temporary Standard*

**TALLAHASSEE, Fla.** — Governor Ron DeSantis announced a lawsuit against the Biden Administration's unconstitutional Occupational Safety and Health Administration (OSHA) employer vaccine mandate. As soon as the unlawful emergency temporary standard (ETS) is published in the Federal Register tomorrow, the lawsuit will be immediately filed with the United States Court of Appeals for the Eleventh Circuit.

"We started with *15 days to slow the spread* and now it's *get jabbed or lose your job*," said **Governor Ron DeSantis**. "We're supposed to be a government of laws, not a government of men. This OSHA rule is 500 pages of a government of bureaucracy, a government that is being run by executive edict, not a government bound by constitutional constraints. The State of Florida will immediately challenge the OSHA rule in court because it's inconsistent with the Constitution and not legally authorized through Congressional statutes. There is no federal police power and the federal government cannot unilaterally impose medical policy under the guise of workplace regulation. Individuals should make informed choices about their own healthcare. It is

important to stand up for people's individual ability to make decisions for themselves. And the practical result is that this is going to exacerbate a lot of the existing problems that we are seeing with the economy."

"The Biden administration continues to violate our constitution and punish hard working Americans for making their own choices," said **Lieutenant Governor Jeanette Nuñez**. "As I've said before, Governor DeSantis and I will fight these un-American vaccine mandates, including the latest OSHA rule, to prevent tyrannical overreach from encroaching on our freedoms."

"The remarkable ease at which this president will abandon the rule of law and separation of powers is astonishing and devastating to the autonomy of American workers," said **Attorney General Ashley Moody**. "For this reason, I will take swift legal action to stop this unprecedented overreach by the federal government — to protect Florida and our workers from the unlawful edicts emanating from President Biden and his handlers. The president does not have the power to force health policy through a workplace safety department. That's not what Congress intended when they created OSHA and it's not a lawful use of the U.S. Department of Labor."

Throughout the 490 pages of governmental overreach in the form of the OSHA rule, some of the most atrocious aspects include:

On page 4: OSHA shall issue an ETS "if the agency determines that employees are subject to grave danger from exposure to

substances or agents determined to be toxic or physically harmful or from new hazards, and an ETS is necessary to protect employees from such danger."

If this was such a "grave danger," why did it take 57 days from the announcement by President Biden to publish the rule and why won't it take effect until January 4 — another 60 days?

On page 5: "The ETS protects these workers through the most effective and efficient control available — vaccination — and further protects workers who remain unvaccinated through required regular testing, use of face coverings, and removal of all infected employees from the workplace."

A recent study from Sweden published in *The Lancet* found that within 200 days, mRNA vaccines had no ability to prevent transmission whatsoever.

On page 15: The agency is not required to support its conclusions "with anything approaching scientific certainty and has the "prerogative to choose between conflicting evidence."

The CDC recently released a review of research studies and its own unpublished data indicating that both infection-induced and vaccine-induced immunity are durable for at least six months. This rule should account for natural immunity.

On page 20: The agency does not believe it appropriate to impose the costs of testing on an employer where an employee has made an individual choice to pursue a less protective option. For the same reasons, OSHA has also determined that it is not appropriate to require employers to pay for face coverings for employees who choose not to be vaccinated.

Employees will have a direct financial penalty for making a medical decision of

which they have every right to be in control.

This rule, if allowed to be implemented, will impact nearly 9,000 employers in Florida and the 4.5 million Floridians they employ who make up 60% of our workforce. Nationally, it will cost \$2.9 billion. This OSHA rule must be deemed unconstitutional and Florida will be leading the way in taking the Biden Administration to court.

# The Courts Are Clear School Districts Must Comply

TALLAHASSEE, Fla. – In yet another victory for parents' rights, the Florida Division of Administrative Hearings dismissed a case filed by six school districts who have disregarded the will of parents to make decisions for their children. In a landmark case, the Administrative Law Judge ruled that the Florida Department of Health had the legal authority to issue **Emergency Rule 64DER21-15**, which empowers parents to decide if their children should wear masks at school and ensures healthy students can remain in school.

"There is no strong evidence of health benefits for children as a result of mask mandates in schools. The rights of parents continue to be protected in Florida, as we can see by this tremendous decision," said **State Surgeon General Dr. Joseph Ladapo**. "Florida will not make decisions out of fear, but rather out of close analysis of the data."

"When you break the law there are consequences," said **Commissioner Richard Corcoran**. "If these districts continue to break the law, we plan to fully hold them accountable."

This ruling follows an opinion issued by the First District Court of Appeals on October 29, which stated in part "(School Districts) cannot stand between parents and their lawful right to make decisions on behalf of their children." At this point, the courts have been entirely clear: All school districts must come into compliance with the

law and honor parental rights to make decisions for their children. Today's ruling also follows eight school districts already acknowledging their missteps in breaking Florida law and since implementing full parental opt-outs to come into compliance with the law (Brevard, FSU Lab, Hillsborough, Indian River, Lee, Leon, Sarasota, and Volusia), and an advisory opinion issued by Florida Attorney General Ashley Moody, which stated "it is my opinion that the District must comply with Rule 64DER21-12 and any other applicable authorities unless and until the judiciary declares them invalid."

Administrative Law Judge Bryan Newman found, based on the evidence presented, that "forcing asymptomatic children to wear masks in schools provides no significant barrier to the spread of COVID-19." He criticized the counties' expert witnesses who could not cite any data in Florida to support their universal mask opinions in school settings, while the Department of Health relied on "relevant data" from a case study of Florida schools during the 2020-2021 school year which showed no statistically significant difference between counties with mask mandates and other counties. In addition, the Department's expert, Dr. Jay Bhattacharya, presented "credible" testimony that "a child infected with COVID survives 99.997% of the time." Judge Newman therefore

concluded that the Department's parental opt-out protocols are "safe" for children and "strike the right balance."

Judge Newman also made clear that the Department of Health has lawful authority to govern the control of COVID-19 in school settings throughout the State. In other words, the counties cannot defy state law based on their own preferences for unnecessarily masking children and keeping healthy children at home. The counties are appealing the decision, but such an appeal will be difficult given the judge's factual finding that the parental opt-out protocols "strike the right balance by ensuring that the protocols that govern the control of COVID-19 in schools go no further than what is required to keep children safe and in school."

reducing your risk for type 2 diabetes."

Fortunately, making a few healthy lifestyle changes can help people with prediabetes improve their health and help avoid or delay developing type 2 diabetes. Here are some actions you can take:

Ask your doctor for a blood glucose test to find out if you have prediabetes. You should be tested for prediabetes if you have overweight or obesity and have one or more other diabetes risk factors.

If you need to lose weight, try focusing on losing a small amount of weight. The NIDDK's Diabetes Prevention Program (DPP) found that people who worked on making lifestyle changes to lose weight, including increased physical activity and healthy eating, could drastically lower their type 2 diabetes risk. The results from the DPP helped the CDC build the National Diabetes Prevention Program ([www.cdc.gov/diabetes/prevention](http://www.cdc.gov/diabetes/prevention)), a lifestyle program for people at risk for type 2 diabetes available at locations across the country.

Become more physically active by going on short daily walks. Or try participating in fun hobbies and activities like dancing, playing with your family or friends, or riding a bike.

Try to spend less time sitting and watching television, playing video games or using social media.

Swap sugary snacks for healthy fruits, vegetables or nuts. Or try trading white bread and white rice for high-fiber options, like whole wheat bread and brown rice.

Use a food and drink diary or a smartphone app to keep track of what you eat and drink. It can help you see when you

tend to overeat or consume foods and beverages high in fat or calories.

If you smoke, try to quit. Talk to your doctor or visit <https://smokefree.gov/> for tools and tips on how to become tobacco free.

Try to get at least 7 hours of sleep each night.

Take other steps to stay healthy. For instance, getting the COVID-19 vaccine (and booster shot, if eligible) and flu vaccine is highly important, especially for people who may be more likely to get sick from COVID-19, such as older adults and people who already have diabetes, obesity or heart disease, which are chronic conditions.

You don't have to make all these changes at once. Any step you can take toward being healthier is a step in the right direction. And don't be afraid to ask your doctor or loved ones for support. you're not feeling well before the holidays, especially if you have COVID-19 symptoms, get tested. Tests are widely available at pharmacies and doctors' offices. Getting tested can provide security, knowing that you won't infect your friends and relatives and everyone can enjoy a stress-free holiday. If in doubt, consider staying home and joining festivities virtually. This will allow you to enjoy the fun while staying safe.

**Pay attention to ventilation.** When celebrating with your families, try to avoid crowded, poorly ventilated spaces. Consider moving celebrations outdoors, especially if you are planning a large get-together. Have a cookout or roast marshmallows. If you attend family festivities indoors where some guests may not be vaccinated, wear a well-fitting mask over your nose and mouth, remembering that you should never put a mask on a child under the age of 2. The CDC also recommends mask wearing in public indoor settings regardless of vaccination status.

**Consider your health status.** If you or someone in your household has a health condition or someone is taking medications that weaken the immune system, you should take extra precautions, even if you are fully vaccinated. The CDC recommends that those with weakened immune systems follow similar guidelines for unvaccinated

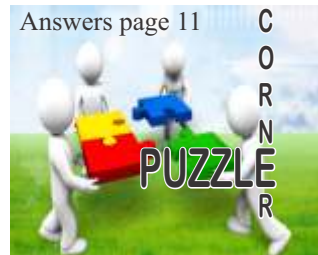

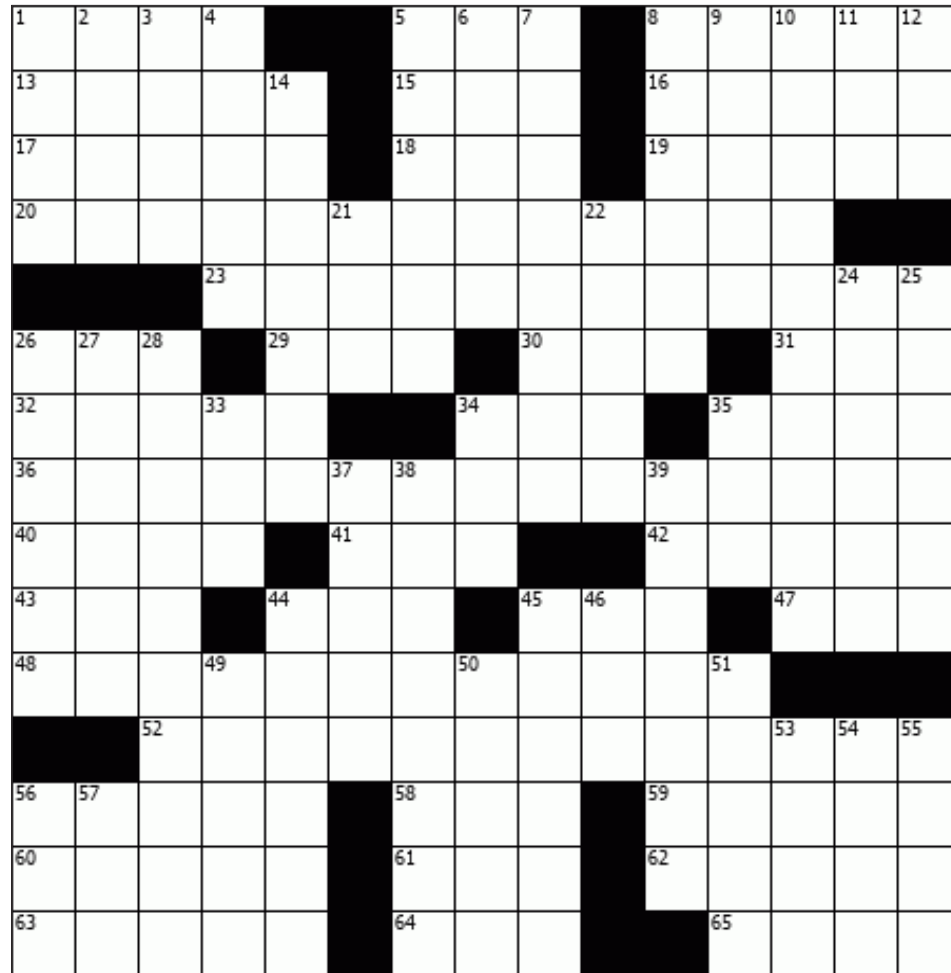

## Steak Tacos



- 1 pound flank or skirt steak, frozen for 30 minutes
- 4 Tbsp (1/4 cup) oil, divided
- 3 Tbsp tamari or reduced sodium soy sauce
- 3 Tbsp freshly squeezed lime juice
- 3 cloves garlic, finely minced
- 2 teaspoons chili powder
- 1/2 teaspoon ground cumin
- 1/2 teaspoon dried Mexican oregano

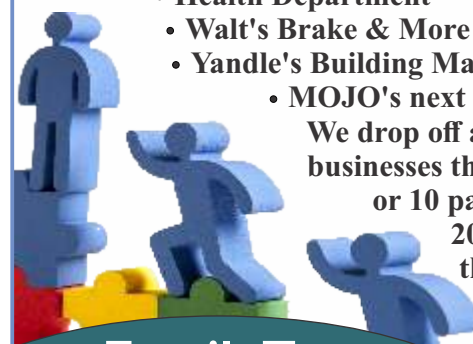

## ATTORNEY GENERAL MOODY



### Attorney General Moody Leads Efforts to Stop Robocallers from Misusing Legitimate Phone Numbers

TALLAHASSEE, Fla.—Attorney General

Ashley Moody is leading efforts to garner support for the Federal Communications Commission's continued attempts to fight illegal robocalls. Scammers are finding ways to circumvent previously implemented anti-robocall technology to continue bombarding citizens with scam messages.

Attorney General Ashley Moody said, "Working with the FCC, we have been successful in reducing the number of scam robocalls targeting Americans. Unfortunately, in recent months, scammers have found ways to circumvent the technology created to protect our citizens from fraudulent robocall messages. Today, I asked the FCC to continue its efforts to reduce the number of calls by implementing stricter processes on companies that assign and distribute telephone numbers."

Earlier this year, following efforts by Attorney General Moody and other attorneys general, phone companies were required to implement a technology program called STIR/SHAKEN. This technology checks to see if a phone call comes from a legitimate source before the

designated phone begins to ring. Since the FCC required large phone companies to begin using this technology in June, scam robocalls have dropped [nearly 30%](#).

Scammers are now trying to circumvent the STIR/SHAKEN program by purchasing access to legitimate phone numbers to conceal their identities. Providing false information and shielding identities, scammers purchase access to legitimate phone numbers from companies that do not have strong know-your-customer policies. For STIR/SHAKEN to reach its full potential to reduce illegal robocalls, scammers cannot be allowed uninhibited access to legitimate phone numbers.

The FCC proposes to implement a more thorough application, review and monitoring process for phone companies that request direct access to phone numbers and to require these companies verify customers' identities to help keep the numbers from being sold, leased or rented to scammers for illegal robocall purposes. This includes limiting the use of temporary phone numbers for trial customers.

### Attorney General Moody Leads Multistate Investigation into Instagram's Impact on Young People

TALLAHASSEE, Fla.—Attorney General Ashley Moody is leading a nationwide investigation into Meta Platforms, Inc., formerly known as Facebook, for conduct relating to use of its social media platform Instagram by children and young adults. Attorneys General across the country are examining whether the company violated state consumer protection laws and put the public at risk by carelessly promoting the platform to younger users.

Attorney General Ashley Moody said, "We have serious concerns about how social media is impacting the lives of young people in this country, and as a mother, I want to know how Facebook/Meta is targeting youth and what strategies this Big Tech giant is using to entice children and teens to lengthen engagement on its platforms. I am proud to lead these efforts with our partner states to find out if Meta

violated any consumer protection laws and put our children at risk."

The investigation targets, among other things, the techniques used by Meta to increase the frequency and duration of engagement by young users and the resulting harms caused by such extended engagement. Today's announcement follows recent reports revealing that Meta's own internal research shows that using Instagram is associated with increased risks of physical and mental health damages on young people. These harms include depression, eating disorders and suicide.

Attorney General Moody continues to challenge Meta's overreaching goals by leading the action to end [Facebooks monopoly](#), supporting the [cancellation of youth social media platform plans](#) and taking action against Facebook to [fight human trafficking](#).

Attorney General Moody is leading the investigation with a bipartisan coalition of attorneys general from California, Kentucky, Massachusetts, Nebraska, New Jersey, Tennessee and Vermont.

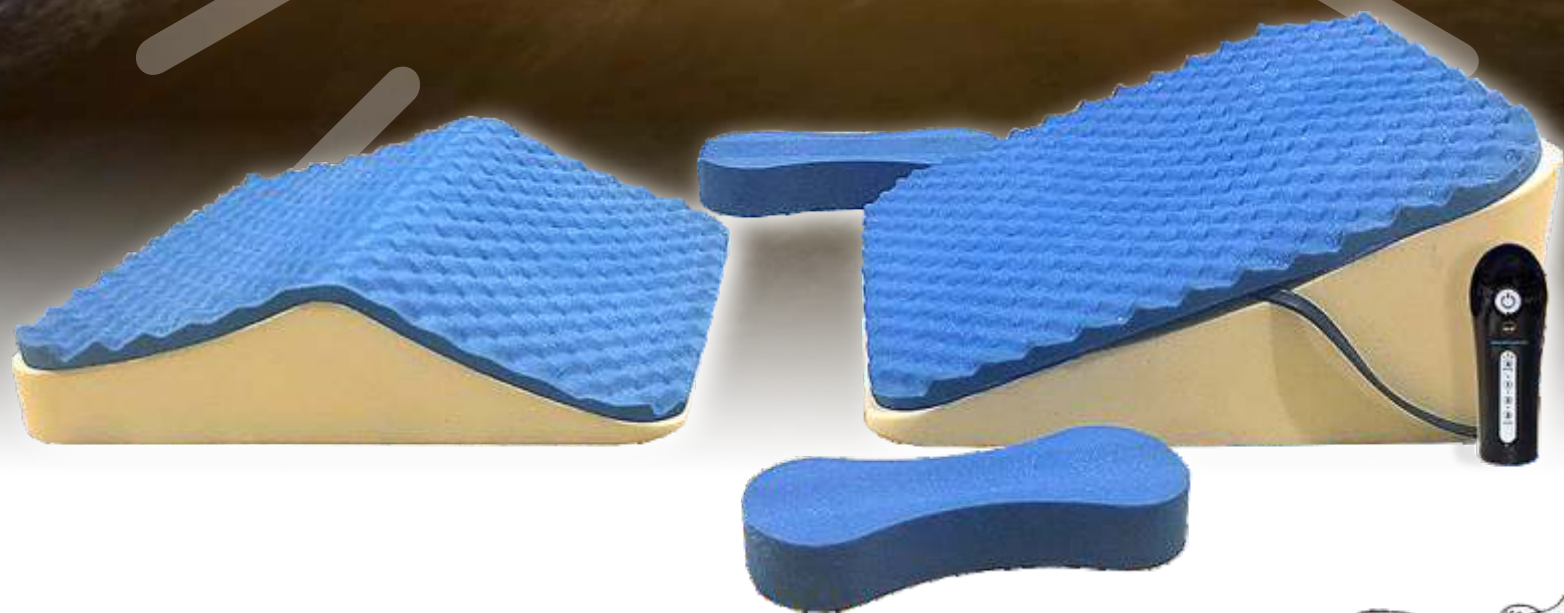
