OCALA/MARION COUNTY CHAMBER & ECONOMIC PARTNERSHIP



At the CEP's Annual Luncheon on 2 February, the new 5-year Strategic Plan, *Forward Momentum*, was unveiled to a crowd of nearly 1,100 business leaders. The plan had been developed over eight months in 2021

and involved consultations with a number of experts and economists.

The plan is a continuation of its two successors (*Moving Forward* and *Moving Forward – Phase II*) but also broadens the engagement of the CEP in a few key areas. All of the plans 19 goals are aligned with the CEP's mission "to be the catalyst for a prosperous community." The following are highlights of a few of the goals. The complete can be found at OcalaCEP.com/the-CEP/strategic-plan/

Business Advocacy – the top goal in Business Advocacy is the *Renewal of the Local Option Sales Tax*. This 1% tax was first approved by voters in 2016 and then overwhelmingly renewed in 2020. The tax is the *best* way to fund important and needed transportation and first responder needs. The revenues can only be spent on capital needs and approximately 1/3 of the revenue is collected by tourists and commuters who are using our roads and depending on our first responders but not otherwise contributing to their support.

Business Attraction – the #1 goal in the plan is to secure a *commitment for commercial passenger air service*. As a community of nearly 400,000 the time is right for the return on local air service.

Business Creation – the *creation of a Community Development Financial Institution (CDFI)* is imperative to implementing our mission of a prosperous community for all. This non-bank lender would work in partnership with local lenders to increase access to capital in our three majority-minority communities of West Ocala, Silver Springs Shores, and Marion Oaks.

Business Retention – work has begun on a *Workforce Participation Study* to better understand the more than 50% of working age adults who are not currently in the workforce. This study, financially underwritten by CareerSource CLM and Duke Energy, will seek to identify these various group, barriers to their entering the workforce, and how those barriers can be addressed. Results from the study are expected in late summer/early fall.

Business Services – this is the area of the CEP dedicated to some of our most popular programs – Leadership, business education series, equine engagement, and networking. If we are to serve the entire Metro, then the CEP needs offices that make it easy for all businesses to access services and programs. The goal is to *open at least one satellite office* during this time.

Business Support – the CEP is a not-for-profit but created a Foundation in late 2019 to easier access grants and tax deductible contributions. The Foundation has had a fairly high degree of success without intentional focus. The goal in this plan is to

hire a Director to focus on securing grants and corporate donations to support the CEP's entrepreneurship, talent development, and leadership programming.

Finally, the three BIG goals of the plan are to 1) impact the announced creation of **5,000 new primary jobs** with 2) wages which are **15% above the County average wage** and 3) result in a direct **capital investment in our community of \$1 billion**.

These are all lofty goals but they are ones which we can and must attain if we are to fulfill the mission of creating a truly prosperous community.

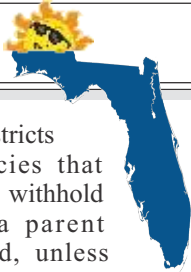

This column will be the second in a series that we plan to write, providing an overview of the 2022 Legislative Session. Last month, we brought some information to you

regarding Florida's budget and what the Legislature did with your money. This month, we will highlight two education policy bills that we passed this year

HB 1557, Parental Rights in Education by Senator Baxley and Representative Harding. By now, many of you are familiar with this bill as it received national attention and is part of broader conversation regarding parental rights going all the way back to last year. Given the slanderous moniker "Don't Say Gay Bill" by left wing media outlets, this bill expands on the Parental Rights bill passed in 2021. Let us be clear, this bill says nothing about not being able to say "gay" in schools. We are not prohibiting casual conversations. What we are saying is that children in K-3 schools do not need to be indoctrinated with gender theory instructional material and their parents left in the dark about it. HB 1557 will empower parents and families by

prohibiting school districts from adopting policies that require employees to withhold information from a parent regarding their child, unless necessary to protect the child when the school suspects abuse or neglect. Additionally, this bill ensures age-appropriate curriculum by prohibiting teacher-led classroom instruction on gender identity or sexual orientation in the primary grade levels (K-3) and Improves transparency between schools and parents by requiring school boards to notify parents if there is a change in their child's services related to mental, emotional, or physical health and wellbeing. The enforcement arm of this bill authorizes a parent to request the Commissioner of Education to appoint a special magistrate to investigate unresolved parental complaints and recommend resolutions to the State Board of Education within 30 days. Further, it establishes a process whereby parents can bring action against a school district that violates the provisions of the bill that seek resolutions for unresolved concerns.

HB 7, Individual Freedoms by Senator Diaz and Representative Avila. This bill protects individual freedoms and prevents discrimination in public schools and the workplace while supporting factual,

educational discussions and materials for our students. The bill identifies several principles of individual freedom to guide instruction and curriculum, such as: No individual is inherently racist, sexist, or oppressive, whether consciously or unconsciously, solely by virtue of his or her race or sex. No race is inherently superior to another race. No individual should be discriminated against or receive adverse treatment solely or partly on the basis of race, color, national origin, religion, disability or sex. Accordingly, the bill requires that instruction, instructional materials, and professional development in public schools be consistent with principles of individual freedom.

Thank you for the honor of letting me serve you in the Florida Senate. There is no

higher calling than serving others.

Brutal Murders Committed by Illegal Immigrant

TALLAHASSEE, Fla. — The Biden Administration's dangerous immigration policies, as well as the soft on crime policies of the 9th Circuit State Attorney's Office (Orange and Osceola counties), have once again resulted in the needless deaths of innocent Floridians. On March 10, 2022, a man named Jean R. Macean, a citizen of Haiti and an illegal immigrant, was taken into custody for the murder of Terry and Brenda Aultman and charged with two counts of first-degree murder. Macean had previously been arrested in Orange County prior to the murders, but the charges were inexplicably dropped by the State Attorney's Office under former State Attorney Aramis Ayala. Daytona Beach Police Chief Jakari Young described these killings as "one of the most vicious attacks I've ever seen in my 20 years."

Students Recognized



Students Recognized for Science Projects That Search for Water Solutions

The District recently presented the Water Matters award to three Pasco County students searching for solutions to improve water quality and sustain freshwater supplies.

The Water Matters awards were given as part of the 2022 Pasco Science and Engineering Showcase last month. Hosted by the District School Board of Pasco

County, this annual event encourages students to work through the scientific research process to explore pressing issues and problems to create powerful solutions. The student projects considered for the Water Matters award aligned with the District's mission to protect water resources and ensure the public's water needs are met, while also demonstrating creativity and innovation.

"It was a great opportunity to recognize the amazing work being done by students related to water resources, and we look forward to presenting the award again in the future," said Katherine Munson, senior communications coordinator.

This year's Water Matters award recipient projects focused on improving water conditions and exploring alternative water supply options. The award was presented to students from the elementary, middle and high school levels.

Jacen Bartenfelder, a third grader at Watergrass Elementary, was the Water

Matters elementary level recipient with his project "Removing Phosphates From Water." His project looked at the effects of different filtration materials and how they impacted the number of phosphates found in a water sample. The inspiration for his project came after concern about runoff polluting the lake behind his home. This experiment was designed to learn about ways to protect his local bodies of water.

Sebastian Davis, a seventh grader at Pasco Middle School, was the Water Matters junior level recipient with his project "Stopping Thirst One Drop at a Time." The project aimed to find the best method for removing mineral components from sea water. Davis observed multiple methods to determine the most effective and efficient way to cleanse sea water. His goal was to find the best way to purify salt water to increase freshwater supply.

Muhammad Shahraj, a twelfth grader at Cypress Creek High School, received the Water Matters award for the high school level. His project involved using White-Rot fungi to degrade metal pollutants in different water environment conditions. Shahraj observed the potential of the fungi in his experiment to understand how the heavy metals would break down in larger bodies of water.

Leesburg Man Arrested

Leesburg Man Arrested On Child Pornography Charges

04/08/2022

On April 7, detectives with the Lake County sheriff's Criminal Intelligence Unit executed a search warrant at the residence of 7448 Harbor View Drive in Leesburg regarding suspected child pornography being contained on the premises. Detectives located multiple electronic and digital media storage devices that were collected as evidence. On-scene forensic analysis was conducted on some of the devices, which revealed numerous images of the sexual performance of children ranging from infants to teenagers.

The suspect in this case, Keith Alan Wilkins (D.O.B. of 9/03/1960), was taken into custody and charged initially with 11 counts of possession of images depicting the sexual performance by a child and possession or promotion of certain images of child pornography. Further forensic review of the evidence collected from the home is being conducted, which will likely result in additional charges.

Wilkins has been employed as a facilities maintenance supervisor responsible for inspecting maintenance work conducted at daycare facilities throughout the state.

Wilkins was transported to the Lake County Detention Center and was booked in with a \$55,000 bond.

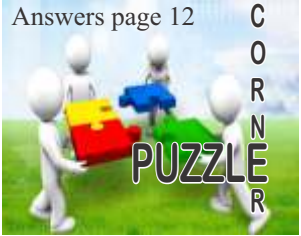

Attorney General Moody and Congressman Posey Announce Legislation to Give States the Ability to Enforce Immigration Laws When DHS Won't

TALLAHASSEE, Fla.—Frustrated by the border crisis and the federal government's refusal to enforce its own laws, Attorney General Ashley Moody and Congressman Bill Posey today announced legislative efforts to give states more authority to combat illegal immigration. The congressional legislation, H.R. 7413, would allow state officials to demand the secretary of the Department of Homeland Security enforce federal immigration law in certain circumstances. DHS will then have the option to either enforce the law or deputize state officials to carry out the federal immigration duties.

The bill comes just days after President Joe Biden announced the termination of [Title 42](#), a pandemic-era rule that allows border agents to quickly expel migrants attempting to enter the U.S. who traveled from a country where a communicable disease is present. DHS estimates that there might already be [25,000](#) migrants waiting in shelters just south of the border for Title 42 to come to an end. There are also projections that customs and border patrol agents could see up to 18,000 migrants a day after the removal of the policy.

Attorney General Ashley Moody said,

“In less than a year and a half, the Biden administration has obliterated our southwest border and it's about to get even worse as the president prepares to end Title 42. We can no longer trust this administration to enforce the law. It is time for swift action to protect the American people. That is why, Representative Posey and I are taking this matter to Congress and asking the legislative branch to let the states protect our citizens by enforcing public-safety immigration laws when Biden won't.”

Congressman Bill Posey said, “Maintaining operational control over our nation's borders is critical to our security and our ability to stop human traffickers, drug smugglers and other violent criminals and terrorists who mean to do our communities harm. When the federal government abdicates its role in protecting our nation's borders and refuses to enforce immigration laws allowing millions of people to illegally cross into our country states should have authority to protect their citizens.”

Under H.R. 7413, the Immigration and Enforcement Partnership Act of 2022, if a state attorney general finds that DHS is not adequately fulfilling the non-discretionary duties under title II of the Immigration and Nationality Act, the attorney general may request in writing that the DHS secretary do so. Such duties include the arrest, detention and removal of criminal and arriving aliens. No later than 30 days after receiving a request, the secretary shall either ensure that the duties are adequately fulfilled by officers and employees of the DHS, or authorize state officials to enforce federal immigration

law. If the secretary does not comply, the attorney general may file a civil action to enforce these requirements. The bill also requires the courts to expedite proceedings on such action to the greatest extent practicable.

U.S. Customs and Border Protection encounters with illegal migrants at the southwest border totaled more than 2 million since February 2021, with deportations down [70%](#) last year. Attorney General Moody and Congressman Posey are concerned that the federal government's seeming disinterest with enforcing immigration laws will exacerbate the opioid crisis and leave the door open for unmitigated drug and human trafficking.

It costs Florida more than \$100 million a year just to incarcerate illegal immigrants who commit crimes in the state. The cost to public safety is harder to calculate as the nation struggles with a deadly opioid crisis claiming 21 lives a day in Florida. The crisis is being exacerbated by fentanyl, a synthetic opioid 100 times stronger than morphine. According to CBP, since Biden took office, the amount of fentanyl seized at the border is enough to kill every man, woman and child in the nation more than seven times over.

According to recent reports, fentanyl is the number one killer of adults aged [18-45](#). The [Center for Disease Control and Prevention](#) projects that nearly 70,000 people nationwide have died from fentanyl overdose in the most recently recorded 12-month period. With Mexico being the number one source of fentanyl [imports](#) into the U.S., it is important that states be able to enforce the law when the federal government does not.

Attorney General Moody and Congressman Posey are also fighting to end human trafficking in Florida. The southwest

border is a gateway for human smugglers to bring trafficking victims into the nation. Due to the chaos at the border, many are sneaking by enforcement officials. A former border patrol chief [estimates](#) more than 400,000 migrants evaded agents and crossed the border last year. The risk of being trafficked is higher with noncitizens who pay to be smuggled into the country. [U.S. Immigration and Customs Enforcement](#) officials state that dangerous human smuggling circumstances are encountered every day at the southwest border.

[CBP](#) reports arrests of individuals with criminal convictions increased more than 340% in the last fiscal year. There was an 450% increase of those previously convicted of illegal drug possession and trafficking, a 585% increase of illegal immigrants previously arrested for trafficking, and a 212% increase of those arrested for sexual offenses.

In [January](#), Attorney General Moody traveled to the southwest border in Texas to receive briefings from law enforcement officials about the dramatic overrun of the border brought on by President Biden's reckless immigration policies. Attorney General Moody joined attorneys general from across the nation for the security briefing.

Congressman Posey has been to the border and seen firsthand how open and dangerous it has been allowed to become. Congressman Posey has been a strong advocate in Congress for securing the borders and maintaining operational control over them, as well as fighting human trafficking, targeting fentanyl and other illegal drugs, deporting criminal aliens and rooting out fraud in our immigration system.

Governor Ron DeSantis Signs Groundbreaking Legislation to Support Involved Fatherhood in Florida

Fla. — Today, Governor Ron DeSantis signed HB 7065, which includes educational programs, mentorship programs and one-on-one support to encourage responsible and involved fatherhood in Florida. The bill is tied to nearly \$70 million in funding to provide a wide spectrum of family and youth support through the Department of Juvenile Justice (DJJ) and the Department of Children and Families (DCF).

“There are more than 18 million children in our country who live without a father in their home,” said **Governor Ron DeSantis**. “This has a severe impact on children, and often leads to dropping out of school, crime and substance abuse. Incredibly, there are those who diminish the importance of fatherhood and the nuclear family – we will not let that happen in our state. I am proud to say we are doing everything we can to support involved fatherhood in Florida.”

“We cannot legislate fatherhood, accountability or character, but we can provide supports for fathers to equip and encourage them to take an active role in the lives of their children,” said **House Speaker Chris Sprowls**, who first brought attention to the fatherhood crisis during his 2019 designation speech. “By addressing the root cause of so many of the challenges facing our sons and daughters, we will see the positive impact of this legislation send shockwaves for generations to come. To my colleagues in the Florida Legislature who worked so diligently to bring this vision to life and carry it to unanimous passage, including Reps. Altman and Alexander, Chair Burton, Senate President Simpson and the many others who stood on the steps of the Historic Capitol with us, thank you. And to Governor Ron DeSantis, a father himself, thank you for standing with us for Florida's fathers and families today and signing this first-of-its-kind legislation for any state.”

According to the U.S. Census Bureau, there are more than 18 million children – one in four – in the United States who do not have a father in their home. To read more about the fatherhood crisis and the impact it is having on our nation's children, click [here](#).

Supporting the bill signing were fathers from across the state and several national and community leaders who encourage involved fatherhood, including former NFL head coach Tony Dungy, former NFL professional football player and philanthropist Jack Brewer, and Glen Gilzean, president and CEO of the Urban League of Central Florida.

“This is a crisis in America, today,” said **Jack Brewer, Founder and Executive Director, The Jack Brewer Foundation**. “Governor DeSantis is setting an example the entire country needs to follow. With bills like this and leaders like the men here behind me, we can change this nation.”

“This is going to be tremendous and such a good help to fathers in Florida,” said **Coach Tony Dungy, Former Head Coach, Tampa Bay Buccaneers**. “This bill is so important. I want to thank all of the men and women that have been behind this. It is going to allow groups like All Pro Dad and people like those here today to do great things for our fathers here in Florida.”

“I truly believe that education is the solution to many of the issues that we face in society,” said **Glen Gilzean, President and CEO, Central Florida Urban League**. “Education comes in many forms and empowering our fathers with the knowledge they need to better themselves helps the community as a whole.”

One of HB 7065's main provisions is supporting and creating mentorship programs at DJJ for at-risk youth. For many of these youth, their mentor may be the closest thing they have to a father. DJJ also hosts and supports programs for involved fatherhood, including barbershop talks and fatherhood classes.

“I would like to thank Governor DeSantis and the Florida Legislature for their efforts to better support Florida's fathers and to strengthen the role they play in their children's lives,” said **DJJ Secretary Eric Hall**. “A supportive and committed family can help change the trajectory of a child's life, and DJJ looks forward to working with our partners to help even more Florida fathers become stronger parents and role models.”

At DCF, the bill will provide a wide spectrum of family support. DCF will create a statewide awareness campaign to call attention to the importance of responsible fatherhood, and to equip fathers with resources to stay engaged in their children's lives. DCF will also support nonprofit organizations that use evidence-based parenting education to help fathers stay engaged and connect with their children, and support case managers who will help fathers find employment, transition from incarceration and manage their obligations.

“Our Department is very excited about this new fatherhood initiative, and we are so grateful for the Governor and Legislature's leadership in providing funding that strengthens families through responsible parenting,” said **DCF Secretary Shevaun Harris**. “Studies have shown that when fathers are involved in their children's lives, there are undeniable benefits – children are statistically less likely be abused or neglected, and they have fewer behavioral and psychological problems. The Department of Children and Families is laser-focused on preventing adverse outcomes for children, so having the opportunity to work on this initiative is truly an honor.”

KISSIMMEE, Fla. — Today, Governor Ron DeSantis was joined by pro-life advocates and community leaders to sign HB 5, the Reducing Fetal and Infant Mortality Act, to protect the lives of Florida's most vulnerable by prohibiting all abortions after 15 weeks of gestation. “Life is precious and children are a God-given gift,” said **Lieutenant Governor Jeanette Nuñez**. “That is why House Bill 5 is so important, as it provides added protections for the unborn child. Governor DeSantis and I remain steadfast in our commitment to defending the sanctity of innocent human life and protecting the unborn.”

“Every abortion kills a special and unique human being who deserves protection under the laws of this state and the chance to grow up in a loving family,” said **Senate President Wilton Simpson**. “As an adopted child in a family that took in foster children, it has always been important to me that our state do everything we can to promote adoption as an alternative to abortion. Floridians can be proud that we live in a state that not only protects innocent, unborn life, but also supports children and parents. I commend Governor DeSantis for making strong pro-life, pro-child, and pro-family legislation the centerpiece of his administration.”

“With Governor DeSantis' signature on our bill that respects and protects life before and after birth, we are well on our way to saving thousands of babies — and it doesn't stop there,” said **House Speaker Chris Sprowls**. “Through provisions in our bill, we will continue to support babies and new moms to ensure they have the best opportunities to be healthy and safe for years to come. I chose to speak up for the women who say abortion does not cause mental distress and the women in their 70s who had abortions who just now are able to testify on

the regret they have held for 40 years.”

“When Hope was 10 and a half weeks gestation, her birth mother had an abortion at an abortion facility and she left that day believing she had had an abortion, but God had spared Hope's life,” said **Terri Kellogg, Hope's mother Pro-Life Advocate**. “At 5 ½ months, her birth mother felt movement and at that point she chose life and adoption. She didn't know anything was wrong with her baby until she delivered two months early. When I look at Hope and I see her scar, I am reminded of how God spared her. I am thankful for my daughter, and I am thankful for her birth mother who chose life when given a second chance. My heart is full to be here with all of you who have done so much to stand for life.”

“No one wanted my daughter, her father said it's not mine, my parents wanted nothing to do with the pregnancy, my mother even took me for the abortion but when I got there, I didn't do it,” said **Kelly Therrien, Pro-Life Advocate**. “I had nothing, I had nobody but I did it. My daughter will be 3 ½ on the 17th. I was pro-choice but when you get in that spot and it is you personally, it messes with your mind and I am against it now, because I wouldn't have her. People say she was a mistake but no, she was a surprise. Thank you Governor for signing this.”

“Being a single mother has not been easy, but I have the good fortune to be where I am now,” said **Agency for Health Care Administration Secretary Simone Marsteller**. “When I was in college, I fell pregnant at 19. I went to a physician and was handed a referral for abortion without any counseling. I decided to keep my baby and when she was born, yelling and screaming, she was put on my chest and immediately fell silent, that is when I knew I had done the right thing. It takes courage for any woman who finds herself at a crossroads and has to make the toughest decision of their life. I hope hearing my story will encourage someone out there to make a choice and choose life, do not believe the narrative that a baby will ruin your life and that abortion is the right choice, you WILL be fine and all WILL be well.”
