A History of Providing Safe and Convenient Transportation. Construction on Florida's Turnpike began in the mid-1950s, and the first 110-mile stretch was completed in 1957.

As I understand the turnpike extends 264.666 miles. When the Turnpike lobbying was going Florida Residents were promised all kinds of things it would only be a toll road to pay for the construction of and so and so forth. Some of the problems did not come up till a little later.

Obituary for R. Ronald Corbett, Ph.D.



August 6, 1938—August 27, 2022

Ron Corbett passed away in his home in Ocala, Florida, surrounded with the love of his brother Ken and his wife of 50 years Sydney. He fought the good fight, he finished the race, he kept the faith—2 Timothy 4:7-8 sums up Dr. Ron's life. God, Country, Family were the three priorities in his life.

An enthusiastic entrepreneur, Ron had several businesses over the years. In Panama, he had American Supply for 20+ years, offering an unusual combination of restaurant, billiard, wedding, and cake decorating supplies. The motto was *Si Hay—Yes, we have it*. When we "retired" to the United States in 1999, he opened *Yes Solutions*, an ink toner/cartridge and printing business.

His motto for life was "Yes, it can be done." He loved a challenge and loved helping others learn how to meet their challenges. He volunteered with SCORE (Service Corps of Retired Executives) for many years in Ocala, sharing his business acumen and expertise with those who were

opening their own new businesses or who needed guidance to help their businesses prosper.

He was a proud Air Force Veteran, having served in Viet Nam as an air-sea rescue paramedic and earning a battlefield commission. He had been a POW until he escaped and helped several others escape also. He was stationed in Panama when he left the Service after 9 years. He stayed in Panama because he met Sydney, who was a teacher in the local high school. They married in 1972 and stayed there until the Carter-Torrijos Treaty closed the American schools and turned the Canal over to Panama in 1999.

While in Panama, Ron served as a Scout leader for the Sea Scouts. He loved sailing and enjoyed sharing his love and ability with the youth. In addition to a love for sailing, he also loved flying. He helped run a small flying school for those seeking their private pilot's license. He was also the "Dad" Advisor for the DeMolay, leading young men to understand responsibility and morally right living.

Also while in Panama, he served on the Presidential Council of Economics as an advisor on international commerce to Presidents Lakas and Royo. This was quite an honor for a "gringo," a testament to his business acumen.

When in his late-50s, he decided he wanted to have a PhD, "just for fun." He achieved that goal in 1996, after applying for an extension due to surgery for a brain tumor. He enjoyed being called "Dr. Ron" or "the Doc" by his friends and colleagues.

He is survived by his wife, Sydney (Townsend) Corbett, his brother Kenneth Corbett living in Utah, and his daughter Virginia (Ginger) Corbett living in Las Vegas.

OCALA/MARION COUNTY CHAMBER & ECONOMIC PARTNERSHIP



The Ocala Metro Chamber & Economic Partnership, along with CareerSource and Duke Energy, partnered together to thoroughly examine the underlying reasons for a persistently low labor

force participation rate (LFPR) in Marion County. The three components used to conduct the LFPR analysis consisted of an assessment of local, regional and national data related to workforce, demographics and employment trends; interviews with local employers to examine the actual recruiting and hiring experience; and a large-scale survey of the working-age population.

The CEP and our partners know that by understanding why individuals are not in the workforce, we can better prepare our workforce and increase the overall economic vitality throughout the Ocala Metro.

Younger & Associates of Memphis, TN, conducted interviews with key employers in Marion County who provided a number of valuable insights about the labor market. Among the key findings are a need for bilingual (English/Spanish) workplaces and supervisors are necessary; Westport High School's Logistics & Supply Chain program is providing new entrants into the labor force; and high school career days are effective. CareerSource and CEP are cited as being effective, proactive partners for employers. While the ongoing rapid population growth in Marion County is not accurately reflected in LFPR statistics, the survey found that 57.15% of people not working were seeking employment.

This report offers some options to respond to the difficulties that employers have securing the talent they need for their companies. CareerSource CLM, the CEP, and Duke believe that a key solution is in the development of a talent pipeline that originates in businesses linking with our school system. Developing stronger participation in CareerSource's Youth Career Expos, which create awareness in 8th and 9th graders, as well as experiential learning opportunities for students ages 16 and above are essential. Marion County School System is a vital partner to expanding career awareness and after-school and summer employment.

Based on the recommendation from the report, the CEP is working to help facilitate workgroups to assist employers with the resources to:

- employ more bilingual supervisors
- establish centralized intake for to assist employers with hiring individuals with a criminal record or who have been incarcerated
- seek affordable caregiving options for individuals re-entering the workforce after the pandemic

This is data is so valuable as we work with CareerSource CLM, the school system, College of Central Florida, the Children's Alliance, and others to address issues which are keeping individuals out of the workforce. Now is the time to address these recommendations while our job market continues to be so strong.

No-Bake Graham Cracker Squares



Ingredients

- Cooking spray
- 2 cups coarsely chopped graham crackers (from 8 graham cracker sheets)
- 2 cups uncooked quick-cooking oats
- ¾ cup dried cranberries
- ½ cup chopped dry-roasted peanuts
- ¼ cup unsweetened shredded coconut
- ¼ teaspoon kosher salt
- ½ cup honey
- ¼ cup packed light brown sugar

- ½ cup creamy peanut butter
- ½ teaspoon vanilla extract

Lightly coat an 8-inch square baking dish with cooking spray. Stir together chopped graham crackers, oats, cranberries, peanuts, coconut, and salt in a large heatproof bowl.

Bring honey and brown sugar to a boil in a small saucepan over medium-high, stirring constantly; remove from heat. Stir in peanut butter and vanilla until smooth. Pour over graham cracker mixture in bowl; stir until coated.

Press mixture into prepared baking dish; chill 30 minutes. Cut into squares.



Mayorkas on the mission in mid-August of last year as part of an ill-fated effort to reassure the nation that the immigration chaos was under control as startling Border Patrol figures revealed that agents shattered a 21-year-old record in July with 212,672 apprehensions, a 13% increase over June.

Mayorkas, shamefully ousted as a Bill Clinton U.S. Attorney after orchestrating the pardon of a big-time drug dealer, put on his game face, met with Border Patrol officials in south Texas, placated and schmoozed local leaders and publicly suggested that the border is under control. In a press conference delivered in Brownsville, Texas the DHS secretary confidently promoted the administration's plan to deal with the crisis, including spending tens of millions of dollars to address the root causes of migration in Central America, an increase in law enforcement operations with our Mexican partners and a vague strengthening of enforcement with additional personnel. Mayorkas also explained that "worsening conditions...including poverty, a rise in violence, and corruption" were responsible for the rise in migrant encounters. He described the situation as a tough and complicated challenge that involves vulnerable people.

Rep. Cammack Joins Rep. Kim, Colleagues In Bipartisan Letter Urging President Biden To Deny Iranian President Raisi Entry Visa To U.S.

WASHINGTON, D.C. — Rep. Kat

Cammack (R-FL-03) joined Rep. Young Kim (R-CA-39) in sending a bipartisan letter to President Biden urging his administration to deny Iranian President Ebrahim Raisi and his delegation entry into the United States for the United Nations 77th General Assembly in New York later this month.

President Raisi was a member of the Tehran "death committee" responsible for the 1988 organized mass execution of 30,000 Iranian political prisoners, most of which were members or supporters of the People's Mojahedin of Iran (MEK/PMOI). His regime continues supporting terrorism abroad and attempts to kill American citizens and Iranian political dissidents on U.S. soil.

"As a member of the Homeland Security Committee, this is without a doubt a dire national security issue," said Rep. Cammack. "To allow an admitted terrorist to not only enter into our country is not something we can allow as a country that values free, democratic principles and human rights. Especially considering that the 77th General Assembly is scheduled to start just two days after the anniversary of 9/11, it would be completely insensitive and thoughtless for the Biden administration to ignore this pressing matter."

"Given Ebrahim Raisi's record of supporting terrorism and violating human rights, he should not be afforded the privilege to step onto American soil nor the privilege to address the United Nations General Assembly," the members wrote. "We cannot turn a blind eye to perpetrators of gross violations of internationally

recognized human rights and cruel regimes that endanger both their people and Americans. We urge you and your administration to carefully consider this matter of national security and to use your authorities under the INA to deny Ebrahim Raisi and his delegation entry into the United States."

Rep. Cammack Joins Sen. Rubio, Rep. Lawson, Colleagues In Petitioning USTR To Protect Florida Growers From Mexico's Unfair Trade Practices
September 9, 2022

WASHINGTON, D.C. — Rep. Kat Cammack (R-FL-03) joined Sen. Marco Rubio (R-FL) and Rep. Al Lawson (D-FL-05) in petitioning U.S. Trade Representative Katherine Tai to initiate a Section 301 investigation of fruit and vegetable imports from Mexico, and to secure trade relief for Florida growers.

For more than 20 years, Mexico has leveraged heavy subsidies and low wages in a scheme to conduct a "conquest of external markets" and displace Florida's seasonal and perishable agricultural industry from the domestic U.S. market.

"I'm proud to join my colleagues on this effort to address Mexico's unfair trade practices," said Rep. Cammack. "As the only Florida Republican on the House Agriculture Committee, I've seen the way our farmers are suffering from the labor shortages, supply chain issues, and inflationary costs we've been experiencing over the past several months, notwithstanding competition from foreign exporters. Our growers in Florida need immediate relief, which is why my colleagues and I are demanding an investigation into Mexico's export targeting scheme that is directly harming our domestic supply chain."

"The Biden Administration has affirmed its intention to protect and reinvigorate critical supply chains within the U.S.,

including agricultural supply chains," the members wrote. "Mexico's export targeting scheme, which is affecting U.S.-grown produce during the winter and spring months, is a direct threat to this objective. As this petition discusses, and as various government entities, including the U.S. Trade Representative, have confirmed, seasonal and perishable industries such as Florida's generally do not enjoy access to trade remedies. The provisions of Section 301 of the Trade Act of 1974, however, are uniquely suited to investigate Mexico's trade-distorting practices and policies and provide urgently needed relief to Florida's growers."

Spain: Free Rail Travel

The Spanish government of Socialist Pedro Sánchez wants to do everything to "relieve the middle class and workers", says the Prime Minister. From September 1st, rail travel in Spain will be free for local and medium-distance trains for three months. In Germany, 52 million 9-Euro tickets were sold in the summer, saving 1.8 million tonnes of CO2, according to the Association of German Transport Companies.

A 0-Euro train ticket for commuters is available in Spain from 1 of September to 31 December. More than 300,000 people in Spain have already bought a free ticket for rail travel. The railways expect that there will be more than half a million travelers in total. The government of the socialist Pedro Sánchez wants to promote public transport and reduce energy consumption. Above all,

however, the goal is to relieve people financially in view of high inflation in Spain.

The 0-Euro-Ticket is financed by the excess profits tax for energy suppliers and banks, which is supposed to bring in 3.5 billion euros per year. In addition to the commuter ticket, the money will flow into public housing and scholarships for students.

Rail saves 70 to 80 percent CO2 of a car journey

Greenpeace endorses the campaign because each journey by train saves 70-80% of the CO2 emissions of a car journey. In Germany, the 9-Euro-Ticket enabled people to travel by bus and train for only 9 euros per month for three months. Due to the high petrol prices even enthusiastic car drivers take the train: people bought over 52 million tickets, according to the Association of German Transport Companies (VDV). Every fifth buyer had never travelled by public transport before. Therefore, the ticket significantly increased the demand for public transport. According to the VDV, Germany saved 1.8 million tonnes of CO2 with the 9-Euro scheme.

The Spanish 0-euro ticket is a bit more complicated than the 9-euro ticket in Germany. For the ticket, you have to register online and pay a deposit of 10 (short-distance) or 20 euros (medium-distance). You get the deposit back if you use the ticket at least four times a month.

What To Look For

- Dizziness or feeling faint
- Pale or blue skin
- Weak pulse

- Tight, hoarse throat, trouble swallowing, swollen tongue

What is an Allergy?

Allergies are the sixth leading cause of chronic illness in the U.S. An allergy is an overreaction of the body's immune system to an ordinarily harmless substance. Allergies exist throughout the year, indoors and out, and affect people of all ages. Animal dander, house dust mites, foods, grasses, trees, weeds, and molds can all trigger an allergic reaction.

Autumn Allergies

Some allergies are seasonal and more likely to occur at different times of the year. The most common culprit for fall allergies is ragweed, which grows wild almost everywhere, generally between August and

November. A number of plants that thrive during cool nights and warm days also trigger fall allergies.

Who is Affected?

Twenty to 40 percent of the population—including at least one of every four children—suffers from allergies*.

People with allergies are often sensitive to more than one allergen. Prevention or treatment can make the difference between chronic illness and a productive, healthy life.

Diagnosing Allergies

Unfortunately, many of these also show up when someone has a cold, the flu or even COVID-19 but doctors do have ways to tell the difference. The first step is to identify allergen-specific antibodies called Immunoglobulin E (IgE). This can be done two ways.

1. Skin Prick Testing: Commonly performed on the forearm and sometimes the back, the skin is cleaned with alcohol and an allergen extract is pricked into the skin. If an allergy is present, a small itchy bump and surrounding redness often referred to as a "wheal and flare" will appear in about 15 minutes. This indicates the specific allergen.

2. In-Vitro Testing: The doctor simply draws a small amount of blood and has it tested in a lab. It is a less invasive method and receives test results within 24 hours. Many professional medical societies recommend also using in-vitro tests such as the OPTIGEN® Allergy Test.

So, once you know you have allergies, what can be done? Here are some options.

Treatments

Allergy management falls into three main categories: avoidance, medication and immunotherapy.

Avoidance: Once the source of an allergy is identified, a solution may be to simply avoid it. This is most effective with food and animal allergies.

Medication: Prescription drugs can reduce allergy symptoms. Many are effective immediately, though some may have side effects or not work for everybody.

Immunotherapy: Allergy shots are given frequently in scheduled doses of gradually increasing concentrations using extracts containing relevant allergens. The idea is to slowly desensitize the body to the offending allergens. Ideally, an injection program can be discontinued after some years.





National Preparedness Month raises awareness about the importance of preparing for disasters and emergencies that could happen at any time. As the second—and usually more active—half of hurricane season begins, Moody highlighted the [2022 Hurricane Preparedness Guide](#) to aid Floridians in developing storm-safety plans.

Moody weighed in on the guide on Tuesday.

“We’ve been lucky that it’s been a relatively calm hurricane season—so far—but it wouldn’t be prudent to let your guard down. The theme of this year’s National Preparedness month is: “A Lasting Legacy. The life you’ve built is worth protecting. Prepare for disasters to create a lasting legacy for you and your family.” Floridians should take stock of current hurricane-safety plans in order to protect loved ones

and property. Moody’s 2022 Hurricane Preparedness Guide contains information and tips for staying safe before, during and after a storm.

Preparedness tips provided by the guide include:

Know evacuation routes and shelter locations;

Stock up on enough food, water and emergency supplies for you, your family and pets for at least seven days;

Verify that storm-related products are hurricane-proof or impact-proof before purchasing;

After the storm, be wary of contractors who solicit door-to-door, quote extremely low prices for repairs, demand large and upfront payments with no return date to do work, or offer to perform repairs at a discount with leftover supplies from another job; and

Research recovery charities before giving. As solicitations increase following a disaster, so do charity scams designed to profit off the goodwill of others.

After a storm strikes, recovery can be a grueling process that scammers may attempt to exploit. To help Floridians avoid falling victim to scams that may occur in the aftermath of a hurricane, Moody released [“Scams at a Glance: After the Storm.”](#)

TALLAHASSEE, Fla.—Attorney General Ashley Moody, Truckers Against

Trafficking, the Florida Department of Transportation and Busing on the Lookout are teaming up to train more than a hundred Florida workers within the gaming and passenger transportation industries to spot and report human trafficking. Today, Attorney General Moody and TAT hosted the Florida Bus & Casino Coalition Build Out—a virtual training event enlisting more soldiers in the fight against human trafficking. The event invites key bus, transit and casino industry stakeholders to join local leaders, law enforcement and government agencies to receive training on how to spot human trafficking and discuss efforts to stop this atrocious crime.

Attorney General Ashley Moody said, “Excited to co-host this important training to enlist even more soldiers in our fight to end human trafficking. Transportation and casino workers can play a key role in helping rescue trafficking victims, so it’s vital that we provide expert training to make sure they know how to spot and where to report suspicious activity.”

Truckers Against Trafficking Senior Director of Programs and Strategic Initiatives Annie Sovcik said, “Human trafficking is a global crime, but fighting it effectively requires local strategies. Truckers Against Trafficking is grateful to the law enforcement, passenger transportation and casino gaming stakeholders in the state for Florida for recognizing the importance of building public-private partnerships to combat human trafficking – and for dedicating their time and resources to coming together around this issue.”

Florida Department of Transportation Secretary Jared Perdue, P.E. said, “The Florida Department of Transportation is committed to the prevention of human

trafficking throughout Florida. FDOT understands the role we can play in preventing our transportation network from being used to exploit the vulnerable. We work to educate our employees, partners and the general public to know the signs of human trafficking and what to do to prevent it. FDOT applauds Attorney General Moody for her hard work in bringing awareness to this issue and we are proud to be a partner in her efforts.”

Members of the bus and casino industries can play a key role in the fight against human trafficking if aware of the common signs of the crime. There are 17 casinos in Florida. Normal casino-hotel activity—with patrons transiting from the adjacent hotel to the casino floor and back again, as well as the frequent exchange of cash—could help conceal human trafficking.

The [U.S. Bureau of Labor Statistics](#) lists Florida as one of the top states that employs bus drivers. Public transit operators in Florida transported [156 million riders](#) on fixed routes in 2020. According to the [American Bus Association](#), human traffickers use bus terminals and bus stops as recruiting areas when looking for vulnerable people to exploit, and use busing to transport victims. Bus drivers and station employees, who are properly trained to spot suspicious activity, could alert law enforcement and save lives.

Today’s virtual training features a Human Trafficking 101 presentation by Katie O’Rourke, a victim-services program specialist with the Florida Attorney General’s Office. There will also be a training session dedicated to bus and casino companies, a presentation by a survivor-leader/field trainer and a moderated law

Today, Governor Ron DeSantis issued Executive Order 22-213 activating the Florida National Guard to assist the Florida Department of Corrections (FDC) in an effort to reduce overtime and provide relief for correctional officers on a temporary basis.

During the 2022 Legislative Session, Governor Ron DeSantis approved record pay increases to recruit and retain corrections officers. These historic pay increases and other incentives have shown early signs of success, with a net gain of nearly 640 officers since the conclusion of the 2022 session, compared to a net loss of more than 465 in the same amount of time prior. As these successful measures continue to bring more highly qualified officers to the FDC, this action and partnership will address officer vacancies on a temporary, short-term basis.

"Florida Public Universities Ranked Among the Nations Best

TALLAHASSEE, Fla. — Today, Governor Ron DeSantis announced that U.S. News and World Report released their 2022-2023 Best Colleges rankings, with Florida Public Universities earning top spots across multiple categories. The Best Colleges rankings placed the University of Florida (UF) and Florida State University (FSU) among the top 20 public universities in the country. UF earned the number 5 ranking on the list and FSU earned the number 19 spot. The University of South Florida was ranked among the top 50 public universities in the country at number 42, rising four spots from last year and breaking into the list of the top 100 public and private universities for the first time ever at number 97. The University of Central Florida (UCF) and Florida International University were also in the top 100 public universities nationally, coming in at 64 and 72 respectively. As of 2021, Florida has been ranked the number one state for higher education for five consecutive years by U.S. News and World Report.

"Florida schools are some of the best in the nation, and these rankings show that our investments in higher education and our focus on providing an affordable, quality education are paying off," said **Governor Ron DeSantis**. "I am especially proud that we have not allowed tuition increases since I have been Governor, making higher education in Florida as affordable as virtually anywhere in the nation."

enforcement panel. Panel members include Assistant Statewide Prosecutors Mary Sammon and Nicole Phillips, along with Sgt. Bradley Bakeman with the Metropolitan Bureau of Investigation, City of Orlando.

More than 150 participants registered for the virtual event co-hosted by the Florida Attorney General's Office, TAT, FDOT, Hard Rock/Seminole Gaming, American Gaming Association, Florida Public Transportation Association and Florida Motorcoach Association.


