## From the Internet

House lawmakers approved H.Con.Res.58 stating that Congress "denounces socialism in all its forms" and "opposes the implementation of socialist policies in the United States". Sponsors said the vote answers a growing push to normalize far-left economics and election ideas.

Backers argued the United States must protect liberty, markets, and family prosperity from centralized control. The measure passed with full Republican support among those voting and modest crossover from Democrats, signaling a clear, formal stand by the chamber.

The text links socialism with threats to freedom and prosperity and asserts that concentrated state power undermines individual rights. A House Financial Services Committee release said the resolution affirms that America rejects socialism because it endangers the freedoms that define the nation.

Lawmakers paired the message with commitments to free and secure elections. The stated aim is to tell voters, agencies, and states that Congress backs the Constitution's limits on government and the dignity of work and private enterprise.

## CEP CHAMBER NEWS

The signs have been out, the mailboxes have been full and another primary election is officially behind us. Now, attention turns to November.

At the CEP, our interest in election season is centered on public policy and its impact on the business community. Decisions made in Tallahassee and here at home can affect businesses, employees, property owners and communities in ways both large and small. Part of our role is helping Marion County's business community stay informed about those issues and better understand what they could mean locally.

And this November, there is more to watch than the names on the ballot.

Florida voters will consider three proposed amendments to our state constitution, each bringing a different conversation with potential implications for businesses and communities across the state.

One deals with Florida's Budget Stabilization Fund, commonly known as the state's "rainy day fund," and how much the state can set aside to prepare for economic downturns, hurricanes and other unexpected needs.

Another hits especially close to home here in Marion County. Voters will consider a proposed property tax exemption for certain tangible personal property used in agriculture and agritourism. With agriculture and the equine industry playing such a significant role in Marion County's economy and identity, this is an issue with clear local relevance.

The third proposed amendment brings property taxes into the conversation more broadly. Changes to property tax policy can have implications for homeowners, businesses and local governments, making it an issue that touches many parts of a community. As with any proposed constitutional amendment, understanding both the immediate and longer-term impacts is an important part of the conversation.

That is where statewide issues become local ones.

Much of the CEP's work involves issues that intersect with public policy — from workforce and infrastructure to economic development and the overall business climate. We regularly work with businesses,

local governments and community partners, and we know these issues rarely have simple answers.

Over the next several months, there will be plenty of attention paid to the candidates running for office. We also hope to use this space and our other CEP platforms to share information about the issues appearing alongside those names on the November ballot and why they may matter here at home.

You don't have to follow politics every day to recognize that decisions made at the ballot box can eventually find their way to Main Street.

With the primary behind us, there is plenty to learn and discuss before November.

## Chewy Chocolate Cookies

## Ingredients

2 cups all-purpose flour  
3/4 cup cocoa powder  
1 tsp. baking soda  
Pinch kosher salt  
1 1/4 cups (2 1/2 sticks) unsalted butter, room temperature  
2 cups granulated white sugar  
1 Tbsp. instant coffee granules  
2 eggs  
1 Tbsp. pure vanilla extract  
1 cup walnuts, roughly chopped  
1/2 cup chocolate chips

### Directions

Adjust an oven rack to center position, and preheat oven to 350°. Line 2 baking sheets with parchment paper.

In a medium bowl, sift together the flour, cocoa powder, baking soda, and salt.

In the bowl of a stand mixer (or in a large bowl with a hand mixer), cream the butter, sugar, and instant coffee granules on medium speed until light and fluffy, about 2 minutes. Add the eggs one at a time, fully incorporating between each addition. Add the vanilla and mix until just combined.

Add the dry ingredients to the butter/sugar mixture all at once, and mix until fully incorporated. Fold in the chopped walnuts and chocolate chips, being careful not to over mix the dough.

Using a medium cookie scoop, scoop about 2 tablespoons dough, and place onto baking sheets 3" apart.

Bake for 12 minutes. The cookies will still be very soft, but will firm up as they cool. Let them sit for 10 minutes on the baking sheet before moving to a wire rack to continue cooling. Repeat in batches as needed.

On October 13, 1775, the Continental Congress passed a resolution authorizing the purchase and fitting of "two armed vessels, one to carry ten carriage guns and a proportionable number of swivels, with eighty men, to be fitted, with all possible despatch, for a cruise of three months." A second vessel of similar size was also authorized. This was in

response to two British ordnance ships known to be sailing from England unescorted, and their capture would yield powder, arms, and equipment that Washington's army besieging Boston desperately needed.

On October 30, four more vessels were authorized and, on November 10, the Continental Marines were established. By the end of 1775, seven ships had been authorized, and 13 frigates of 24, 28, and 32 guns were under construction in American shipyards.

The Continental Navy never numbered more than 65 vessels, and it was gradually reduced by capture and attrition, effectively disbanding in 1785. The U.S. Navy traces its continuous institutional existence to the Naval Act of March 27, 1794. But, by convention and by act of Congress, October 13, 1775

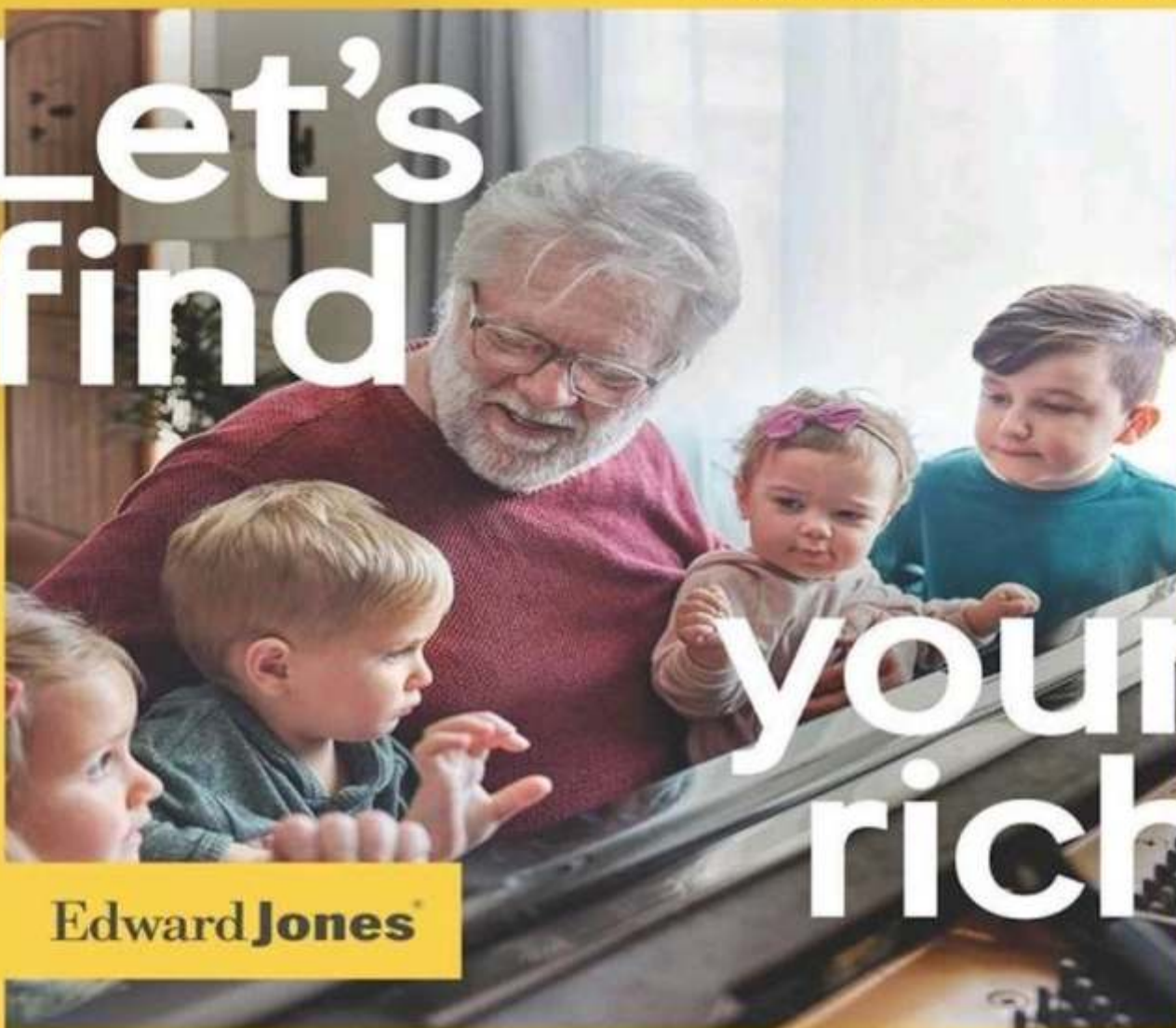

## FAIRTAX



Inflation is often described as “too few dollars chasing too few goods” While that may be a n oversimplification of a complex issue, it captures an important truth: prices rise when the supply of money and purchasing power grows faster than the supply of products and services available for purchase. Let's see how the FAIRtax addresses the “too few goods” side of that equation by encouraging more production.

The current income/ payroll tax system taxes wages, profits, interest, dividends, capital gains and business income. The FAIRtax removes federal taxes from the production process and places the tax at the point of final retail sale. By doing so, the FAIRtax would stop penalizing work, savings, investment and business expansion.

Under our present system, businesses face corporate income taxes, payroll taxes, tax compliance costs, depreciation rules and other federal burdens that raise the cost of producing goods. Those costs are built into the prices we pay. They also discourage investment that would otherwise increase factories, equipment, inventory, transportation capacity and employment. As the saying goes, “the more something is taxed, the less you get of it”.

Under the FAIRtax, companies earn profits without federal income/payroll taxes and workers earn wages without federal income/payroll taxes. When the current tax code goes away, businesses will invest in new machinery, expand facilities, hire workers and bring production back to the U.S.. Investors will also have greater incentive to fund production because capital gains will no longer be reduced by federal income taxation. More investment means more output and more output means more products to buy. When shelves are stocked, supply chains are stronger and domestic producers can respond more quickly to demands and inflationary pressure is reduced.

By removing tax barriers to production, the FAIRtax would attack one of inflation's

root causes: scarcity. If inflation is “too many dollars chasing too few goods”, then a tax system that helps create more goods is a powerful anti-inflation reform.

The answer is a decade ago it started and yes we were and are being invaded. Remember China said the perfect way "to take over a country is take it without firing a shot!" Here is what I think the answer is. Follow me now. People who want to be considered Agriculture must have acreage, Raise beef cows for self consumption and to sell at the market or private transaction. For instance you raise 5 steers, someone wants to buy a beef cow for the freezer. You sell a beef steer and send a copy to the state to prove you are raising to sell and to consume yourself.

# Fire Arnold Truss Manufacturing

## Commercial Structure Fire at Arnold Truss Manufacturing

**(OCALA, FL) Sept. 16, 2026** – Ocala Fire Rescue and Marion County Fire Rescue responded to a structure fire at Arnold Truss Manufacturing, located at 2250 NW 42nd St. The emergency call was received at 5:38 p.m., reporting flames engulfing the commercial structure.

Ocala Fire Rescue's Engine 1, Squad 7, Ladder 3, Battalion Chief 11, and a Safety Officer responded. Upon arrival, firefighters encountered a fully involved medium-sized sawmill shed, with access restricted by a bolted gate. The Safety Officer assisted Engine 1 in cutting the chain to gain entry while additional crews conducted a secondary 360-degree assessment of the structure.

Marion County Fire Rescue crews from Stations 1, 11, 19, and 21 arrived shortly after, established a water supply, and aided in the fire attack.

Because of severe fire conditions and a partial collapse of the structure, crews transitioned to a defensive strategy to extinguish the fire. Despite these challenges, firefighters had water on the fire within four minutes of arrival.

The fire was under control at 5:56 p.m., preventing the flames from spreading to surrounding structures.

No injuries were reported.

Marion County Sheriff's Office also responded.

## CONGRESSWOMAN KAT CAMMACK



Twenty-five years ago this morning, America watched the unthinkable unfold. 343 New York City firefighters went up the stairs of the World Trade Center so everybody else could come down. They did

not come back.

I was 13 years old and living in Colorado. I remember the shock of that morning. I remember watching first responders run into danger while thousands of people fought to get out. That image has stayed with me ever since.

It never left a young man named Matt Harrison either. What he saw that day set the course of his life. He chose the fire service. Today he serves Gainesville Fire Rescue as a firefighter and paramedic, and he spent six years as a SWAT medic. I am proud to be his wife.

Life in a first responder family gives you a close view of service. The tones can go off at any hour. Dinner goes cold. The person you love walks out the door to meet a stranger on the worst day of that stranger's life.

Then you wait.

Every family across North Central Florida with a firefighter, a deputy, a dispatcher, or an EMT at the table knows that wait. Their people run to wrecks on Interstate 75 and Interstate 10. They go into burning homes. They carry neighbors through hurricanes. They handle medical emergencies behind closed doors that nobody else will ever hear about. There is no applause at the end of a long shift. There is another call.

So this is a love letter. To every fire department in our twelve counties, from the

big stations in Gainesville and Ocala to the volunteer companies that cover a hundred square miles with one engine. To the police departments and sheriff's offices that stand with them on every scene. To the dispatchers who take the worst call of someone's life and never get a headline. You are the reason our neighbors sleep at night. Thank you.

Gratitude comes easily on an anniversary. It has to carry into the other 364 days. In my office, that work starts with the equipment our first responders rely on.

Start with the gear. A firefighter should never have to choose between a working air pack and a working engine because a budget got tight. In Congress I voted for the Fire Grants and Safety Act, which extended the Assistance to Firefighters Grant program that pays for protective gear and equipment and the SAFER program that helps departments keep enough people on the truck.

This spring I introduced the First Responders' Equipment Access Act to fix federal rules that get in the way of fire engines and emergency equipment reaching the departments that need them. When Washington argues about spending, I think about who is standing in an apparatus bay in a small county wearing turnout gear that was handed down twice.

Then there are the survivors.

September 11 did not stop killing people on September 11. The federal Victim Compensation Fund reports that deaths from 9/11-related health conditions have far surpassed the number of people killed in the attacks. More than 10,000 FDNY members are living with a certified 9/11-related physical health condition.

Some responders and survivors now call

North Central Florida home. My district team works casework for people fighting serious illnesses while navigating federal paperwork. We help eligible constituents work with the World Trade Center Health Program and the September 11th Victim Compensation Fund. Our job is to make sure a federal form does not stand between them and the help available under the law.

Today I will climb the stairs at Ben Hill Griffin Stadium with the firefighters of Alachua County. Last year hundreds of first responders and neighbors climbed 2,071 steps in The Swamp for the people we lost. Then I will travel to Lake City and stand in the apparatus bay with the men and women who protect Columbia County. Most of them were kids on September 11, 2001. Some were not born yet. They chose this work anyway.

Twenty-five years later, they still run in. We still owe them. We honor the promise to never forget when we remember the fallen. We keep it when we take care of the ones still carrying the cost of that fateful day.

One day I will tell Auggie why her dad does what he does. I will start with the 343.

### Congresswoman Kat Cammack Issues Statement on the Censure of Rep. Chuck Edwards

WASHINGTON, D.C. — Congresswoman Kat Cammack (FL-03), Chair of the Republican Women's Caucus, released the following statement after the House voted 413-2 on Tuesday to censure Rep. Chuck Edwards (R-NC) following a bipartisan House Ethics Committee investigation into his conduct toward two staffers:

"Yesterday, I voted to censure Congressman Chuck Edwards.

I read the Ethics Committee's report, and I read his letter and his lawyers' response with the seriousness they deserve. He had every right to defend himself. It did not change my

vote.

The Committee found a persistent pattern of unprofessional and inappropriate conduct toward two young women on his staff, and he did not deny much of the underlying conduct. In fact, defends it. He defends the gifts and the poetry, and he defends traveling with a young woman who had only just left his office. His argument is that none of it broke a rule, and that is precisely the problem.

I was a congressional staffer myself before becoming a Member. I understand the responsibility Members have to the people who work for us. Members of Congress hold enormous power over the people who work for us. 'Technically permitted' is a low bar. Judgment is the standard.

I co-founded the Republican Women's Caucus to raise the standard in this institution, and that starts with how we treat the people who serve alongside us. Two young women left his office, and the Committee said the House lost them because of his conduct.

Congress cannot ask the American people to trust this body if we refuse to hold ourselves accountable. Yesterday's vote was accountability after the fact. My work with Chairwoman Leger Fernández and the Democratic Women's Caucus is about making sure the next staffer never has to get that far. We will have more to share on that work soon."

### Congresswoman Kat Cammack Secures \$50 Million in Water Infrastructure Authorizations and Horseshoe Beach Storm Protection Study in House-Passed WRDA

Washington, D.C. — Congresswoman Kat Cammack (FL-03) secured \$50 million in new and expanded federal water and wastewater infrastructure authorizations for Columbia, Suwannee, Marion, and Gilchrist Counties, along with a coastal storm risk study for Horseshoe Beach in Dixie County, in the Water Resources Development Act of 2026 (H.R. 9497), which passed the House of Representatives today by a vote of 415 to 9.

The House-passed bill:

Authorizes up to \$39.3 million for water and wastewater infrastructure in Columbia and Suwannee Counties.

More than doubles Marion County's existing authorization, from \$10 million to \$20.5 million, providing an additional \$10.5 million in authorized capacity.

Authorizes up to \$200,000 for water and wastewater infrastructure, including stormwater management, in Gilchrist County.

Directs the U.S. Army Corps of Engineers to study coastal storm risk management for the town of Horseshoe Beach, including shoreline damage prevention and mitigation.

"Our water and wastewater systems in North Central Florida carry the weight of decades of growth and back-to-back storms. Columbia, Suwannee, Marion, and Gilchrist Counties needed a federal partner. Securing these three priorities in the House-passed WRDA is an important step toward delivering the infrastructure these growing communities need," said Congresswoman Kat Cammack. "Horseshoe Beach took a direct hit from Idalia and Helene, and this study is the first step toward advancing long-term coastal storm protection for the community.

**Attorney General James Uthmeier Proposes the Florida Anti-Spam Communications Act to Stop Robocalls, Robotexts, and AI Voice Scams**

TALLAHASSEE, Fla.— Attorney General James Uthmeier proposed legislation that gives the Attorney General independent authority to investigate and shut down spam calls and texts and gives prosecutors new tools against impersonation, fake warrants, undisclosed AI voices, and the phone farms that power those campaigns.

“Floridians should not have to fear every unknown call or text,” said Attorney General James Uthmeier. “What we are talking about is fraud—pure and simple. It just arrives as a phone call, a text, a fake warrant, or an AI voice. This proposal lets our office investigate and act independently, and it gives prosecutors the tools to put the worst offenders in prison.”

Spam floods Florida phones. Scammers spoof government agencies, banks, and utilities. They send fake warrants and official-looking papers by text. Artificial voices make the fraud sound real. Under current law, some of these crimes don't carry tough penalties, and Florida law does not provide consequences for the phone farms and SIM farms that blast thousands of numbers from one room.

The Florida Anti-Spam Communications Act would:

1. Crack down on phone and text fraud, including AI voices and fake warrants.

Impersonating an official, spoofing a number, using an undisclosed AI voice to obtain money, or sending a fake warrant by text or e-mail is treated as communications fraud and simulated legal process. High-volume or high-loss cases would be an elevated felony and carry mandatory prison time. Possession or importation of a phone farm or SIM farm becomes a felony, and the equipment is designated contraband.

2. Cut off unlawful traffic.

Communications providers would be required to authenticate caller ID, answer traceback requests, and cut off a named unlawful campaign after written notice.

3. Strengthen consent and opt-outs.

Florida's telemarketing consent law is tightened, and a STOP request must be honored within days instead of weeks. Selling stolen lists used to target Florida numbers is its own civil violation.

4. Give the Attorney General independent authority.

The Department of Legal Affairs may investigate spam calls and texts on its own and seek injunctions, restitution, and civil penalties, including against those who sell or traffic in illegally obtained records.

5. Educate seniors before the next call lands.

The Department of Legal Affairs would run a statewide campaign so older Floridians know how to spot a fake warrant, a spoofed number, and an AI voice—and how to hang up and report it.

Floridians who receive a suspicious call or text should not send money. A real court does not text a warrant. Report it at 1-866-9NO-SCAM or MyFloridaLegal.com.

**Attorney General James Uthmeier Takes Legal Action Against Amazon for Secret Ad Surcharge Scheme Driving Up Prices for Florida Families**

TALLAHASSEE, Fla.—Attorney General James Uthmeier joined the Federal Trade Commission and 21 other states in suing Amazon, alleging the company spent years secretly inflating the prices Florida businesses pay to advertise on its platform—costs that were then passed on to Florida families at checkout.

“Amazon told Florida businesses they were bidding in a fair auction. That was false,” said Attorney General James Uthmeier. “Amazon hid a surcharge, padded its own profits, and those costs landed on Florida families buying groceries, medicine, and everyday essentials. Amazon should expect to be held accountable.”

According to the complaint filed in the U.S. District Court for the Western District of Washington, Amazon represented for years that it ran “second-price” auctions in which the winning advertiser would pay only one cent more than the next-highest bidder. In practice, Amazon added an undisclosed surcharge and used an “invented auction participant” to drive prices higher than genuine competition would have produced. By 2024, Amazon charged Sponsored Products advertisers their own winning bid approximately 80 percent of the time, converting a nominally second-price auction into a first-price auction without telling customers.

The complaint alleges Amazon began testing hidden surcharges in 2019 and 2020. After concluding advertisers could not detect the extra charges, Amazon rolled them out across the platform and ramped them higher on Prime Day and Black

Friday. Internal documents quoted in the complaint describe “a surcharge hidden in it” and a “clever non-transparent way to charge first price.”

Those overcharges did not stop with the businesses that buy ads. The complaint alleges that a significant portion of the advertising costs paid by Amazon sellers “are ultimately passed through to and paid by Amazon shoppers in the form of higher prices,” including on low-margin necessities families buy every day. Nationally, the scheme is alleged to have extracted more than \$20 billion from approximately 1.2 million advertising customers, including more than 500,000 small- and medium-sized businesses. Sellers and vendors based in Florida have been overcharged by hundreds of millions of dollars over more than four years.

Amazon understood that disclosing the change would cause advertisers to lower their bids. The complaint alleges the company concealed the surcharges, gave false and misleading answers when advertisers asked whether the auction format had changed, and continued the practice after the FTC notified Amazon of its investigation.

The lawsuit alleges Amazon violated the Florida Deceptive and Unfair Trade Practices Act. Attorney General Uthmeier seeks a permanent injunction, consumer restitution, disgorgement of ill-gotten gains, civil penalties, attorney's fees, and other relief authorized by Florida law.

**Governor Ron DeSantis Announces  
Second Annual Second Amendment Sales  
Tax Holiday**

LAKELAND, Fla. — Today, Governor Ron DeSantis announced Florida's Second Amendment Sales Tax Holiday is back for a second year, providing tax relief on firearms, ammunition and a wide range of hunting, fishing and camping supplies through December 31. The Governor also broke ground on the new Florida Archery Center at Tenoroc in Lakeland, expanding opportunities for Floridians to participate in shooting sports and enjoy the outdoors.

"Since I became governor, we have enacted billions of dollars in tax cuts. This year's hunting, fishing and camping sales tax holiday—ongoing through December

31—will provide Floridians with even more tax relief," said Governor DeSantis. "We are proud to protect Floridians' Second Amendment rights while helping hunters, anglers, and sportsmen keep more of their hard-earned money."

The Second Amendment Sales Tax Holiday began September 1 and runs through December 31, 2026. During the holiday, Florida will suspend the collection of sales tax on eligible firearms, ammunition and hunting, fishing and camping equipment.

Eligible purchases include:

Ammunition;

Firearms, including pistols, rifles and shotguns;

Firearm accessories, including holsters, grips, sights, stocks and cleaning kits;

Bows, crossbows and related accessories;

Fishing rods, reels, bait and tackle; and

Eligible camping supplies, including tents, sleeping bags, camping stoves and lanterns.

Following the success of last year's inaugural holiday, Florida expanded tax relief for 2026. This year, the state doubled the eligible price thresholds for fishing bait and tackle to \$10 for individual items and \$20 for multiple items sold together. Florida also expanded tax relief for firearm accessories through a separate sales tax exemption that includes magazines, range bags, firearm barrels, triggers, slings, bipods and suppressors.

**Governor Ron DeSantis Awards More  
Than \$10 Million to More Than 1,500  
New Law Enforcement Officers**

Since 2022, nearly 12,500 new law enforcement officers across the state have received bonuses through the Florida Law Enforcement Recruitment Bonus Payment Program, totaling more than \$83 million.

LAND O'LAKES, Fla. — Today, Governor Ron DeSantis awarded more than \$10 million in bonuses to 1,506 new law enforcement officers through the Florida Law Enforcement Recruitment Bonus Program, including 38 new recruits in Pasco County. Since 2022, nearly 12,500 new law enforcement officers across the state have

received bonuses through the program, totaling more than \$83 million.

"In 2022, while some cities were reaping the disastrous results of "defund the police" experiments, I signed landmark legislation to strengthen law enforcement recruitment and retention in Florida," said Governor Ron DeSantis. "In the four years since, we have awarded nearly 12,500 bonuses totaling more than \$83 million to our law enforcement officers. We have also made record-breaking investments in officer pay, benefits, training, and protections for the men and women who put their lives on the line to protect the people of our state. We continue to build on this foundation to keep Florida the most law enforcement-friendly state in the country."

"Governor DeSantis has made Florida the national model for supporting law enforcement and the nearly 12,500 recruitment bonuses awarded since 2022 are a testament to the success of that commitment," said Secretary of Commerce J. Alex Kelly. "Through a comprehensive commitment to the men and women who protect our communities—including investments in pay increases, expanded education opportunities and wellness benefits—Florida remains committed to our sworn officers and their families."

The program provides a one-time \$5,000 bonus—after taxes—to newly recruited and employed officers as a show of appreciation and incentive for choosing to serve Florida. The bonuses are part of a broader initiative to solidify Florida's position as the Nation's law-and-order state.

Under the Fiscal Year 2026-27 budget, the Governor secured \$19.8 million in pay increases for sworn state law enforcement officers, \$20 million for the Law Enforcement Recruitment Bonus Program, and \$2.5 million in pay increases for state firefighters. In the Fiscal Year 2025-26 budget, state law enforcement officers saw a raise in the minimum base pay to \$60,000 and significant raises for both entry-level and veteran officers—10% and 15% increases, respectively.
