A YEAR IN RE-VIEW

I am proud to say that we have accomplished a great deal in 2015 here in Marion County. Crime in Marion County has been re-

duced by 8.9 percent in the last two years and we've saved enough money to put our hard-working, dedicated deputies in new cars that can safely get them to and from their calls for service. Your Marion County Sheriff's Office also has the #1 ranked SWAT Team in the world. Our SWAT Team is comprised of individuals who are specially trained, prepared and proven to protect our citizens at a moment's notice. We have town hall meetings each month to brief our citizens on what they need to know and answer any questions they may have regarding homeland security, crime trends or any other issue of importance they may want to discuss. We have regularly scheduled 12-week Citizens Academies which nearly 1,000 citi-

zens have attended. I also hold and teach a concealed weapons class – which close to 600 Marion County citizens have attended – in order to make sure our citizens who want to be armed can lawfully do so.

But recently, I have been concerned with certain things I see happening outside of our county borders. The increase in gun violence and terrorist activity we've recently seen in our country has me worried for my citizens here at home.

If you are certified to carry a gun, I would like to encourage you to do so. Those who

## Representative Dennis K. Baxley Endorses Governor Scott's Proposed Reforms for Enterprise Florida

Ocala, Fla.— Representative Dennis K. Baxley, HD 23, announced his support for Governor Scott's proposed reforms for Enterprise Florida, including the creation of the Florida Enterprise Fund.

Representative Baxley said, "Gov. Scott has stayed laser focused on diversifying Florida's economy, making Florida the best place to do business, facilitating jobs, jobs, jobs in the private sector raising the path of opportunity for all Floridians. Enterprise Florida has been a major tool for this success, putting Florida on a sound footing. Legislators should give high priority to this initiative to invigorate this effort with the revamp of Enterprise Florida for maximum success. Below please find details of this plan. Gov. Scott is leading and he has my full support."

Our proposed economic reforms which have been endorsed by the Enterprise Florida Executive Board include:

Creating a new \$250 million competitive fund called the "Florida Enterprise Fund."

Making the Florida Enterprise Fund a state trust fund to replace the existing escrow account to allow the state's investment to accrue more interest.

Increasing the Legislature's role in competing for job creation projects by requiring that any deal over \$1 million have the approval of the Speaker of the House and the Senate President, as well as the Governor.

Reforming the return on investment requirements by eliminating the use of waivers and requiring a 10 percent annualized return on top of the original amount invested in a company.

Streamline the state's approval process while continuing to ensure that NO tax dollars leave the state trust fund until a company meets specific job creation goals spelled out in their contract.

# **Helping Older People** to Maintain Independence

(NAPSI)—For most older adults, the identify the transportation options in their ability to live independently is associated with the ability to drive. That's one reason the prospect of eventually "giving up the keys" can be a frightening one.

To help, the experts on aging at the National Association of Area Agencies on Aging (n4a) developed a brochure called "Before You Give Up the Keys: Create a Roadmap for Transportation Independence" that may lessen those fears by empowering older adults to evaluate their mobility needs,

community and develop a plan customized to their unique circumstances.

"A too-familiar scenario is that older adults wait until they're involved in some sort of emergency, like a traffic accident, before they really think about their driving ability and the other transportation options available to them in their community," said n4a CEO Sandy Markwood. "Our goal is to shed light on a critical issue that will likely affect most families with an older loved one who may need to limit or eliminate their driving, and to provide a catalyst for discussion, and hopefully, action," Markwood also

The n4a represents America's national network of 623 Area Agencies on Aging (AAAs). It helps older adults and people with disabilities live with dignity and choices in their homes and communities for as long as possible.

To that end, it created the Eldercare Locator. This serves as an essential, trusted gateway to help older adults, caregivers and health professionals navigate the maze of aging programs and services, as well as to assist them in identifying and accessing the resources that match their needs best. The National Call Center operates five days a week from 9 a.m. to 8 p.m. ET and can be reached at 800-677-1116 or www.eldercare.

According to recent research by the Federal Transit Administration, the National Highway Traffic Safety Administration, n4a and the National Aging and Disability Transportation Center, the rise in the 65-plus population—some 45 million and growing—has triggered a corresponding spike in the number of nondrivers of more than 1.1 million between 2001 and 2009.

"This is a major issue for older adults because when they lack access to transportation, they can't get to the doctor, the grocery store or see friends and family as much, which means their overall well-being is likely to suffer," added Kathy Greenlee, Assistant Secretary for Aging.

# OCALA/MARION COUNTY CHAMBER & ECONOMIC PARTNERSHIP



As we begin the New Year, the CEP has much to celebrate as we look back over the last year. The CEP will celebrate 2015 and the year's accomplishments at our Annual Luncheon on February 10th at

Circle Square Cultural Center, but I wanted to take a moment and relay some of the highlights. This month we will focus on the great success and strides our Business Attraction and Business Retention efforts have

made and will focus on Business Creation, Business Services and Business Advocacy next month.

What a year it has been! Last January in front of the largest crowd of business and industry leaders ever gathered in our community, the CEP outlined how we are working to meet our Moving Forward goals by the end of 2017. That plan includes three strategic goals to be met over five years (impact the creation of 3500 new jobs, which on average pay 15% above the average county wage, and result in a capital investment of \$225 million) and the two guiding principles to reach those goals (does it create or retain jobs, does it provide a return for our inves-

tors). The plan outlines the five program areas and the staff and investment needed to accomplish those goals. While we will not announce the official progress on these goals until the Annual Luncheon, we will state that we are ahead of schedule on all three strategic goals!

**Business Attraction** 

This year has seen a nice mix of manufacturing, logistics and office projects. The year began with the announcement that Coates Golf would be locating their head-quarters and distribution facility here. Other significant projects include eResources moving their headquarters and network operations center to Ocala, the purchase of the former Merillat facility by Paramount Transportation Logistics, and The REV Group, Inc. establishing an ambulance manufacturing center.

The Ocala MSA continued to see its un-

employment rate plummet while the job growth rate has been among the highest in the state. Forbes again named the Ocala MSA to its list of Top 10 Metros for Job Growth and Bloomberg included the area on its list of Fastest Growing Economies.

Business Retention

A focus of the CEP is to have the best business retention program in the state of Florida and we believe we are certainly among the best. Our team has worked with approximately 200 existing businesses this year working to identify barriers to their growth and ways to remove those barriers. We are still finalizing the numbers but the CEP has directly assisted existing companies, which has led to the announced creation of nearly 400 jobs and approximately \$10 million in capital investment. What a great endorsement of our community to have companies currently doing business here growing and expanding!

This year at the CEP has been a great one and we are excited about the opportunities in store for our community in 2016. Thank you for your partnership and desire to help keep our community Moving Forward!

# 3 Steps to Kick Off a Year of Good Health

(Family Features) A fresh beginning with a new year is the perfect time for a health assessment to ensure you are ready to take on a full and active year ahead. Even if you're feeling great, it's a smart practice to take time to identify potential problems before they become more serious health concerns.

Early detection of ailments, such as cardiovascular disease, can significantly impact an individual's ability to cope with the disease, allowing you to make adjustments such as changes in diet and lifestyle, or when necessary, drug therapies and other medical treatments. Delaying detection of this serious disease until its more advanced stages can have dire consequences.

With these three steps, you can get a better picture of your cardiovascular health and identify silent, hidden risk factors (like plaque in your arteries) that you may not even know are there.

Get your blood pressure checked. Blood pressure measures how much force a person's blood is putting on the artery walls as the heart pumps. High blood pressure, or hypertension, occurs when your heart has to work extra hard to pump blood throughout the body. High blood pressure often happens when arteries lose their elasticity through hardening caused by cholesterol, plaque or scarring. Many people do not experience symptoms of high blood pressure, so it's im-

portant to have your blood pressure checked periodically. Screening for high blood pressure involves placing a pressure cuff around your upper arm to monitor both diastolic and systolic blood pressure. A normal systolic reading is between 90 and 119, and a normal diastolic reading is 60-79.

Get your cholesterol

Get your cholesterol checked. A simple fingerstick screening measures

total cholesterol as well as three different kinds of lipids in your blood (HDL, LDL and triglycerides), which are important in determining your heart health. Low-density lipoprotein, or LDL, is known as the "bad" cholesterol and can build up in the walls of the arteries that feed the heart and brain. Along with other substances, it can form plaque – a thick, hard deposit that can clog those arteries. High-density lipoprotein, or HDL, is known as "good" cholesterol because it carries LDL away from the arteries and back to the liver, where it's passed from the body. A high HDL level helps prevent heart disease, while a low HDL level increases the risk of heart attack and stroke. Triglycerides are the most common type of fat. Like cholesterol, they circulate in blood but are stored in the body for extra energy. A high triglyceride level combined with a low HDL or high LDL can speed up the process of plaque formation in the arteries.



Learn about other risk factors for cardiovascular disease. Many people in the early stages of cardiovascular disease are asymptomatic, meaning they have no symptoms to indicate their health is at risk. Some common risk factors include age (55 and older), family history, tobacco use and high blood-pressure, other factors, such as high cholesterol, aren't as easily observed. Preventive health screenings, such as those provided by Life Line Screening, can give you a fuller picture of how risk factors may be stacking up. The screenings are designed by doctors and administered by trained professionals to help detect hidden health issues. Garlic Cream Elbows With Sun-Dried Tomatoes and Basil

Prep time: 10 minutes Cook time: 20 minutes

Servings: 4

8 ounces (about 2 cups) Dreamfields Elbows

1 tablespoon unsalted butter

1/4 cup diced red onion

4 cloves garlic, minced

2 tablespoons all-purpose flour

1 cup 2% milk

1/2 cup (2 ounces) grated Parmesan cheese

1/2 cup low-sodium chicken broth salt

pepper

1/3 cup julienne cut sun-dried tomatoes, not packed in oil, divided

1/3 cup chopped fresh basil, divided Cook pasta according to package directions.


