

Gov. Scott Directs DEP to Investigate St. Petersburg Sewage Spill

TALLAHASSEE, Fla. - Governor Rick Scott directed the Florida Department of Environmental Protection (DEP) to investigate the recent sewage discharges in St. Petersburg. While the City of St. Petersburg is responsible for conducting testing in the immediate area of the sewage spill, Governor Scott yesterday directed DOH to begin additional testing at this site. Additionally, the Florida Department of Health (DOH) continues to monitor the water quality and conduct sampling at 14 beaches which includes nine in Pinellas County and five in Hillsborough County. Earlier this month, following Hurricane Hermine, the City of St. Petersburg dumped about 150 million gallons of raw and partially-treated sewage and wastewater into Tampa Bay and Boca Ciega Bay.

Governor Rick Scott said, "Florida is known for our pristine environment, world-class beaches and award winning state parks. We must do all we can to protect our environment and that is why I am directing the Florida Department of Environmental Protection to investigate the sewage dump that occurred in St. Petersburg following Hurricane Hermine. Today, I spoke with Nick Wiley, Executive Director of the Florida Fish and Wildlife Conservation Commission, and requested that they provide assistance to

DEP if necessary during its investigation. I want to thank Representative Kathleen Peters, Senator Jeffery Brandes and Senator Jack Latvala who have been focused on this issue and I look forward to reviewing DEP's findings."

At this time, DOH has issued one health advisory for Simmons Park Beach in Hillsborough County which is across the bay from St. Petersburg.

Please review the evidence and let me know what you think, I will print your review!



#### **Ocala Fire Rescue**

(OCALA, Fla.) September 23, 2016 – Ocala Fire Rescue firefighters have had a Friday filled with fire calls which have not only ranged in structure type, but which became progressively worse as the day elapsed.

The morning began with reports of a fire at 1850 SE 18th Avenue. At 7:58 AM a caller advised Marion County Dispatch that a building located in Deerwood Apartment Complex appeared to be on fire. Crews arrived to find smoke showing out of a work shed. Entering the smoke filled shed, fire-fighters proceeded to identify hot zones and ambers throughout the garage, watering each area with a possible threat along the way. No one was in the shed at the time of the fire. No injuries were reported.

The second fire call came in at 10:17 AM, when a neighbor noticed that the Recreation Vehicle next to his was on fire. Firefighters arrived at 4001 West Silver Springs Boulevard to find an RV with flames covering ap-

proximately one third of the structure. The RV, which was not occupied of at the time of the fire, was a total loss.

The last fire however, left a man seriously burned. At 2:41 PM, OFR was dispatched to 1512 SE 43rd Avenue, where a man working on his motorcycle suffered serious burns after fuel from the motorcycle ignited. Three minutes later firefighters were on scene preparing the patient for transport to Shands Medical Center. No other injuries were reported







#### Man Killed by Falling Tree During Storm

MARION COUNTY, Florida (September 2, 2016)- On Friday, September 2, 2016, Marion County Sheriff's Office (MCSO), Ocala Fire Rescue (OFR), and the Ocala Police Department (OPD) responded to the Diamond Oil gas station located at 3380 SE Lake Weir Avenue in reference to a storm-related death.

The investigation revealed that three individuals were sleeping in tents behind the Diamond Oil when a tree fell onto their campsite. Two individuals were able to get out from under the debris and call 911. Units from MCSO, OFR and OPD responded and immediately began clearing debris, at which

time, they discovered a white male, who was later identified as John Mayes (DOB: 2/1/1960). Mayes received fatal injuries from the fallen tree.

Lieutenant Chip Wildy, Marion County Emergency Management Director, stated "It is always tragic when there is a loss of life during a natural disaster. Emergency Management personnel along with first responders are actively assisting our citizens with anything they may need following this storm." - 3. Prepare the grill for indirect cooking over medium heat (350° to 450° F).
- 4. Mix the rub ingredients. Season the chicken breasts all over and between the skin and meat with the rub.
- 5. Drain and add the wood chips to the charcoal or to the smoker box of a gas grill, following manufacturer's instructions, and close the lid. When smoke appears, grill the chicken, skin side down first, over indirect medium heat, with the lid closed, until the juices run clear and the meat is no longer pink at the bone, 25 to 30 minutes, turning once when the skin releases easily from the cooking grates. Remove the chicken from the grill and, when cool enough to handle, shred into pieces, discarding the skin and

6. Increase the temperature of the grill to

high heat (450° to 500° F).

- 7. Spread half of the tortilla chips into a large grill-proof pan. Distribute half each of the cheese, scallions, jalapeño, and chicken over the chips. Repeat with another layer.
- Place the pan with the nachos over indirect high heat, close the lid, and cook until the cheese is melted and the chips are tinged golden brown, 7 to 9 minutes. Wearing insulated barbecue mitts or gloves, carefully transfer the pan to a heatproof surface. Top the nachos with the avocado and then drizzle with the chipotle cream and lime juice. Garnish with the cilantro. Serve hot with salsa, if desired.
