## PUBLISHER'S NOTES



What have we learned from the Forest High School shooting? During a conversation with a nurse this last month, we were talking about what we learned from this shooting suspect at Forest High

School. Sources say most of our resources were at Forest High when the call came in that there was another student with a gun at West Port High School. The school was locked down, the student had a gun but was not attempting to use it. Meanwhile the person that I talked to said she received a call stating the school her daughter was at was in lockdown, her daughter was safe and in the background there were people hollering, sirens blaring. Things sounded like chaos in the background. This would be easy to fix. The parents need to know if things are under control. Don't give them a heart attack. Maybe an automatic dialing system and a brief message without the background

noise.

For those of you that have not watched the video interview of the suspect in the Forest High School shooting, watch it on [www.ocala.com](http://www.ocala.com). You will see the true story.

I ask again: what did we learn? A statement from the gunman who was nineteen said "I was surprised how easy it was to walk into the school and go into a bathroom." He said "no one tried to stop me!" We have learned from other incidents, if a person wants to get attention, they can get a gun, knife, hammer, car or just a blunt object. They will get attention which is what they really want. When these incidents happen we should report the news for 24 hours then shut it down and let the investigation take place, instead of talking about it every day for months. When we teach high schoolers and college students about shooters maybe we should not tell them to run and hide. Tell them to use their heads. It's very possible they might be standing right next to the shooter before they

run and hide. I don't know what the answer is but this Forest High shooter should not have been able to get a gun. He was Baker Acted when he was 14 years old for the same thing. Talk about doing something stupid. Makes you wonder????

While I am on the gun issue, let's talk people who leave the big city and move to rural Marion County. I think it is against the law to target practice in your yard unless you have a certain amount of land. If a bullet ricochets and hit someone or an animal you are liable and it is a felony. I have asked for the statue but I am not an attorney. I would like law enforcement to say if you have 5 acres and a qualified backstop you can shoot and make them permit it. If there is a call about bullets buzzing by neighbors, something should happen but right now nothing does.

Turnpike Authority strikes again. They have added the word Enterprise to their title. Anyway check out the story in this paper about the Coastal Connector.

There seems to be a lot food product/food recalls. Go to "Recall Alert" google it and check it out. There is more on that site than I ever thought would be there. I think it's coming largely from Foreign Countries.

Marion County hits state and national news. Marion County K9 deputy Jeremie

Nix saved a three months old child. The baby's mother flagged down the deputy who was on his way home from work. He went into action using some lifesaving methods which were not working so he put the baby in his patrol car and rush him to the hospital where they stabilized him.

Teacher suspended after drowning raccoons. A local FFA teacher drown two Raccoons and an Opossum after they had killed Chickens that the students were raising for an FFA project. Drowning them was probably a bad choice but maybe giving them to a Florida Wildlife Officer might have been better. I know on my Farm we had a raccoon go into our chicken pen and kill a number of our chickens. I could maybe understand it if he was eating them but he was just killing them. He was stopped! I think this will blow over but the teacher did not handle it correctly. Don't make the students a part of the action. From what I understand the Florida Wildlife is looking into the incident. Put a letter in his file and let him go back to teaching!

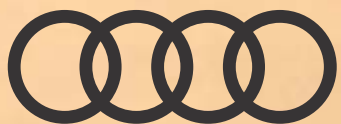

# Florida State Senate

## DENNIS K. BAXLEY



In 1968, Florida became the only state to allow for its state constitution to be revisited and changed through a regularly scheduled commission called the Constitution Revision Commission. Once

every 20 years, Florida's Constitution provides for the creation of a 37-member revision commission for the purpose of reviewing Florida's Constitution and proposing changes for voter consideration. The Constitution Revision Commission (CRC) meets for approximately one year, traveling the State of Florida, identifying issues, performing research and possibly recommending changes to the (State) Constitution. Any amendments proposed by the CRC would be placed on the 2018 General Election ballot. You can visit their web site at [flcrrc.gov](http://flcrrc.gov) to see all of the proposed Commission and Public Proposals, the full text of each proposed ballot amendment and additional information about the commission.

You might want to consider voting by mail, mailed to you by the Supervisor of Elections 35 days prior to the election. This will allow you plenty of time to review the eight (8) amendments being proposed by the CRC. In addition, there are numerous other amendments and perhaps a few local issues for consideration. The eight proposals by

the CRC are as follows:

- 1) Rights of Crime Victims; Judges
- 2) First Responder and Military Member Survivor Benefits; Public Colleges and Universities
- 3) School Board Term Limits and Duties; Public School
- 4) Prohibits offshore Oil and Gas Drilling; Prohibits Vaping in Enclosed Indoor Workplaces
- 5) State and Local Government Structure and Operation
- 6) Property Rights; Removal of Obsolete Provision; Criminal Statutes
- 7) Lobbying and Abuse of Office by Public Officers
- 8) Ends Dog Racing

The fact that most of these amendments cover more than one subject should give you pause. The Supervisor of Elections in an April 18<sup>th</sup> Press Release encouraged voters to vote by mail and to expect a lengthy ballot in November. These amendments must secure 60 percent of voter approval to become law.

You may feel strongly about an issue, but consider, does this issue belong in my State Constitution or can it be accomplished through the legislative process by passing a bill to become law.

Keep in mind this is your Government, your Constitution and you decide the outcome.

Preserve farmland

While Florida can use an enhanced road system, such enhancement should not compromise Marion County's wonderful farmland and horse country.

My suggestion is linking the Suncoast Expressway and Interstate 75 around Brooksville, where the Suncoast and I-75 are already pretty close in what is largely an urbanized area. And it would not take much to extend an expressway to the east to link up with Florida's Turnpike in the Clermont area.

A State Road 50 expressway connector would let Pinellas County traffic readily find its way to I-75. Going the opposite direction, turnpike traffic going to Tallahassee and points west via Interstate 10 could get over to the Suncoast

Expressway, which could easily be extended to U.S. 19/98 at some convenient place in Citrus or Levy county.

My proposal would create a new roadway in an urbanized area to serve as a great east-west connector. Meanwhile, Marion County could still preserve its wonderful farmland and horse country.

Mother's Day was recognized as a holiday

in West Virginia in 1910, and became a national holiday in 1914, primarily through the efforts of Anna Jarvis of Grafton, West Virginia. Jarvis is now widely credited as the founder of Mother's Day.

In the nineteenth century, however, there were several attempts to establish a holiday honoring motherhood. Most of these celebrations were on a local level, or with political motives: one notable mother's holiday was celebrated in the cause of peace, and another was created to discourage drinking. The first Mother's Day celebration just for Mom — and the first major effort to create a national holiday in that spirit — happened right here in the fine Commonwealth of Kentucky.

The arbiter of this holiday, Miss Mary Towles Sasseen, was a tall, intelligent woman with auburn hair and a deep love for her mama. Sasseen, a schoolteacher in Henderson, Kentucky, held a Mother's Day celebration on April 20, 1887, which was her mother's birthday. As a teacher, Sasseen envisioned that Mother's Day would be celebrated primarily by children in schools. Since her first celebration, however, the holiday has gradually increased in popularity, drawing in the entire family.

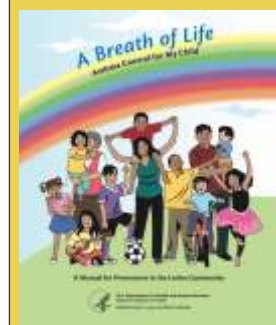

# Spaghetti Squash and Meatballs



**Ingredients**  
**For the marinara:**  
2 tablespoons olive oil , plus extra for drizzling  
1 tablespoon Italian seasoning blend  
1 (15-ounce) jar crushed tomatoes  
1 teaspoon Celtic sea salt , plus extra for seasoning  
**The squash:**  
1 spaghetti squash, cut in half and seeds removed  
**For the Meatballs:**  
1 pound ground organic turkey  
1 large egg, beaten  
1/2 teaspoon Celtic sea salt  
1/4 teaspoon freshly ground black pepper  
Parmesan cheese for garnish (optional)  
**Instructions**  
Place the olive oil and Italian seasoning in a small sauce pan over medium-low heat.

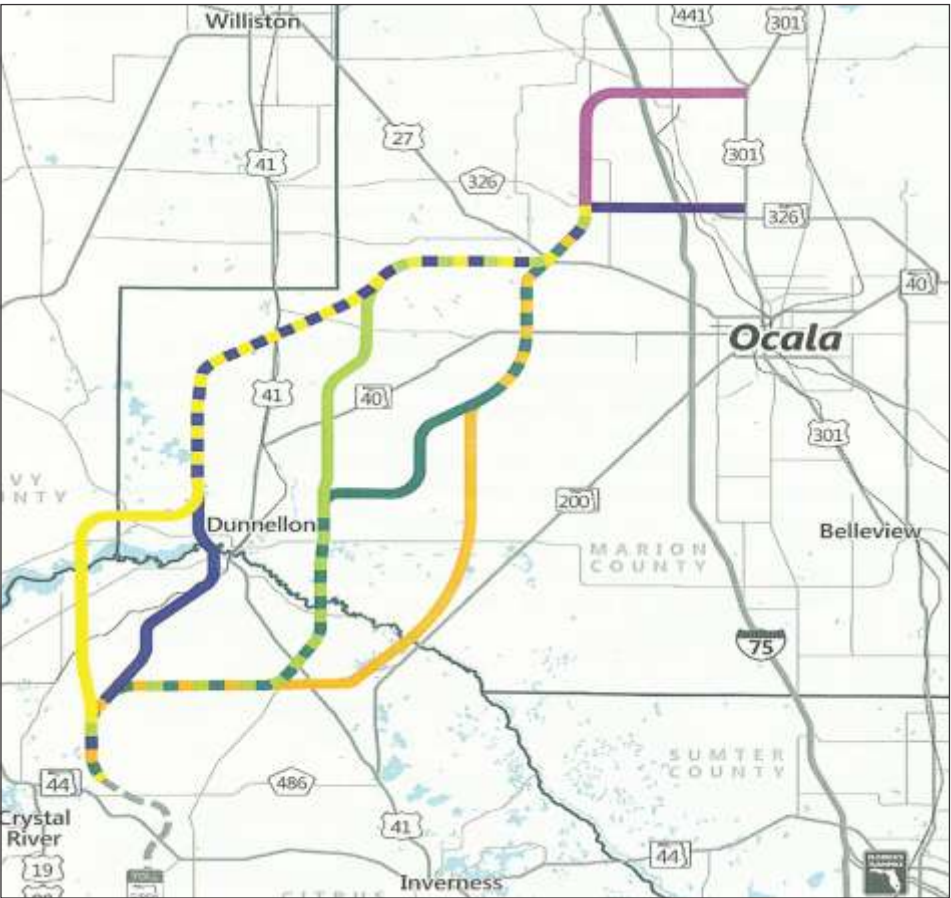
OK now that I got that out of my system. The state of Florida does not have a good track record when it comes to abusing permanent residents. Let's list the abuses.

It is considered separate unless you agree to something else. Once you get an attorney, tell the attorney what you want and don't talk to the project Turnpike people any more. Refer them to your attorney!

Last but not least, "It is my opinion that there should not be a Turnpike Authority. It turns out it is a huge money and land grabbing machine. It needs projects to grow and this is one of them. DOT is who should be the one and only name we hear. Improve the roads we have and stop taking the tax payers' private property.

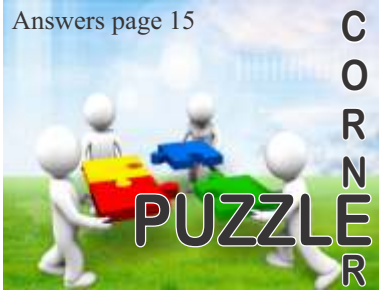

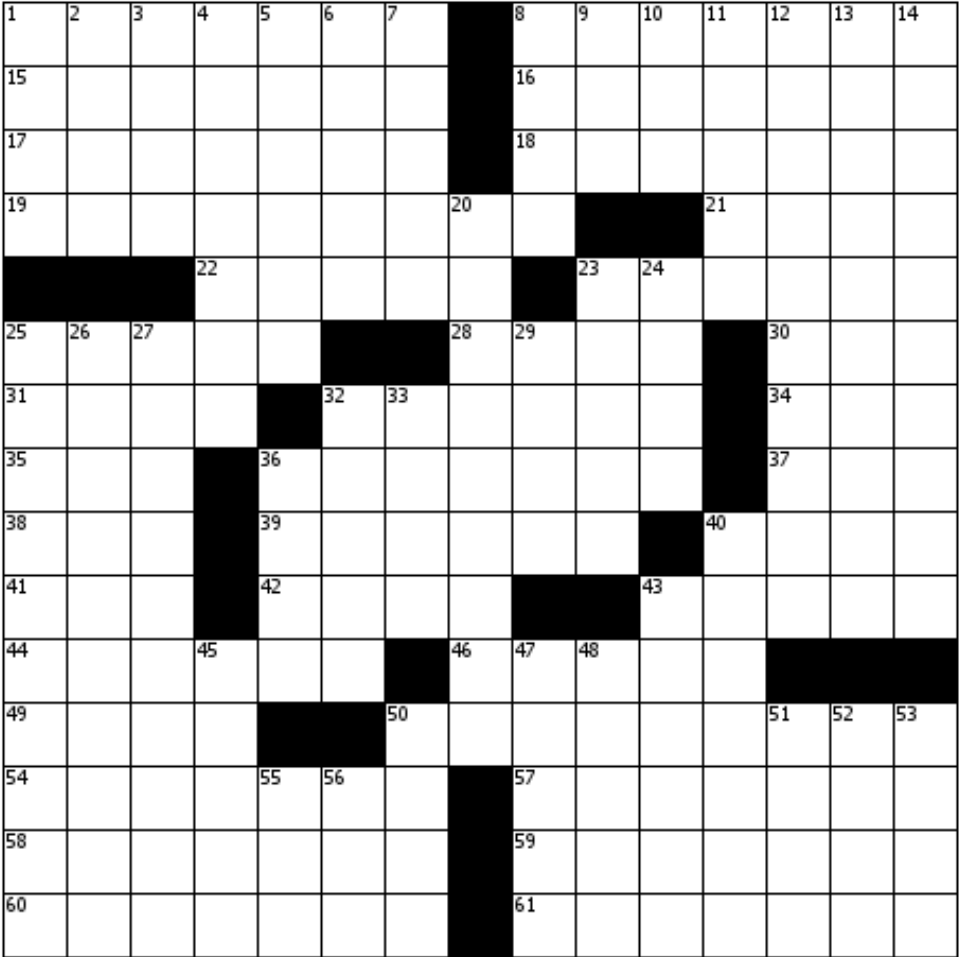

**Run even faster if they ask for more money down.** It's reasonable for contractors to request a modest down payment before work begins (consider it "earnest money"), but if the figure exceeds 20 percent of the bill's projected total cost — say, 50, or even 75 percent — it should set off a red flag.

**Know your contractor.** When it comes to peace of mind, hiring a contractor who is a member of a reputable roofing manufacturer's contractor program is helpful. 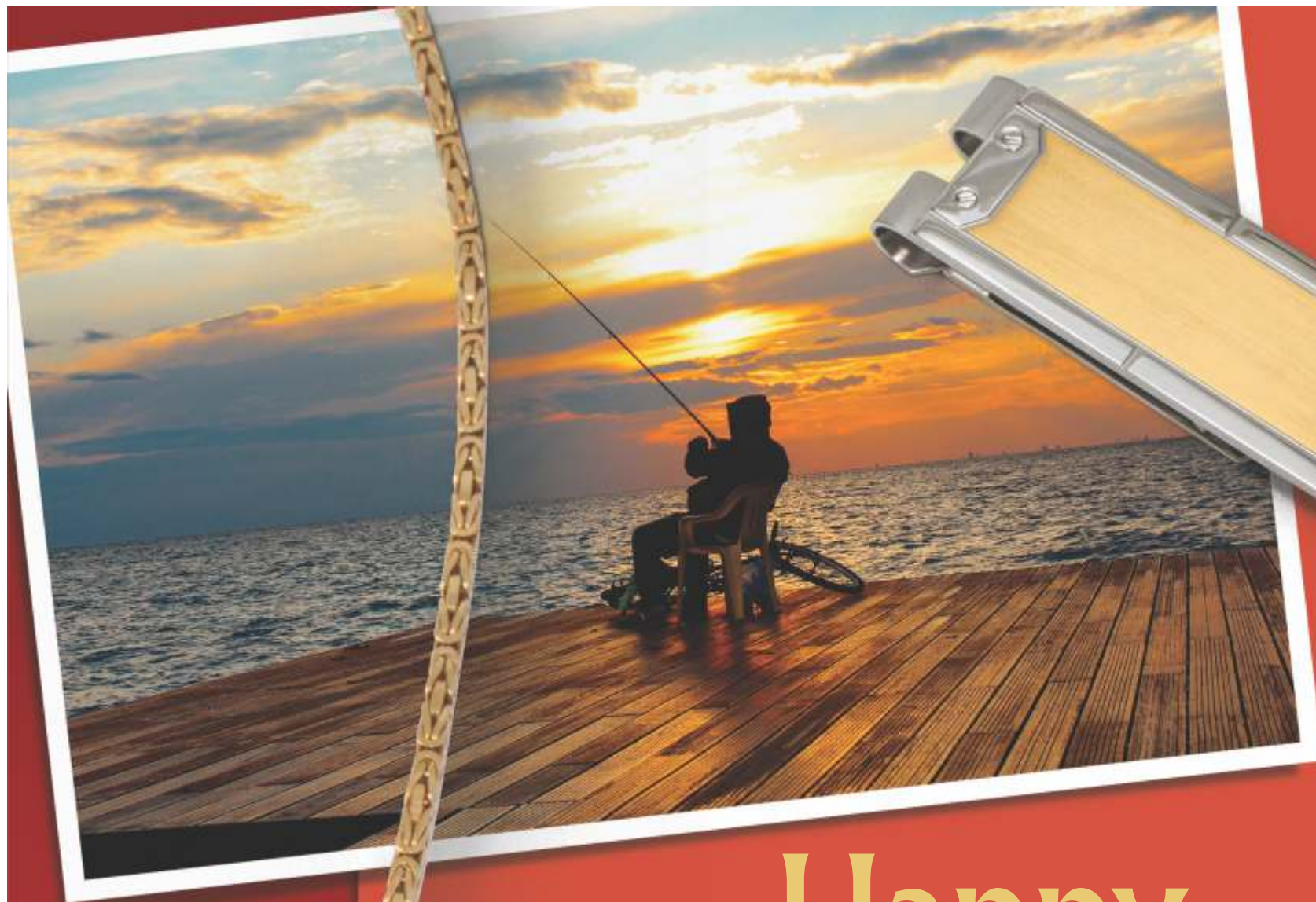
